1	Brief Discussion on marking of APFRS by the Field Staff	
Resolution	It is already known that, the Government of AP have ordered to	
Taken:	implement the Attendance by Photography (Facial Recognition Based Attendance System) to all the employees of all the categories of Government offices across the State vide GO MS No. 159 G.A (PU-B) Dept, Dt.26-12-2022.	
	FRS is implemented almost in all the offices, right from the section level in our department. Elaborate discussion on APFRS was held during the 5 <sup>th</sup> General Body Meeting, at Tanuku and many of the Engineers have requested to tag the subdivisions and section offices in the FRS Attendance system and raised many difficulties in marking attendance in FRS i.e., Server and Network problems, Location accessibility, Leave options etc. Those issues were put forth before the APAEEA, State Body, with a request to address the same to the higher authorities of WRD. Recently, tour option and leave option are enabled in the APFRS app, which gave some flexibility to the section officers.	
	During the discussion on the above issue, in the 6 <sup>th</sup> General Body Meeting at Palakollu, the attendees have sort clarification regarding the timings for marking the Clock in & Clock out in APFRS, as there is no clear cut instruction on the timings. Further there is also a difference in the timings for the secretariat employees and the section employees in marking the attendance in APFRS. Further, option for applying the Half Day CL, Earned Leave and 5 days extra CLs to Women employees are not enabled in the APFRS app so far.	
	As per the discussions held during the 6 <sup>th</sup> General Body meeting, it is opined to appraise the above issues to the APAEEA, State Body with a request to appraise the same to the higher authorities of WRD.

Discussion on Problems faced by the AEE's both Service and Technical related issues

Resolution Taken:

Various problems faced by the section level officers were discussed during the General Body meeting such as levying indents on AEEs, Less Sub-staff allotment to Drainage division when compared to the Irrigation division, forcing the section level officers to prepare the budget proposals (budget proposals have to be prepared by the staff of Division office), Creation of agreements in CFMS etc.

Keeping in view of all these issues, the APAEEA, WG dt (erstwhile) has assured the members that, timely intervention and appropriate action shall be initiated against such issues keeping in view the well being of all the AEEs in the Association.

It is decided to follow a standard procedure in dealing with such issues, like whenever an issue arises in a particular division, the respective division coordinator from APAEEA WG Team along with the AEEs working within the division shall meet the concern Executive Engineer, escalate the issue and ensure amicable solution is achieved. If the issue is not settled in the first instance locally, then the APAEEA WG district executive team shall intervene, consult with the higher officers of the department and ensure amicable solution is achieved, such that the interests of the AEEs are protected. We are happy that, APEEA WG District body has already intervened in few such issues within the district and could resolve the issue locally with the intervention of respective division coordinators.
