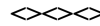

Resolution Taken:	<p>In the wake of General transfers 2023, few of the AEE's working in W.G District (erstwhile) got transferred to other Districts and few from other Districts were posted in W.G District (erstwhile). Therefore, it is necessitated to update the list of the AEE's working in the W.G District (erstwhile), as commencement of the Annual Membership drive 2023 is scheduled from 1st August 2023.</p> <p>Also, recently the A.P State Government has instructed all the service associations/units to furnish the information regarding total number of members, list of office bearers with an updated copy of the bye-laws, audited annual statement of accounts of association.</p> <p>In view of this the APAEEA W.G District(erstwhile) unit during the General Body Meeting has resolve to instruct all the divisional coordinators to update the list of AEE's working in their respective divisions and submit the same to the district body for updating the AEE's master data base in a couple of days.</p>
2	<i>To finalize the seniority list of the Asst. Executive Engineers and to take up Regular Promotions immediately, instead of FAC arrangements.</i>
Resolution Taken:	<p>As we all know that, the W.R Department hasn't taken up any regular promotions from 2019 and only FAC arrangements are made for all the vacant posts till now. Due to delay in taking up the regular promotions, the AEEs of 2007, 2008 PSC Batches are deprived of their much awaited promotions as well as monetary benefits. As a result the AEEs of 2007, 2008 PSC Batches are suffering both Financially and Psychologically as they are still working as AEE's, even after completion of 15 years of service in the department.</p> <p>Recently, during the meeting of the Special Chief Secretary with the service associations the Engineer in chief was instructed to finalize the seniority list of AEEs and to take up the regular promotions at an early date in accordance with the Hon'ble Courts decision.</p> <p>As per the discussions held during the 7th General Body meeting, it is opined to once again appraise the above issue to the APAEEA, State Body with a request to constantly follow up the same, with the higher authorities of WRD.</p>

effective function of divisions along with the financial implications and other aspects such as advantage to the technical officer's in their promotion channel, consequent on creation of one post of Dy.EE in the division offices was addressed by the Engineer-In-Chief (Admn), Vijayawada to the Special C.S to the Government, WRD, AP Secretariat, Velagapudi, Guntur Dt. During the previous General Body Meetings of the APAEEA, WG District, elaborate discussions were held on this issue. Constant follow up is done with the state body on this issue and recently the State Body has communicated that, the file is at the WRD, A.P Secretariat. The file should go to Finance Department for approval, and then to GAD for consent and then it has to be passed in the cabinet for issuance of relevant GOs.

The State Body & the District body are hopeful, that PA to EE proposal will be fruitful very soon. The State Body at this crucial moment needs the support of the District Body and all its members in achieving the most awaited target "creation of Post of Personal Assistant (PA) to the Executive Engineer in the rank of Deputy Executive Engineer.

Hence, during the General Body Meeting opinion of all the association members are taken on this issue and it is unanimously resolved to extend our support to the State body in constant perusal of this issue at Secretariat level and to succeed in Approval of PA to EE proposal.

4 *Amendment of the A.P Irrigation Engineers Service Rules, regarding the Rules pertaining to the "Probation Declaration".*

Resolution Taken: It is well known that, due to delay of Probation declaration, some of the AEEs of 2017 PSC Batch are deprived of the monetary benefits and regularization of their service. Keeping in view the well being of these AEE's, APAEEA WG Dt (erstwhile), have constituted a team to constantly pursue the issue with APAEEA, State Body and to ensure that the file is sent to the Secretariat and to get the necessary amendment order from the Government. With the constant pursuance of the APAEEA State Body, District Body along with the 2017 batch AEE's the issue was resolved.

But few of the AEE's who have not completed the probation within three years of joining other than those AEE's who got delayed due to COVID are still facing the problem of probation declaration as there is no clear instruction regarding this case in the A.P Irrigation Engineers Service Rules.

	<p>The individual representations of those AEE's who haven't completed their probation in three years are being sent to the Secretariat from the Engineer-in-chief (Admin) which is a cumbersome process. In this regard the Engineer-in-chief (Admin) was instructed by the Principal Secretary WRD to prepare a proposal for amendment of the A.P Irrigation Engineers Service Rules, regarding the Rules pertaining to the "Probation Declaration" and submit the same to the secretariat for approval.</p> <p>A detailed discussion was held on this issue, during the General Body meeting and it is resolved to once again address the issue to the APAEEA State Body with a request to appraise the same to the higher authorities of WRD and to the Principal Secretary, WRD for taking necessary action for amendment of the A.P Irrigation Engineers Service Rules, regarding the Rules pertaining to the "Probation Declaration".</p>
5	<i>Restoration of OPS to all the employees under CPS.</i>
<i>Resolution Taken:</i>	<p>As we all known that, under CPS i.e., Contributory Pension Scheme, 10% of the Basic pay and DA of Government employee will be deducted and credited to the NPS (National Pension Scheme). The Government also contributes an equal amount to the investment account of NPS. On retirement, 60% of the accumulated fund can be received in lump sum by the employee. This amount would be tax free. However, the remaining 40% of the fund is mandatorily used to receive annuities. These annuities would be taxable. Whereas in GPS i.e., Guaranteed Pension Scheme, a fixed pension at 50% of the basic pay drawn at the time of retirement will be offered when compared to the current fluctuating CPS of 20%. As you are aware of the fact that, until today just a handful of A.P State Government Employees, recruited under the CPS regime have retired from their service. Therefore a conclusive assessment on the pension received under the CPS is yet to be ascertained.</p> <p>A detailed discussion was held on this issue, during the 7th General Body meeting and it is unanimously resolved to restore the Old Pension Scheme instead of GPS and it is also resolved to support the other associations like the NGO Associations, Teachers Associations, Government Employees Associations etc., financially to the extent possible, who are also striving for restoring the Old Pension Scheme.</p>
6	To clear the pending TA and DA bills of all the Asst. Executive Engineers.
<i>Resolution Taken:</i>	Regarding the DA Arrears and TA Bills, elaborate discussions were held on this issue during the previous General Body Meetings also. It is
