

Some might want to review the “treaty” clauses. *See also* Missouri v. Holland. 252 U.S. 416 (1920)

The Bridge Creek Wilderness Study Area now known as the Steen Mountain Cooperative Management and Protection Area, that is within or adjacent to the Malheur National Wildlife Area, have been pledged, mortgaged and pawned through numerous international treaties and agreements. In fact, those same areas that are cited in the Hammond Superseding Indictment are designated as U.N. Protected Areas. Those designated protected areas are managed under international management prescriptions by a due paying member in the IUCN (Fish & Wildlife Service), or by a subsidiary agency (BLM) that has no discretion. See NEPA below.

The Malheur National Wildlife Area is designated as an IUCN category IV, U.N. Protected Area.

The Culture of Corruption knew those same conditions when they passed 18 U.S.C. 844(f)(1), the very same statute that Dwight and Steven Hammond were re-sentenced under.

18 U.S.C. § 844(f)(1):

(f) (1) Whoever maliciously damages or destroys, or attempts to damage or destroy, by means of fire or an explosive, any building, vehicle, or other personal or real

property in whole or in part owned or possessed by, or leased to, the United States, or any department or agency thereof, or **any institution or organization receiving Federal financial assistance**, shall be imprisoned for not less than 5 years and not more than 20 years, fined under this title, or both.

Numerous international treaties and agreements directly impact the global governance, management, and use of land and resources in, on, and under the Malheur National Wildlife Refuge and the Steen Mountain Cooperative Management and Protection Area. They include, but are not limited to, several Migratory Bird Treaties, the Convention on Biological Diversity (CBD), Convention on Climate Change (CCC), Convention on International Trade in Endangered Species (CITES), along with the International Union for Conservation of Nature and Natural Resources' (IUCN) foreign "Statutes and Regulations", the IUCN Red Book (endangered species), and the resolutions of the World Conservation Congress, The World Forest Congress, and the International Ranger Federation and Congress.

The Hammond Superseding Indictment specifically, but general mentions the "National Environmental Policy Act."

## **NEPA – National Environmental Policy Act**

### **42 U.S.C. 4332**

The Congress authorizes and directs that, to the fullest extent possible:

- (1) the policies, regulations, and public laws of the United States shall be **interpreted and administered in accordance with** the policies set forth in this chapter, and
- (2) **all agencies of the Federal Government shall—**

(F) **recognize** the worldwide and long-range character of environmental problems **and**, where consistent with the foreign policy of the United States, lend appropriate **support** to **initiatives, resolutions, and programs designed to maximize international cooperation** in anticipating and preventing a decline in the quality of mankind's world environment;

(G) **make available to States, counties**, municipalities, institutions, and individuals, **advice and information** useful in restoring, maintaining, and enhancing the quality of the environment;

"Shall" means must.

Dwight and Steve Hammond were secretly charged with and found guilty of setting fire to lands and resources owned or controlled by international "organizations" that are funded by the Culture of Corruption.

How is that for a different perspective on what is going on in Oregon and elsewhere?

P.S. Bundy's ranch operation had similar conditions and the same adversaries in Clark County, Nevada. (Clark County and Sin City passed their joint Comprehensive Land Management and Zoning Plan, and then signed concessionary funding contracts that implemented and enforced the global plantation scheme locally. The Bundy Ranch on the lower Virgin River is located right between three U.N. designated Protected Areas, and close to the UNESCO Grand Canyon Park. Their grazing allotments were being shut off under pretext of endangered species treaties and other international agreements. There are only two functioning ranches left in Clark County.)
