## 2021 OFFICER AND COMMITTEE CHAIR STATUS

The continued success and future of QGSC is dependent on members stepping up and answering the call.

The benefits are many.

- ⇒ You get to meet and work with new people.
- ⇒ You might learn some new skills along the way.
- ⇒ You get to experience the satisfaction that your effort is supporting a greater good.

Yes, every position takes a commitment of time on your part but others are always there to help, answer questions and generally be supportive. **Personal growth and learning should be a lifetime goal.**

**Three key officer positions for 2021 are still open:**

- ◆ **President Elect/Parliamentarian (currently called Co-President)**
- ◆ **Secretary**
- ◆ **Vice President/Programs**

### **PRESIDENT ELECT/PARLIAMENTARIAN (CURRENTLY CALLED CO-PRESIDENT)**

- a. The President-elect will assist the president as called upon and shall exercise all functions of the president in her/his absence.
- b. The President-elect will serve as advisor on parliamentary procedure to the president and other directors and members of the guild upon request.
- c. The President-elect will be responsible for maintaining and updating the bylaws.
- d. The President-elect is responsible for the outgoing president's remembrance.

- e. The President-elect is responsible for giving the Treasurer a written budget for his/her office by January 31st of each year so that it may be presented to the board for approval.
- f. The President-elect is responsible for an annual inventory including current location of guild property.
- g. The President-elect shall serve a two-year term, succeeding to the office of president upon the second year of the term.
- h. President-elect is responsible for the oversight of the following committees: Nominating, Annual Challenge, Audit, Bylaws, Show-N-Tell, Monthly Mini.

### **SECRETARY**

- a. The Secretary is responsible for taking notes at all general and board meetings, typing them up and forwarding a copy to the newsletter chairperson.
- b. The Secretary is responsible for keeping a copy of the guild minutes, board minutes, guild newsletters, membership lists, and any outgoing or incoming guild correspondence. She/he may be asked to write letters, thank-you notes, etc. on behalf of the guild.
- c. The Secretary is responsible for presenting a written budget to the treasurer by January 31st of each year to be approved by the board.
- d. The Secretary is responsible for contacting another guild member to take minutes ahead of time if she/he cannot be present at a board or general meeting
- e. The Secretary is responsible for keeping a written copy of all minutes and guild correspondence in a notebook which can be reviewed at any time if necessary. A copy will also be provided for the president.
- f. The Secretary is responsible for oversight of the historian and library committees.

**2021 OFFICER AND COMMITTEE CHAIR STATUS CONTINUED****VICE PRESIDENT/PROGRAMS**

- a. The Vice President/Programs will assist the president as called upon.
- b. The Vice President/Programs has authority and responsibility to sign programs contracts for speakers, classes and facilities.
- c. The Vice President/Programs is responsible for proposing a program agenda (available programs/speakers/teachers, price, etc.) to the board to be voted on before presenting any program information to the guild. The Vice President/Programs is responsible for keeping the board updated regarding the latest programming ideas and plans at monthly board meetings
- d. The Vice President/Programs is responsible for giving a written budget to the treasurer by January 31st of each year for approval by the board.
- e. The Vice President/Programs is responsible for coordinating all programs and/or program ideas for the following fiscal year with the assistance of Day and Evening programs committees.
- f. The Vice President/Programs, and her/his delegated members of the Day/Evening program committees, is responsible for scheduling the monthly programs/speakers/workshops that meet the purposes of the guild.
- g. The Vice President/Programs is responsible for writing a monthly article for the newsletter describing the upcoming programs (date, time, description of speakers and/or programs, etc.).
- h. The Vice President/Programs is responsible for introducing the speaker and/or program at each month's guild meeting.
- i. The Vice President/Programs will coordinate with the Day and Evening Program Committees in determining class and workshop agenda to ensure all arrangements are addressed (i.e. facility, publicity, treasurer, etc.)
- j. The Vice President/Programs will ensure that all letters of confirmation and cancellation are written for speakers, if need be.
- k. The Vice President/Programs will ensure that the program committees manage expenses of the speaker costs (i.e. hotel, transportation, meals, etc.) and provide receipts to the treasurer for payment.
- l. The Vice President/Programs is responsible for oversight of the following committees: Daytime Programs/Classes, Evening Programs/Classes, Daytime Facilities, Evening Facilities.

### STAYING CONNECTED IS UP TO ALL OF US

If you do why not organize a pop-up sew-in for an hour or two? A Zoom account for an hour or longer meeting is \$15 per month. For 45 minutes or less it is free.

FaceTime can also work to help us stay connected in this Covid-19 world and at NO COST!

I participate in both Zoom and FaceTime meetings to stay connected.

Contact Wanda or Kristin for suggestions on how to get started or for general Zoom help so you are more comfortable attending our meetings.

Some of you are Facebook users, some are not. This is another way to stay connected but if you want to see and hear a real live person Zoom and FaceTime are for you.

There is no need to sew alone!

Communication is a two way street and everyone has a responsibility to control the traffic.



### ADVANTAGES OF ZOOM MEETINGS

Thank you to Joann Gorrell for sharing this information after attending a Zoom session presented by the Global Quilt Connection.

- ◇ Every viewer has a front row seat and they can adjust the sound so they can hear what's being said. Not always true in a face to face meeting.
- ◇ For people who don't drive at night or drive at all zoom is an option to connect with other guild members.
- ◇ For people who can't leave a loved one home alone, zoom is an option to connect with other guild members.
- ◇ It's economical for guilds to not have to pay for airline tickets and hotel rooms for the speaker.
- ◇ Teachers use overhead cameras and close-ups of what's being sewn. This is often hard to see when we gather around the teacher at a live workshop.
- ◇ Teachers can show close-ups of tools and items being demonstrated that we used to have to pass around the group. By the time it gets to the last person, the teacher is on to a different topic or another tool.

head the committee.

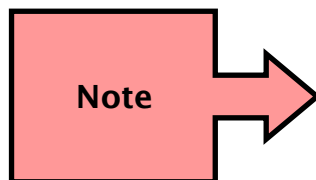

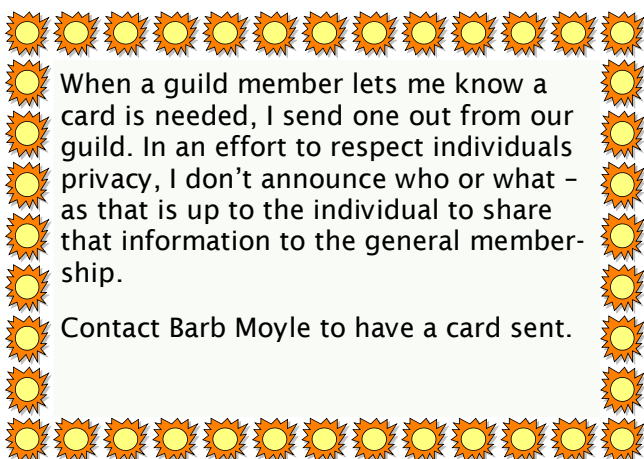
