It was **RESOLVED** to submit the following comments:

Google earth backdated photos: Google maps dated prior to 2021 shows no stud and only a stable, neither is there a touring caravan visible. Aerial photographs show no buildings are there until after 2020. It is quite clear on the aerial photographs when the pigeon loft was erected in 2021, prior to that there is only the stable visible

Local knowledge: A touring caravan had been seen there within the last 9 years and a small stable. No pigeon loft until about a year ago. Prior to that it was just horses and a stable.

Other evidence: Facebook – Tumley Loft Stud, the photos on the page are of Polehayes, not the Blackhill site. The Website also shows Polehayes and not Blackhill at the time of checking
