IV. BUSINESS and Open Forum



Water Tank Status: The 10,000-gallon galvanized water well tank is deteriorated beyond repair. A professional inspector confirmed it cannot be relined. No suitable "used" tank is available for replacement.

Replacement Plan: A new tank must be ordered with a 4-month lead time. A 50% deposit is required at the time of the order; the remaining 50% is due at installation. Delaying the order increases the risk of complete water service loss. The board will continue collecting estimates while waiting on funds. The Association is responsible for utility plant upkeep, per historical practice and legal counsel.

Deferred Maintenance & Financial Impact: Historically low monthly assessment fees have resulted in underfunded reserves and deferred maintenance. Major repairs now require special assessments due to insufficient reserves. To deter future special assessments, higher monthly assessment fees would be necessary.

OHURTICANE Repairs Insurance: No claims filed due to high-deductible exceeding repair costs. **Responsibilities:** Association: responsible for building exteriors. Unit Owners: financially responsible for individual screen patio enclosures.

Special Assessment

Purpose: To fund urgent repairs and hurricane-related damage.

Payment Structure: Installments: (Total \$1,979.06) \$1,000 due May 23, 2025 with remaining balance payable over two additional months.

NOTICE: Pool, Pool Building, Retention Pond: Pool is closed due to hurricane(s) impact. Pool, pool building and pond will be on near future meeting agenda.

Members facing hardship are encouraged to contact the Association.

Board of Directors Vote: The special assessment was approved by the unanimous board of directors "Yes" votes.
