### CALL TO ORDER

## SHERIFF'S MONTHLY REPORT

The council reviewed the January and February monthly reports. Sheriff Mike Buchannan discussed that their department with recent resignations of two deputies they have hired Deputy Dusty Nordyke who will be living at Housing. They have another interview scheduled with another potential candidate in a week or so. They have a new app to track calls made. They are in discussions with Park and Wildlife concerning all the coyotes wondering around town.

This should have been out of the 2023 budget and were just now paid. J&S Construction had to fix a broken cable on the shop door and \$300 was for rental of a lift.

## DISCUSS TIFFANY KNUDSEN SUGGESTED AMENDMENT-TINY HOME

Tiffany Knudsen was not in attendance. No discussion was held.

### **KMH-Jasmine Shea Housing Funding**

Jasmine DON of KMH along with Dan Covington discussed the need for housing and presented the council with a CHFA handout on funding. The council discussed the plans in place to address the housing shortage in Cheyenne Wells. The town is currently working with CHFA, DOLA, and Wells Rural Development to engineer a large housing development on the east end of Town. The council will be in contact with KMH for letters of support in future grant applications.

### DISCUSS CHEYENNE COUNTY FAIR & TUMBLEWEED

Discussion was held with Council and Fair Board Manager Jim on the open container of alcoholic beverages in the fairground area during the rodeo and dance time frames.

## SCHEIMER KERR WELL UPDATE

Councilman Pelton discussed the possible 99-year lease for the Scheimer Kerr Well the Town's Water Attorney and Scheimer attorneys are in negotiations on a lease agreement.

## Hydro Resources

Hydro Resources is scheduling a time to pull the Scheimer well and get a video of the internal fixtures of the pump. The estimated quote on this is \$6100.

#### Water State Inspection and Samples

Town Superintendent Crum stated that the state inspectors came down. The Town will be written up on backflow reports for the firehouse, Eastern Co Bank and Cheyenne Manor. As he didn't get their reports on file. The State will give us 120 days to correct this. The monthly water samples came back fine.

## SOME GIRLS & A MURAL ENTRANCES SIGNS DESIGN

The Council reviewed the updated draft of the welcome sign. Mary Weed has offered funds towards paint for this project. Councilman Hyle and Taegen Eiring are looking at xeriscape options at these locations for Mr. Eiring's Boy Scout project. The updated sign from Some Girls & A Mural upon motion from Councilman Anderson and seconded by Councilman Hyle. All voting for, motion carried.

## EIAF #9808 TCW HOUSING ENGINEER GRANT

The Council reviewed their award letter for the WRD Engineering grant in the amount of \$41,643. After the engineering is completed, we will look into more grants to begin construction of the infrastructure needs derived from the completed engineering.
