Scheuneman made a motion to approve payment and allow the Shiawassee River Water Trail Coalition to place mile marker #79 on the flats, seconded by T. Fish. Motion carried.

Mike Belanger informed the council of his intent to run for Village President as a write in candidate. He asked several questions of the council. He wanted to know why we have a police officer, why is there a sex offender employed by the Village, and what is the inventory the village has received from the LESO/1033 program, why is there village vehicles at the pot plant, why is there police trucks at the lagoons, who is in charge of the equipment the village gets from the 1033 program when they get rid of it, why is the Marijuana facility not paying taxes, what happened to the generator behind the Fire barn, how did a mobile home sneak in at night.

#### Old Business

Scheuneman presented the council with the updated Oakley Backyard Fowl Ordinance. The council agreed to the wording and President Fish suggested they move forward with a Public Hearing.

Scheuneman made a motion to hold a Public Hearing for November 12, 2024 at 6:30PM at the hall, seconded by T. Fish. Motion carried.

#### **New Business**

Scheuneman made a motion to transfer \$58543.75 from Wastewater Special Assessment Savings to Operation and Maintenance checking to pay the sewer loan, seconded by T. Fish. Motion carried.

The council discussed Halloween hours and decided the hours will be October 31, 2024 from 6-8PM. The Village Halloween Party will be held from 5-8PM at the hall.

President Fish informed the council he applied for a Grant to repave Woodard Street and it was granted. Approximately \$228,000 will be put towards repaving Woodard Street in 2025.
