- Trial location available 7 AM to 6 PM each day or until one hour after event
- Bath/cool off tub provided
- Owners or agents are solely responsible for the presence of their dog(s) at the Trial arena. Judges are not required to wait for dogs.
- Exhibitors are expected to cleanup after their dogs.
- Bitches in season will be allowed to participate; they will run in catalog order.
- ALL DOGS PRESENT MUST BE HELD ON LEASH or otherwise restricted except when working. Under NO circumstances will dogs be allowed to disturb the resting stock or interfere outside the arena during another dog's performance. (See Chapter 1, Section 20 of the AKC Herding Regulations)
- Entry fees shall not be refunded in the event that a dog is absent, not allowed to compete, disqualified, excused by veterinarian or judge, or barred from competition by action of the show committee.
