SUMMARY OF SIGNIFICANT ACCOUNTING POLICES AND OTHER EXPLANATORY INFORMATION TO THE FINANCIAL STATEMENT FOR THE YEAR ENDED MARCH 31, 2024

1 Significant Accounting Policies

A Basis Of Preparation

The financial statements of the Company have been prepared in accordance with generally accepted accounting principles in India (Indian GAAP). The Company has prepared these financial statements to comply in all material respects with the notified accounting standards by Companies (Accounting Standards) Rules, 2006,(as amended), and the relevant provisions of the Companies Act, 2013. The financial statements have been prepared on an accrual basis of accounting and under the historical cost convention.

The classification of assets and liabilities of the Company is done into current and non-current based on the operating cycle of the business of the Company. The operating cycle of the business of the Company is less than twelve months and therefore all current and non-current classifications are done based on the status of realisability and expected settlement of the respective asset and liability within a period of twelve months from the reporting date as required by Revised Schedule VI to the Companies Act 2013.

The accounting policies adopted in the preparation of the financial statements are consistent with those used in the previous year.

B Method of Accounting

The company follows Merchantile System of Accounting and recognizes income and expenditure on accrual basis.

C Taxes On Income

Income tax expenses for the period comprise of current tax and deferred tax is included in determining the Net Profit / Loss for the period. Current Tax provision has been determined on the basis of relief, deductions, etc. available under the Income Tax Act.

Deferred Tax is recognized for all timing differences between taxable income and the accounting income, which originate in one period and are capable of reversal in one or more subsequent periods. The tax effect is calculated on the accumulated timing differences at the year end based on tax rates and laws enacted or substantively enacted as of the Balance Sheet date.

Earning Per Share

The company reports basic and diluted Earning Per Share (EPS) in accordance with Accounting Standard 20 on Earning Per Share. Basic EPS is computed by dividing the net profit or loss for the year by the weighted average number of Equity Shares outstanding during the year. Diluted EPS is computed by dividing the net profit or loss for the year by the weighted average numbers of Equity Shares outstanding during the year as adjusted for the effects of all dilative potential Equity Shares.

E Fixed Assets & Depreciation

Fixed Assets are stated at cost and includes the expenditure incurred during the year.

Depreciation has been provided on straight line method at the rates and in the manner specifice in Schedule - XIV of the Companies Act, 2013.

F Contigent Liability

Liabilities not provided for in the books of accounts have been disclosed in the accounts by way of notes giving the nature and quantum of the same.
