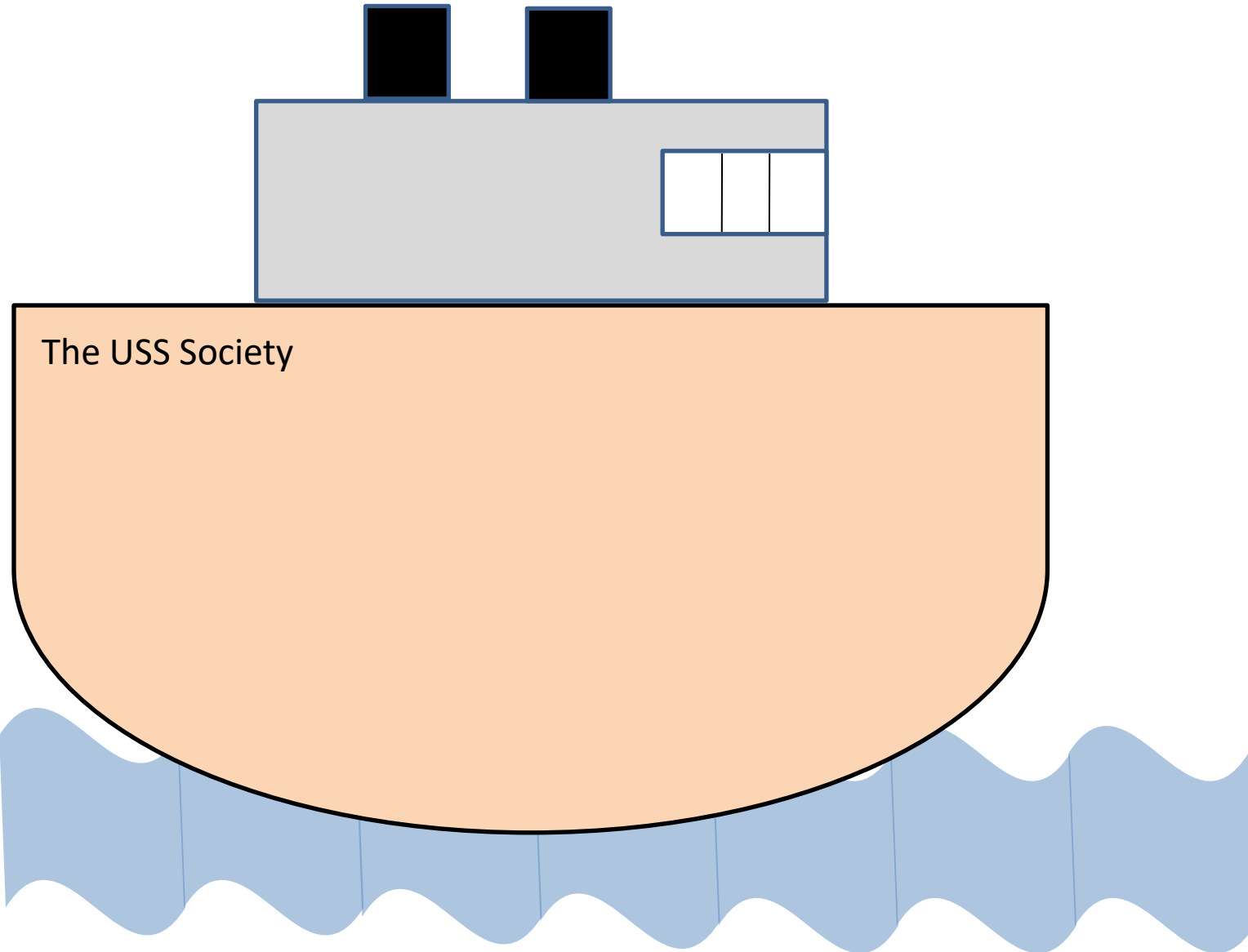
- Endless analysis and debate about the causes of human misery do nothing to alleviate it.

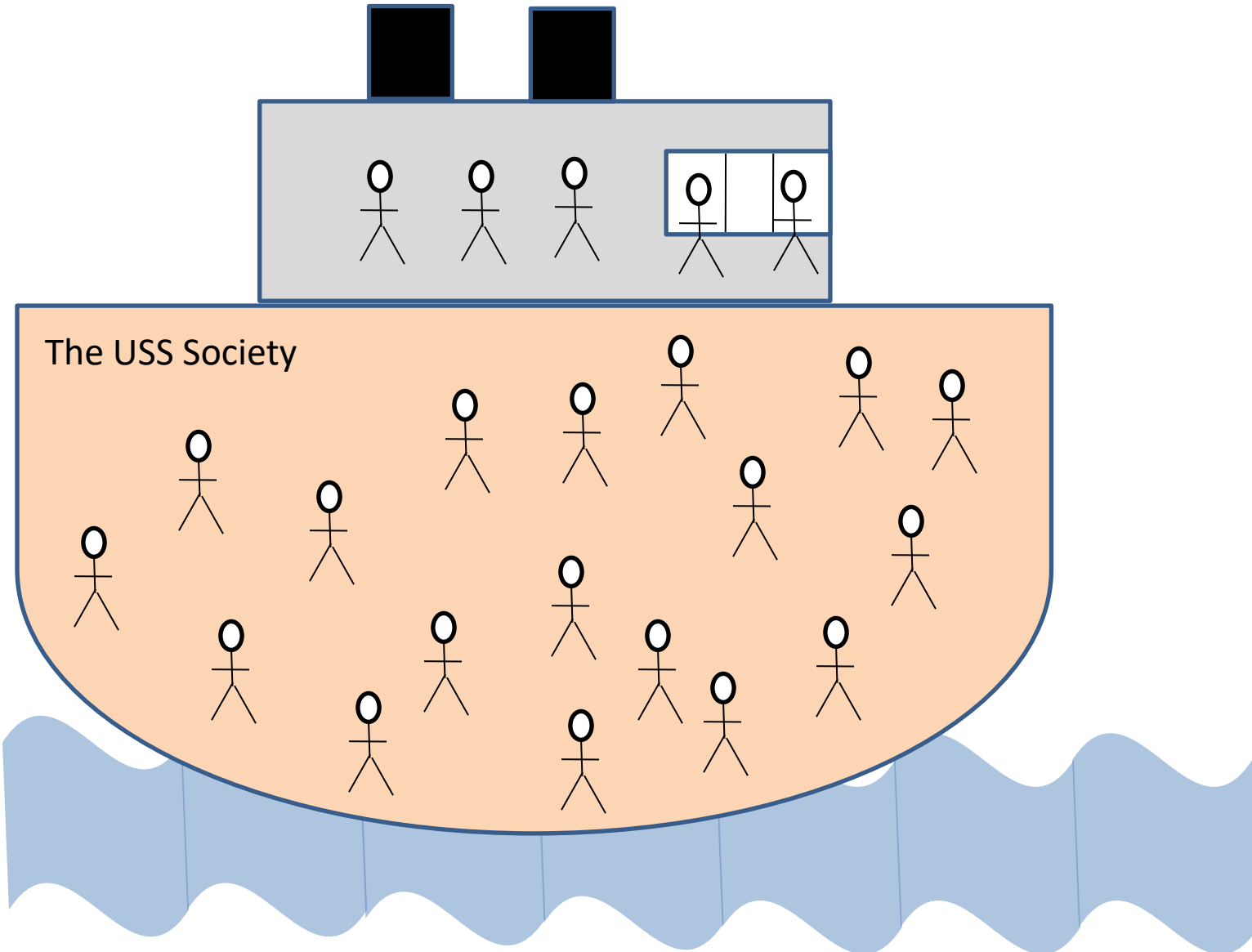
Foundation approach

- To take effective action you need to fully understand the system you are a part of.
- “Education” in the system does not prepare you to see the system itself or to function in ways not prescribed by the system.
- Modeling (visual representations with supporting text) is an effective way to reach understanding.
- This presentation is a model of system you are a part of.

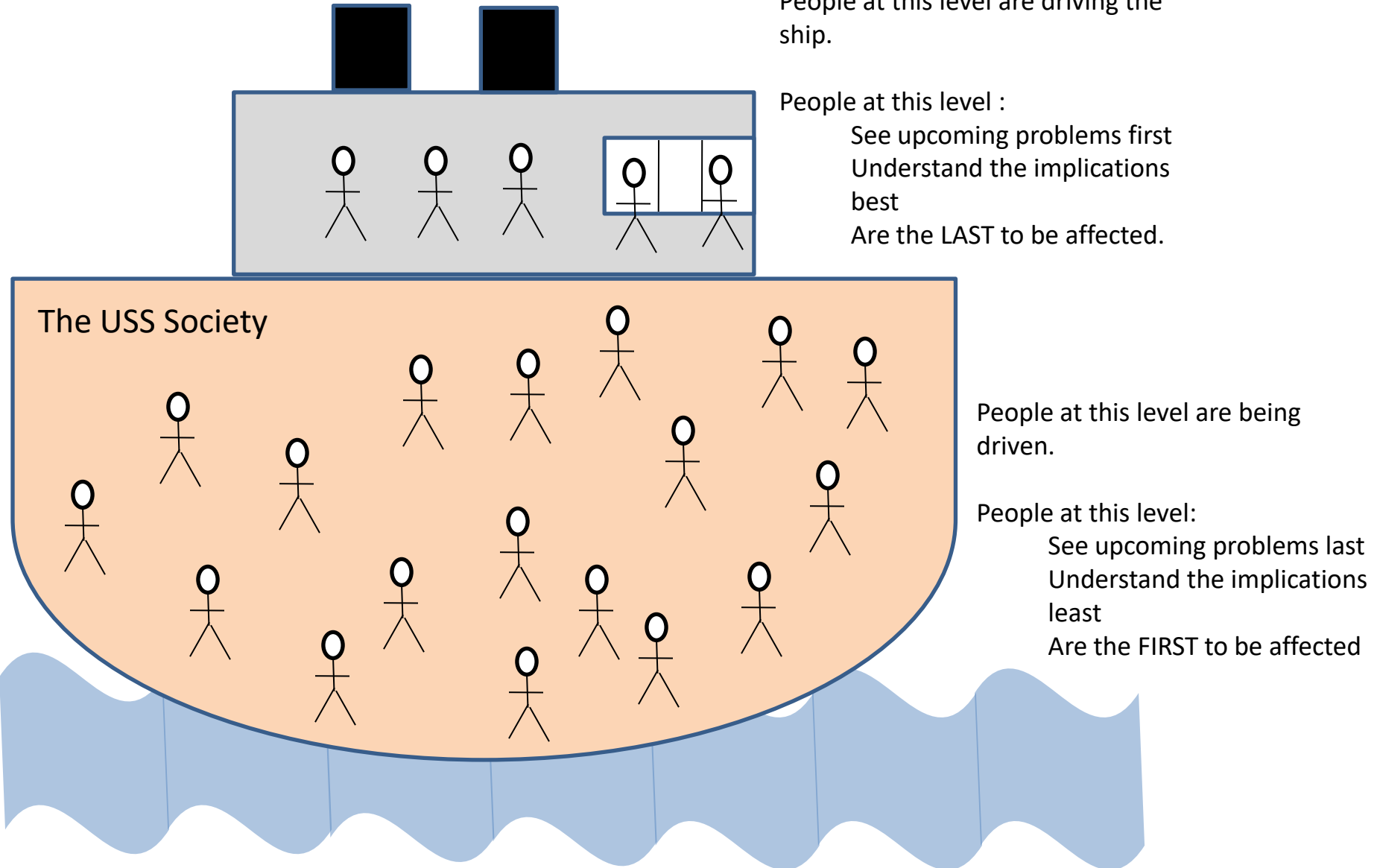
Model used: Analogy of a ship



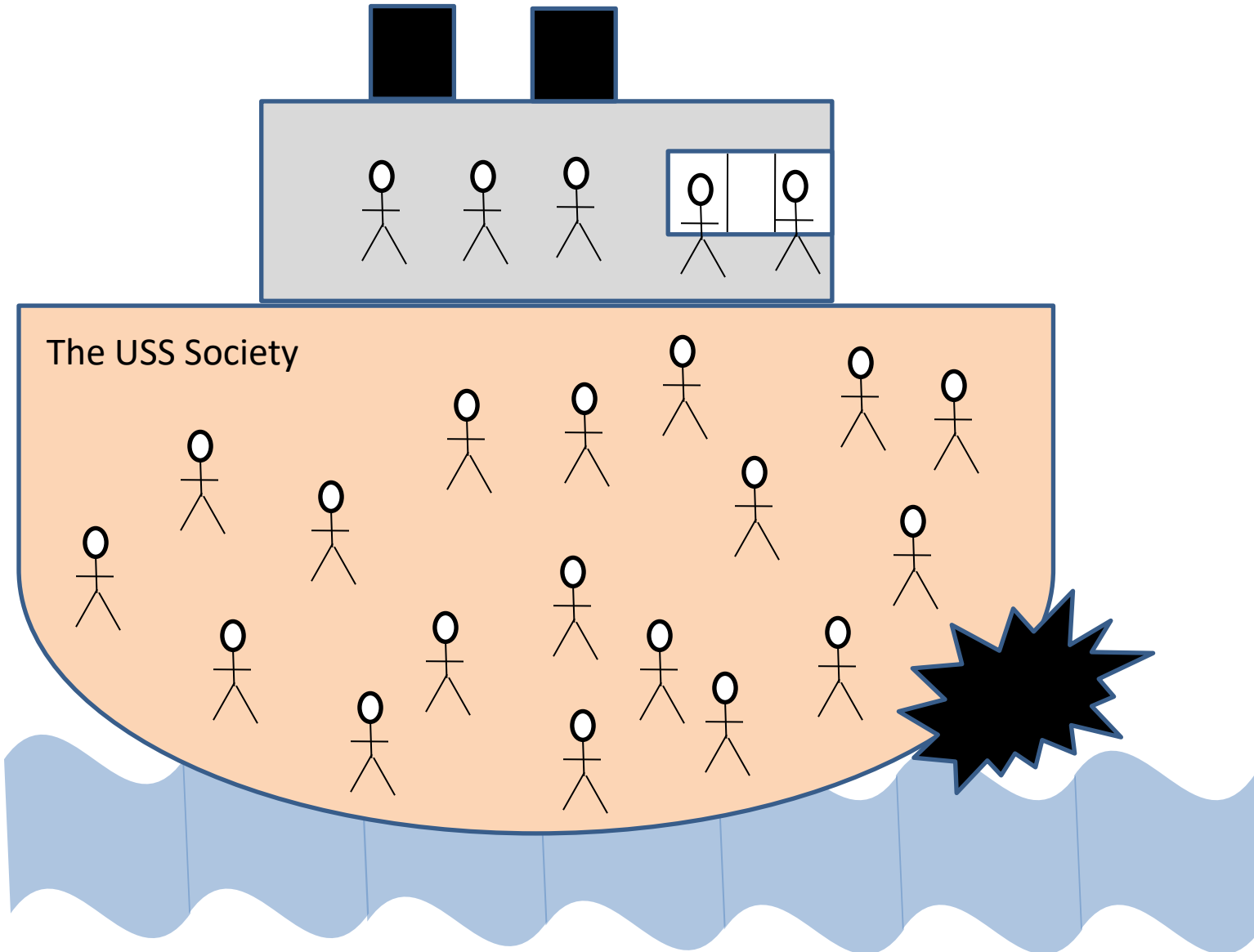
People live in different areas of the ship



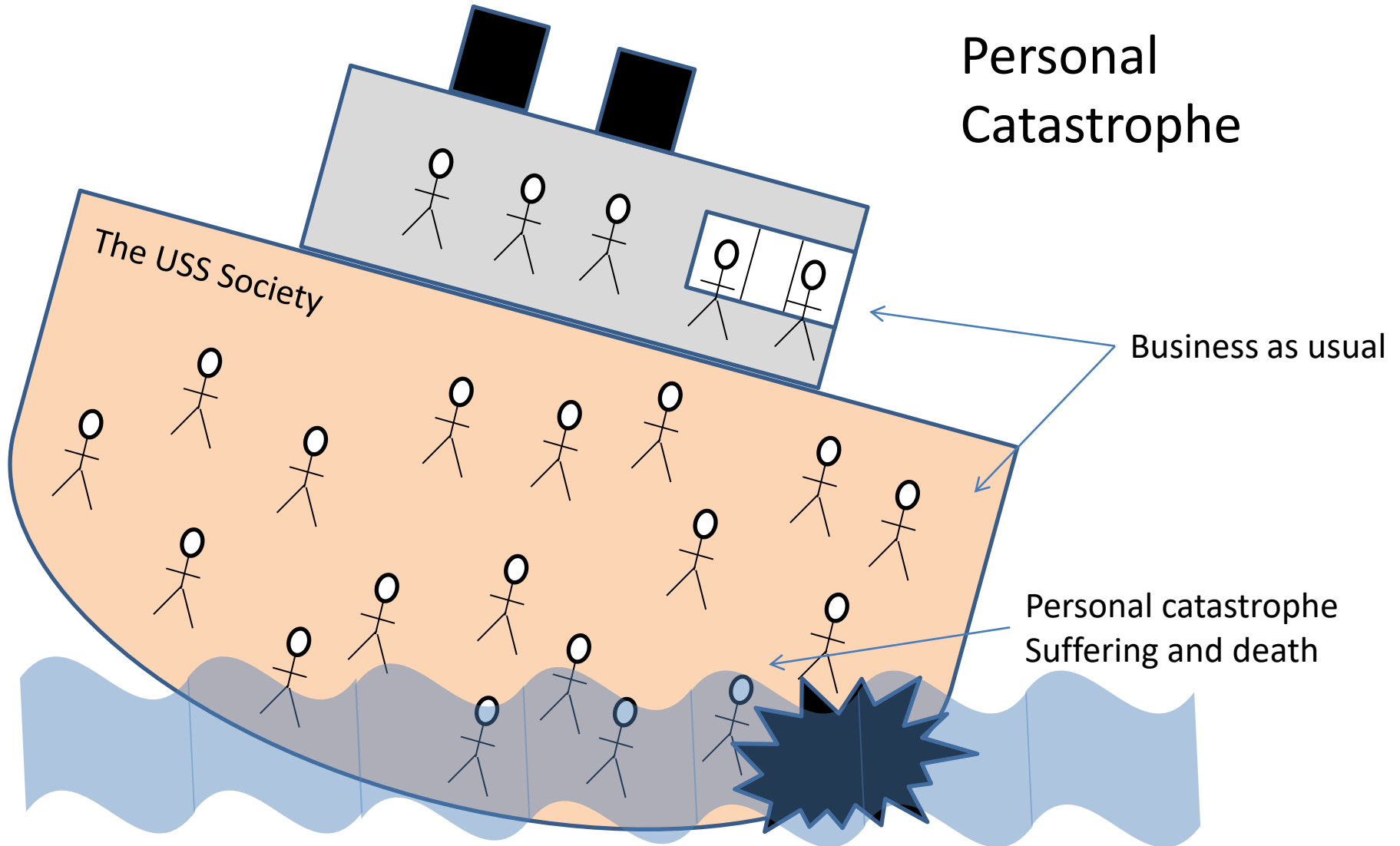
What is the perspective of people living in different areas of the ship?



Who is in danger if the ship is damaged?



Is it a catastrophe if the ship is damaged?
It depends on where you are on the ship.



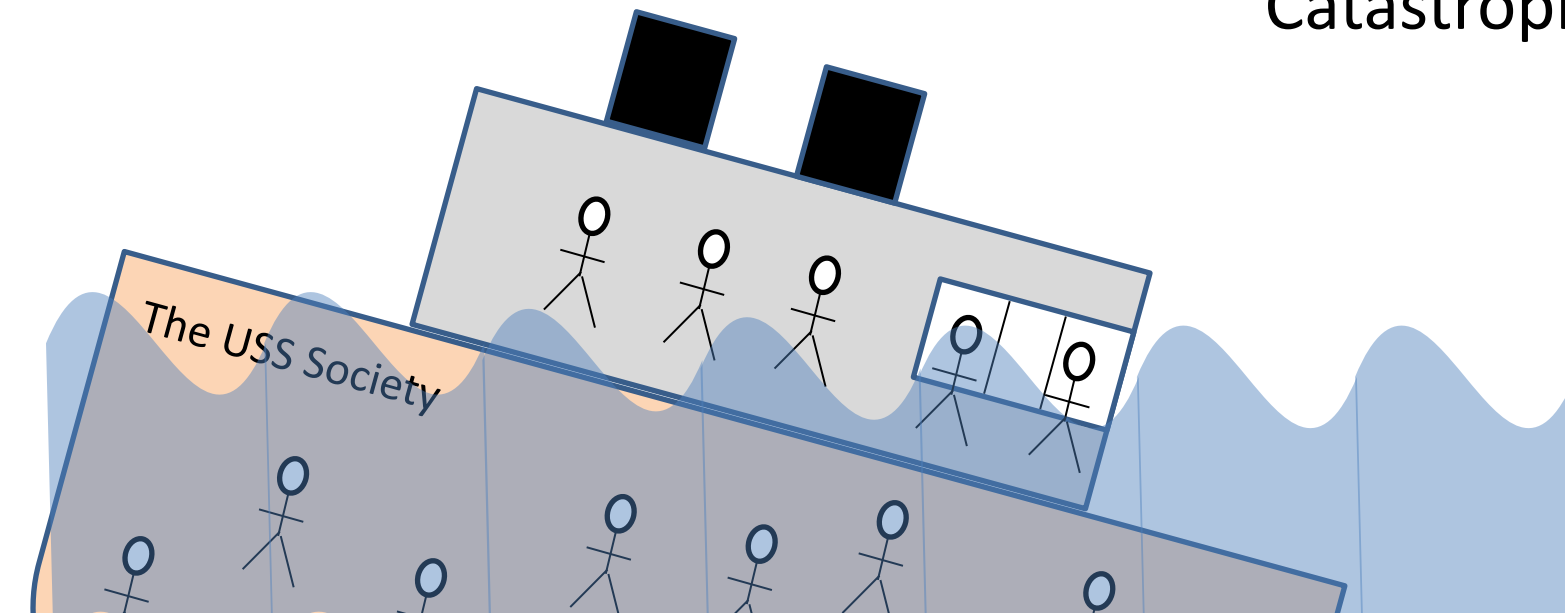
If the entire ship sinks it is a social catastrophe. But this only happens when the people on the top of the ship drive the ship into fatal collision.

Examples:

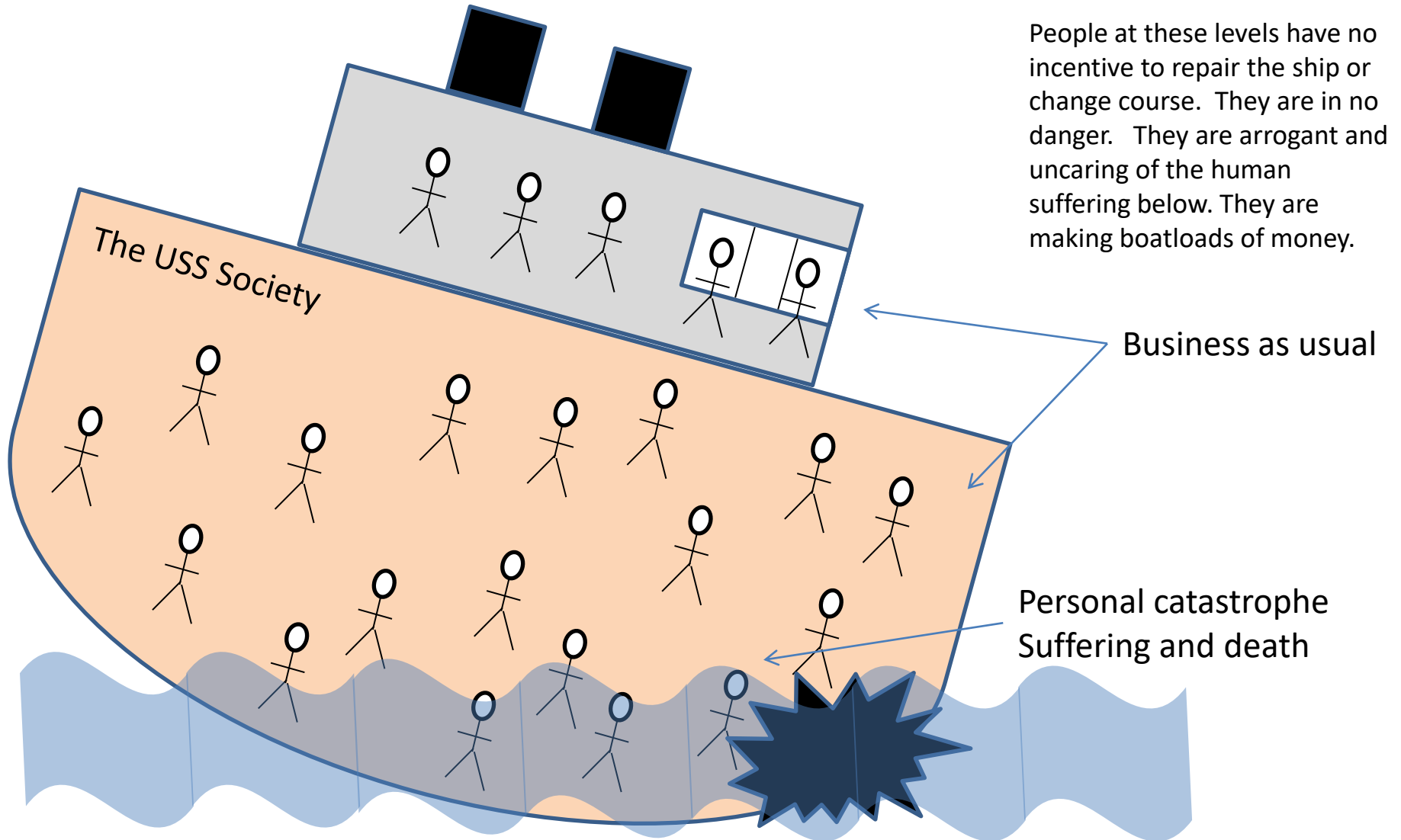
“rulers” start wars, lose the war, and their country is conquered. Millions die from hunger, disease, social violence. This is a social catastrophe.

“government officials” create monetary policy which destroys the economic system and the system collapses. - Millions die from hunger, disease, social violence. This is a social catastrophe.

Social Catastrophe

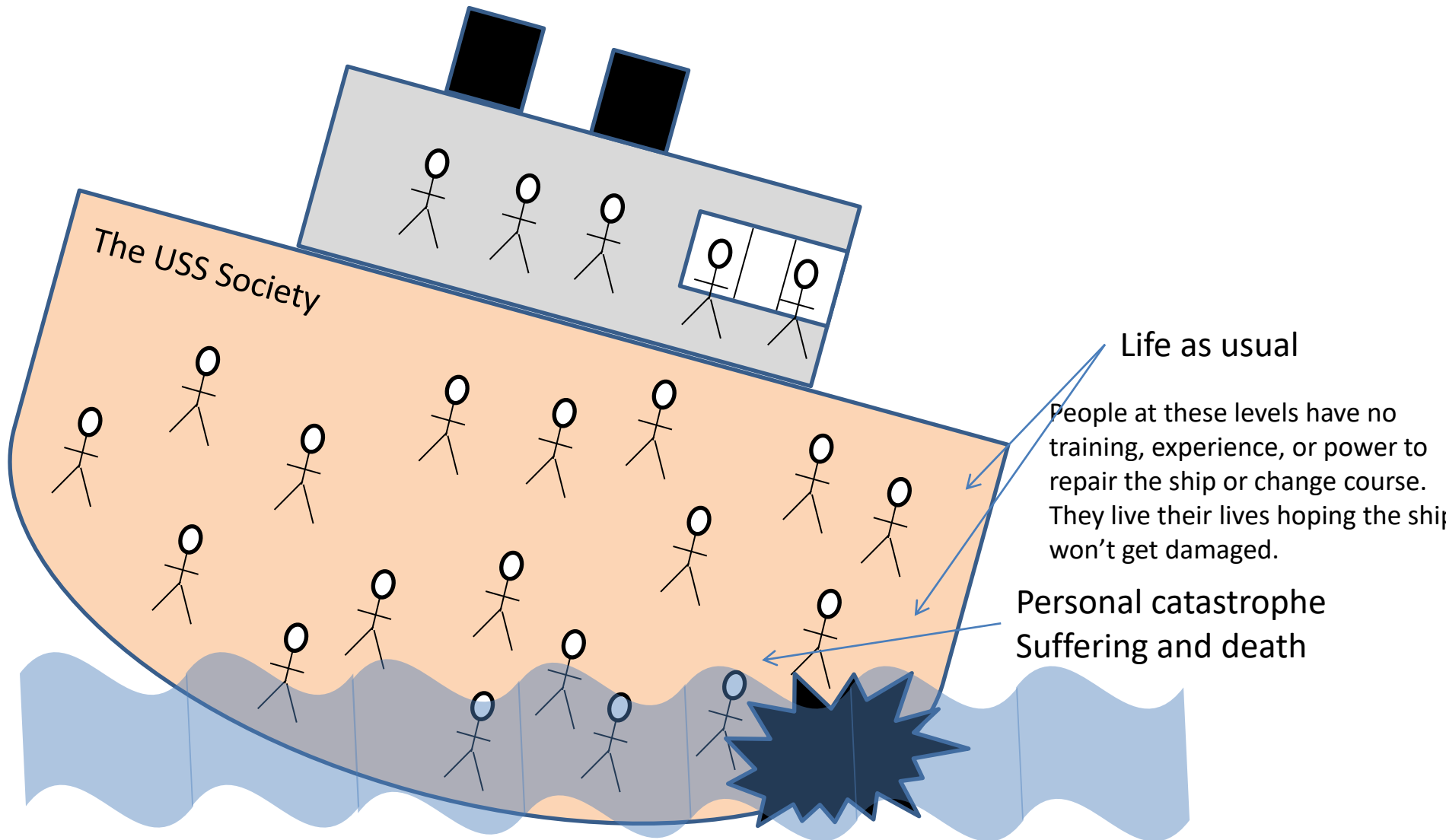


This is the usual state of the ship.

This is the usual state of the ship.



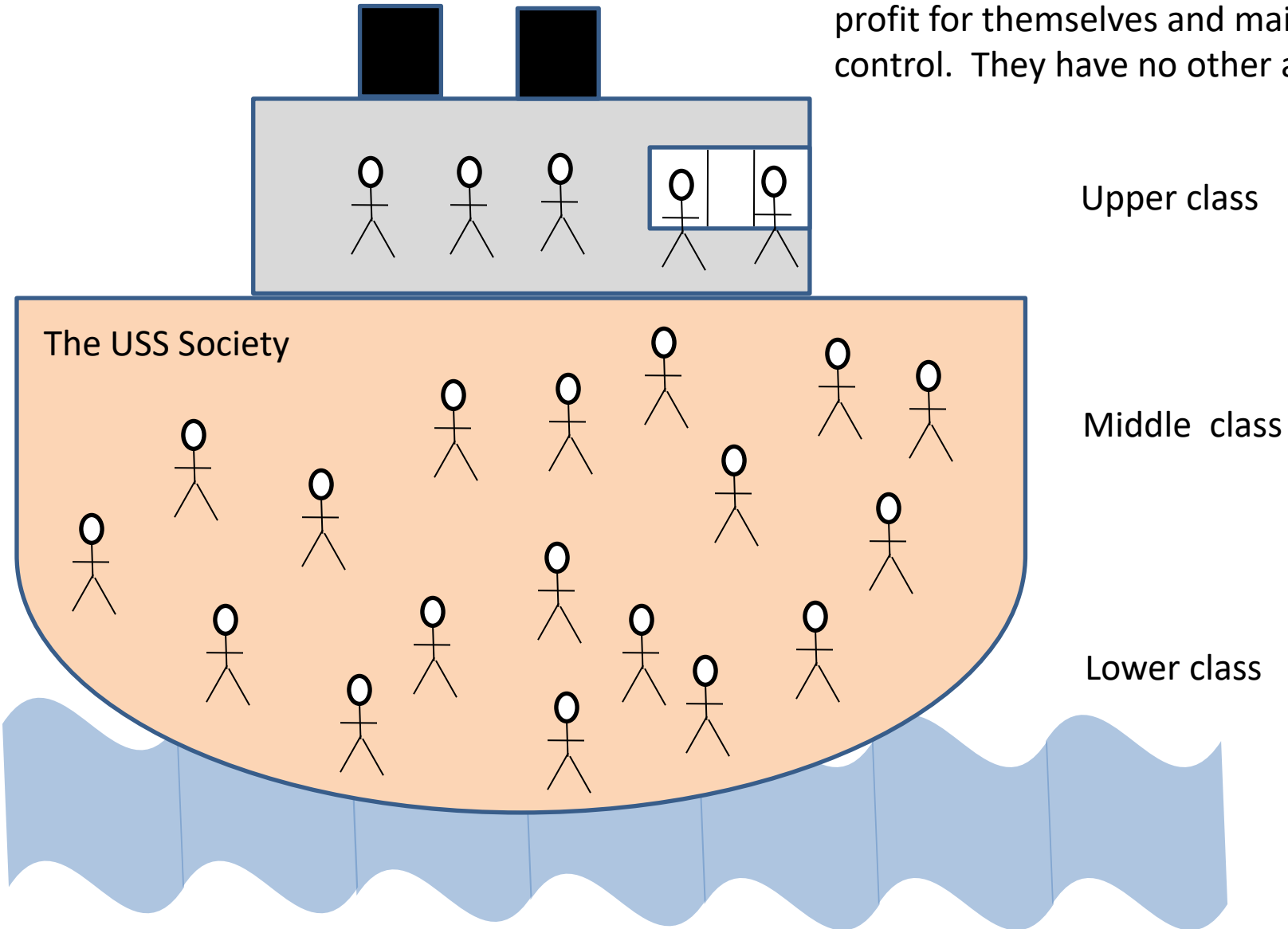
Life as usual

People at these levels have no training, experience, or power to repair the ship or change course. They live their lives hoping the ship won't get damaged.

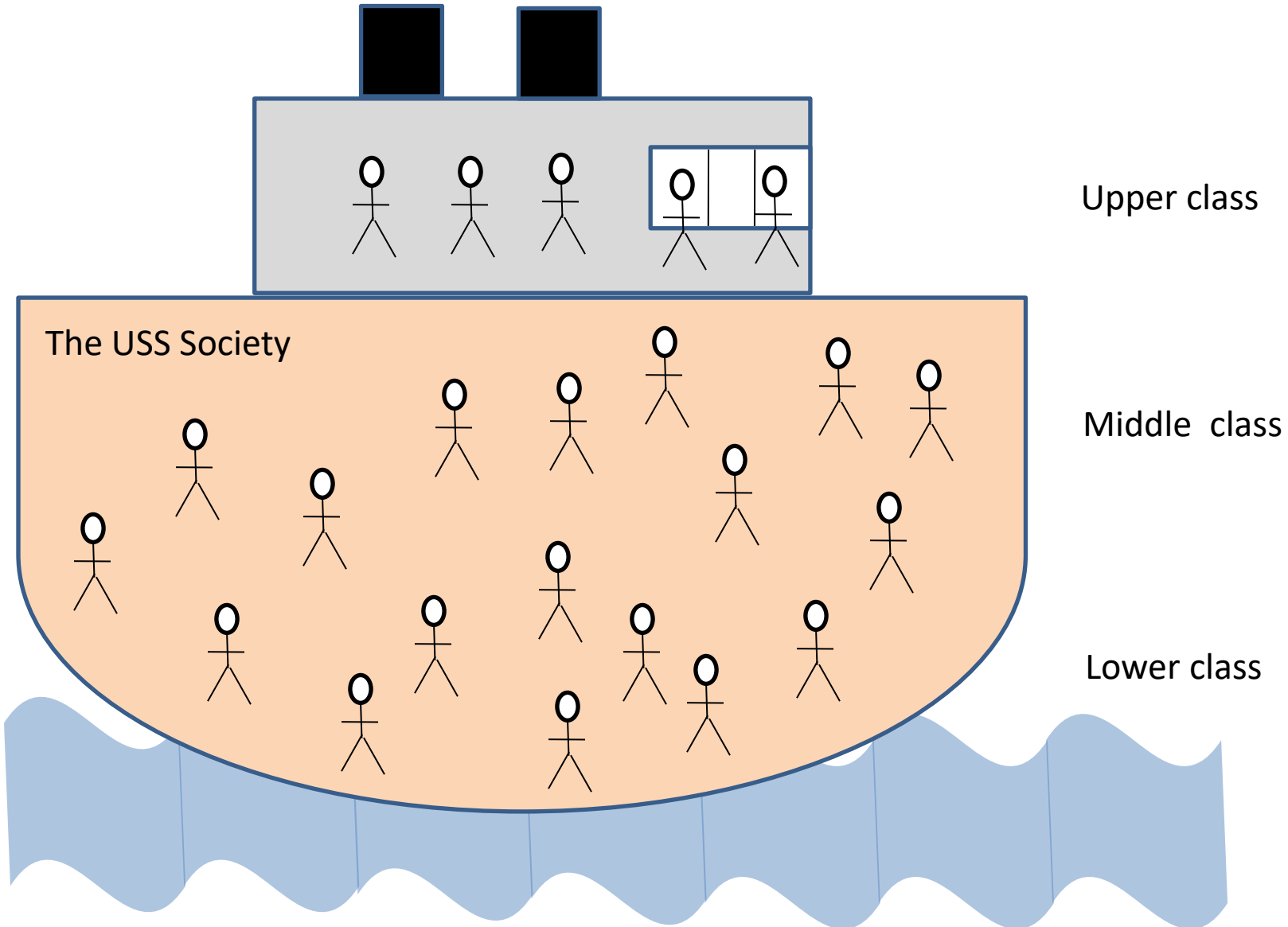
Personal catastrophe

Using the model to understand behavior

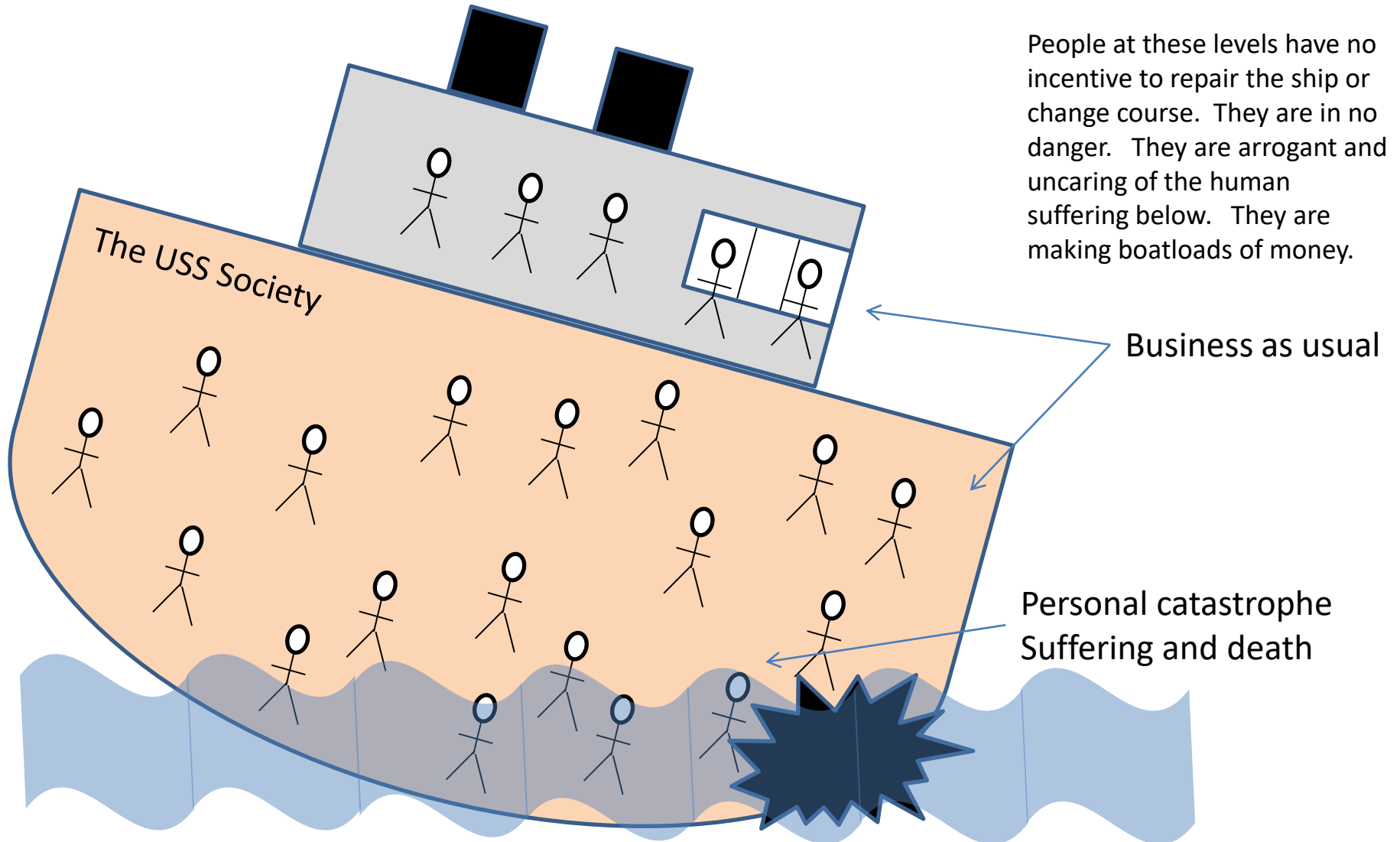
Those in control drive the ship to make profit for themselves and maintain their control. They have no other agenda.

Democracy? No. OLIGARCHY. i.e rule by a few.

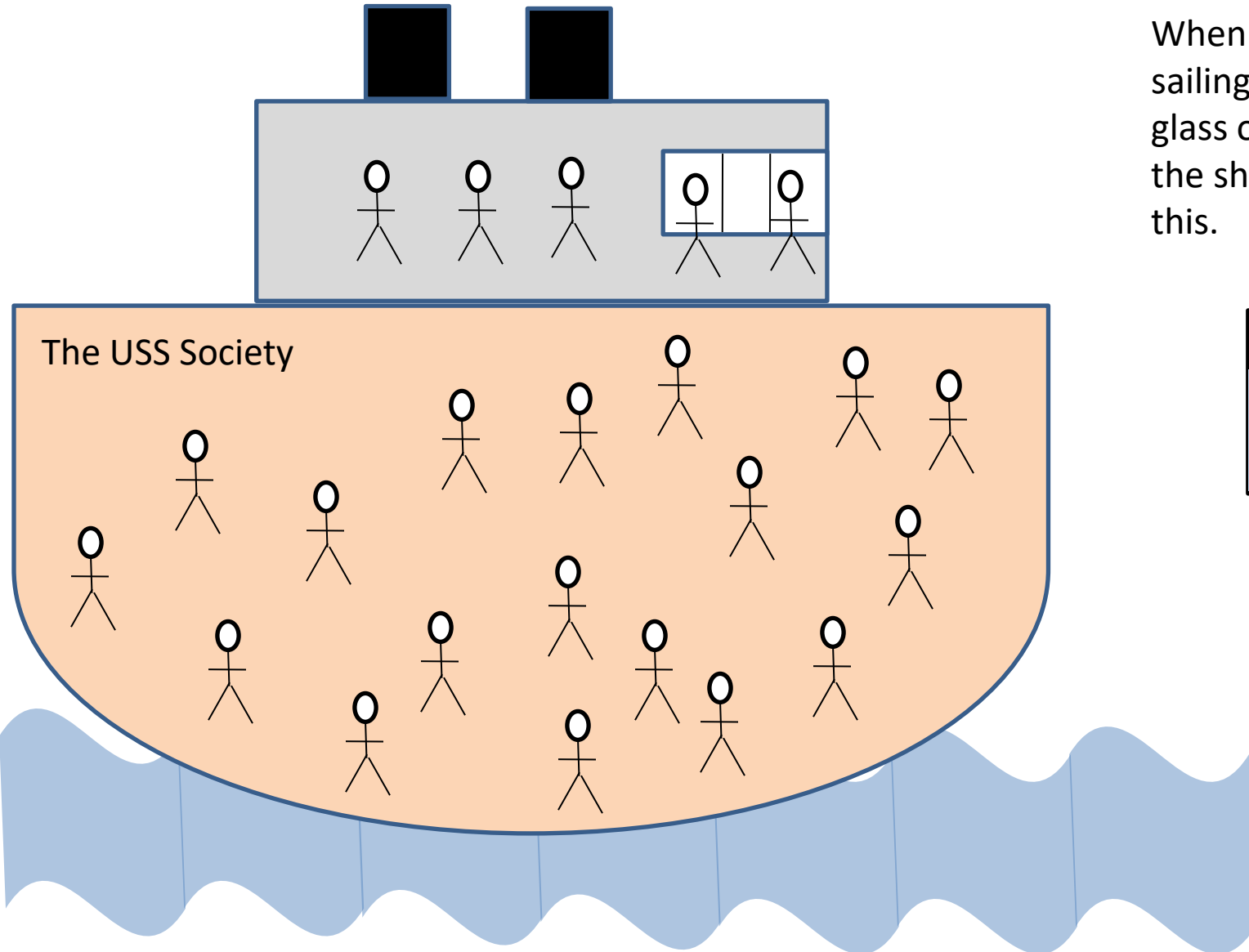


Based on this model if the ship is damaged is it an “accident”?

How can anyone on the ship see if the ship is in trouble?

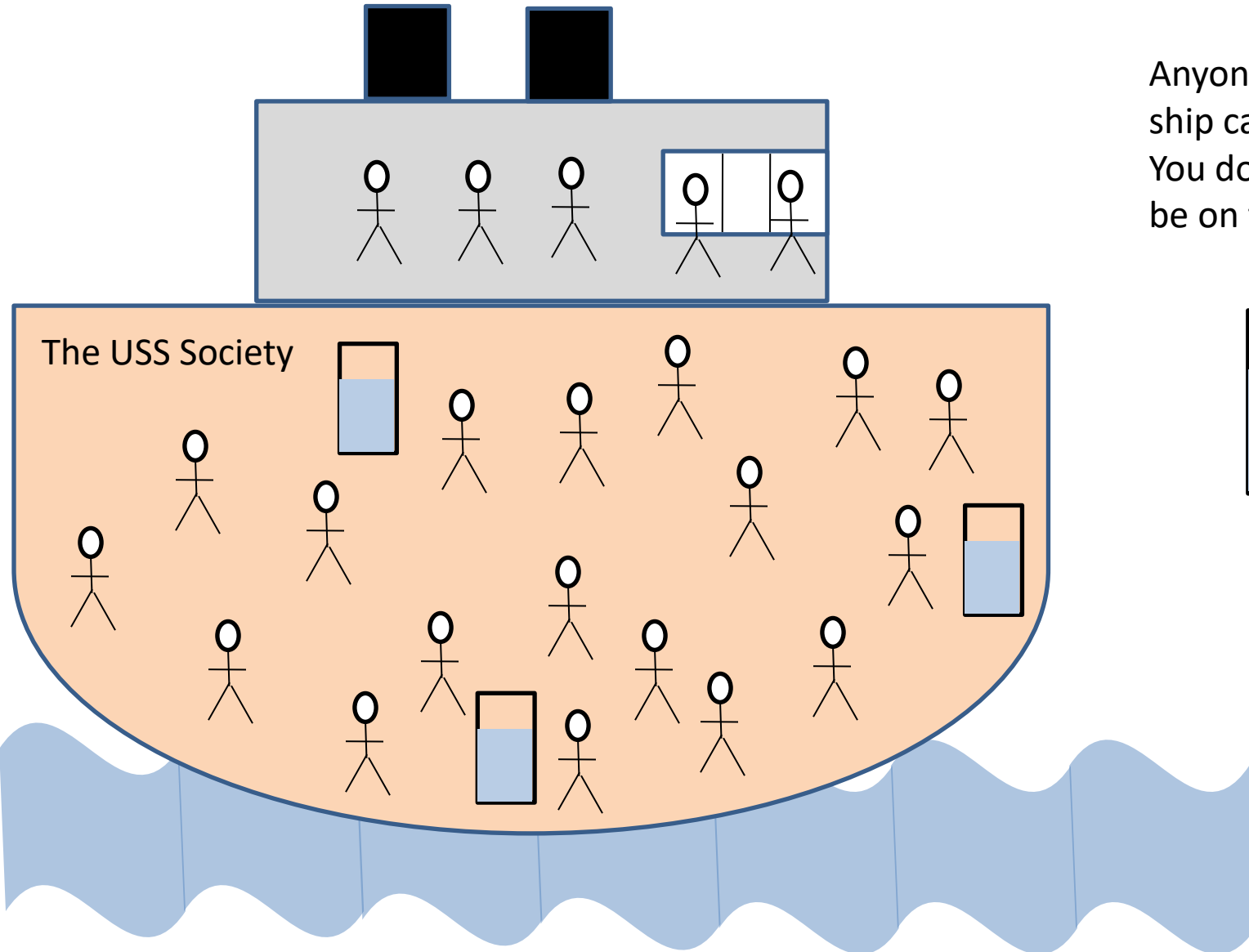
Real world indicators: A glass of water



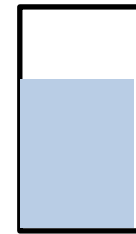
When the ship is sailing normally, a glass of water on the ship looks like this.

Real world indicators: A glass of water

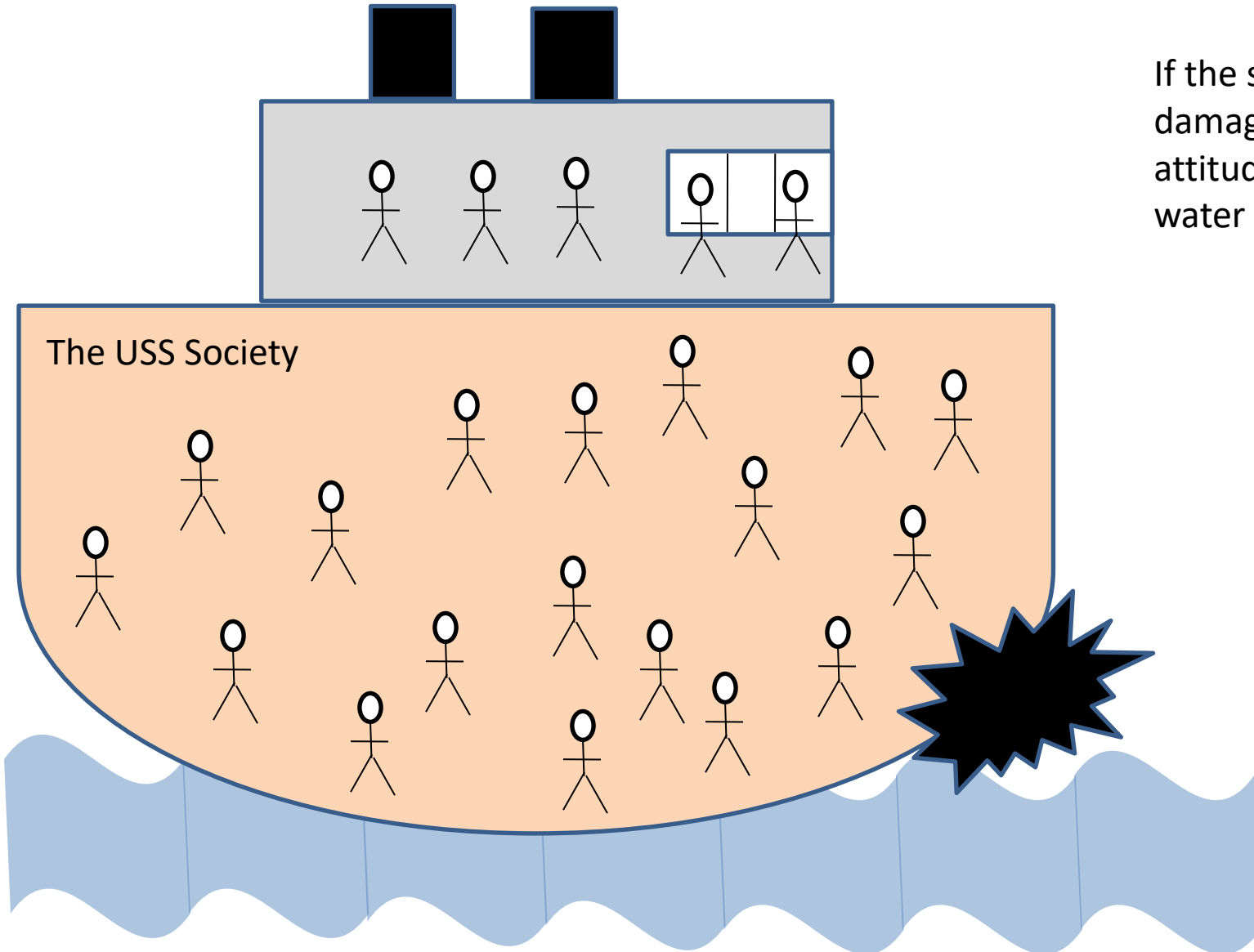


Anyone on the ship can see this. You don't have to be on the bridge.

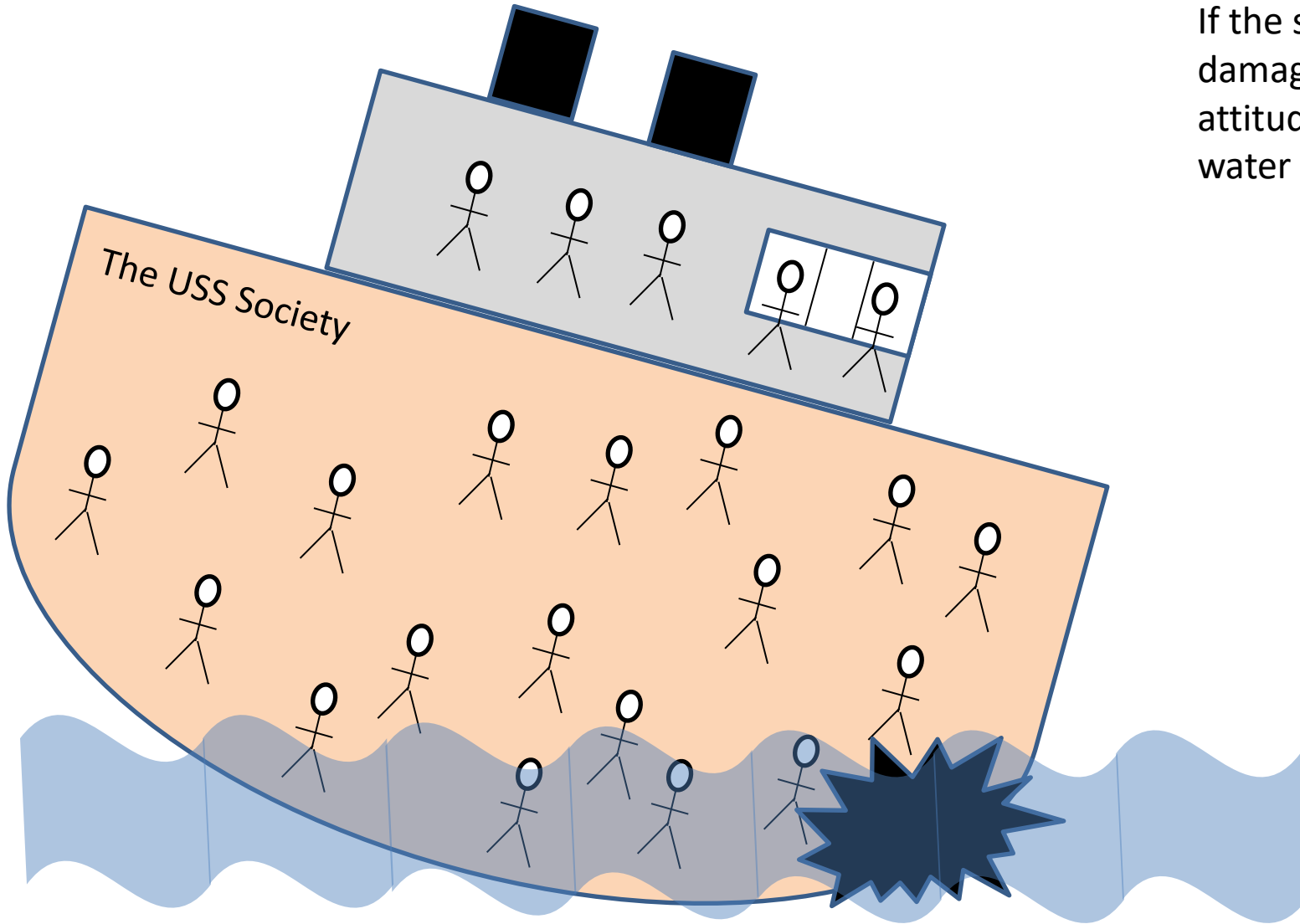
Real world indicators: A glass of water

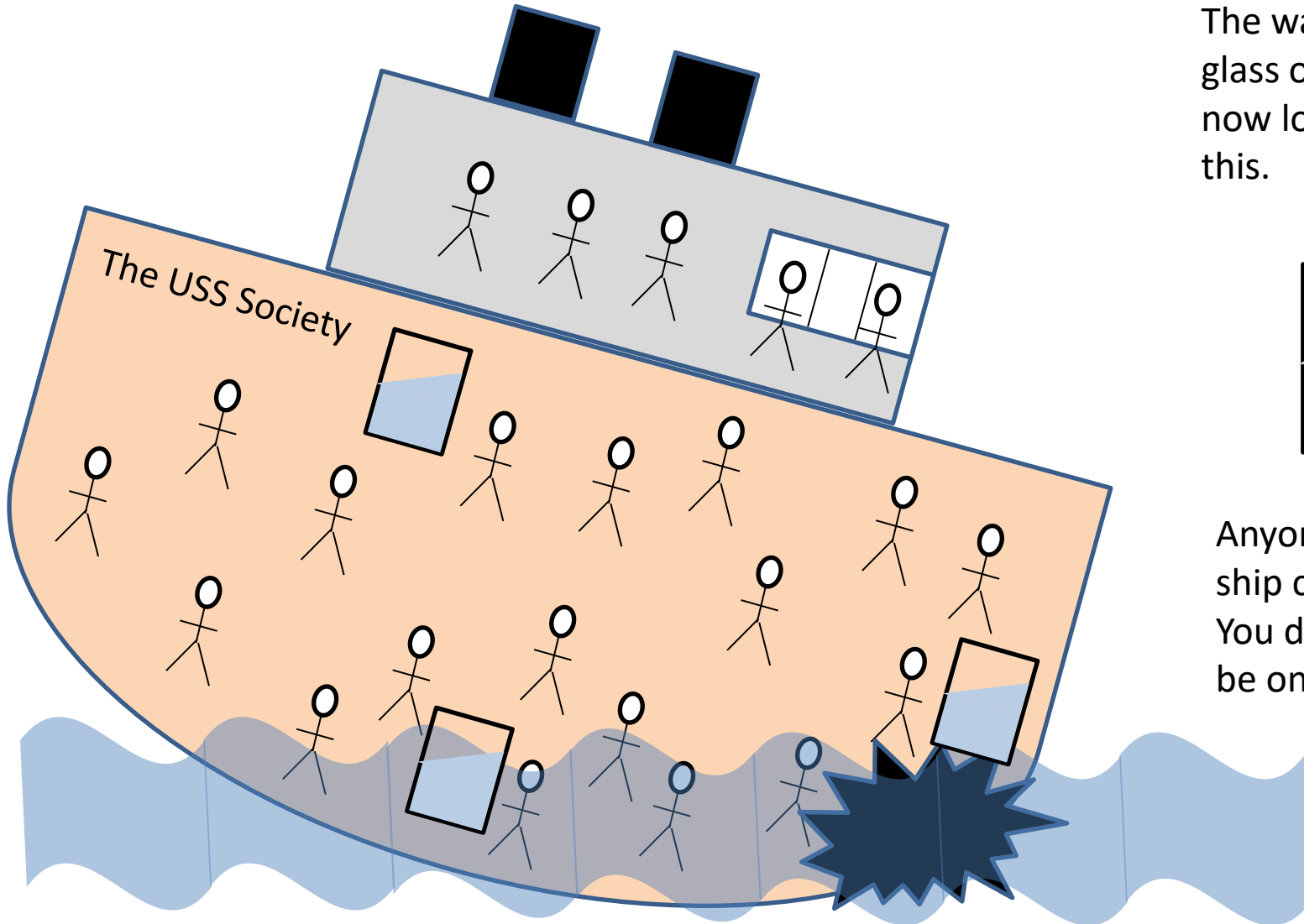
Real world indicators: A glass of water



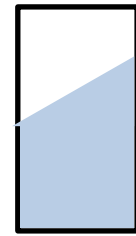

Real world indicators: A glass of water

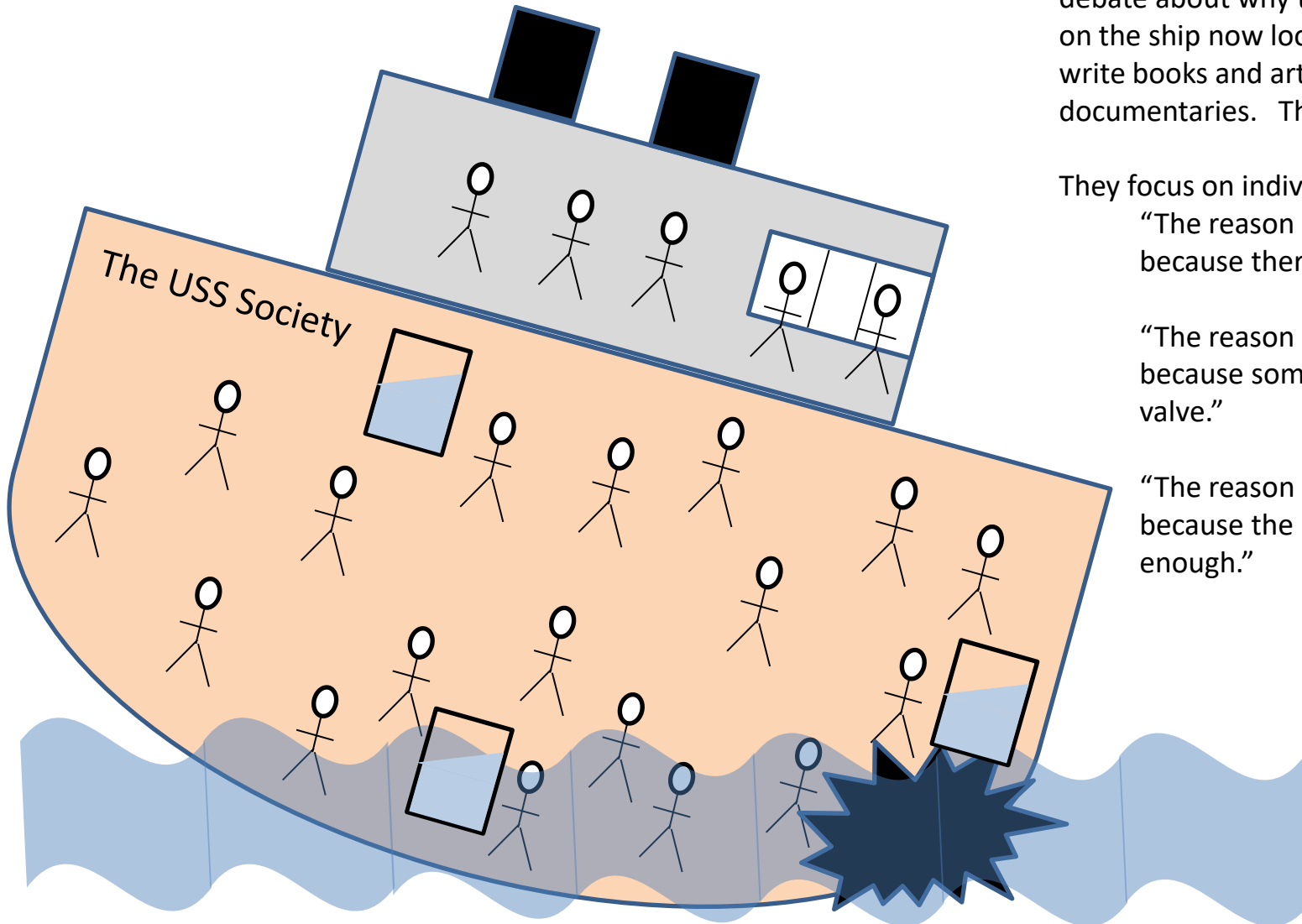
People on the upper decks argue and debate about why the water in a glass on the ship now looks like this. They write books and articles. They make documentaries. They lecture.

They focus on individual causes like:

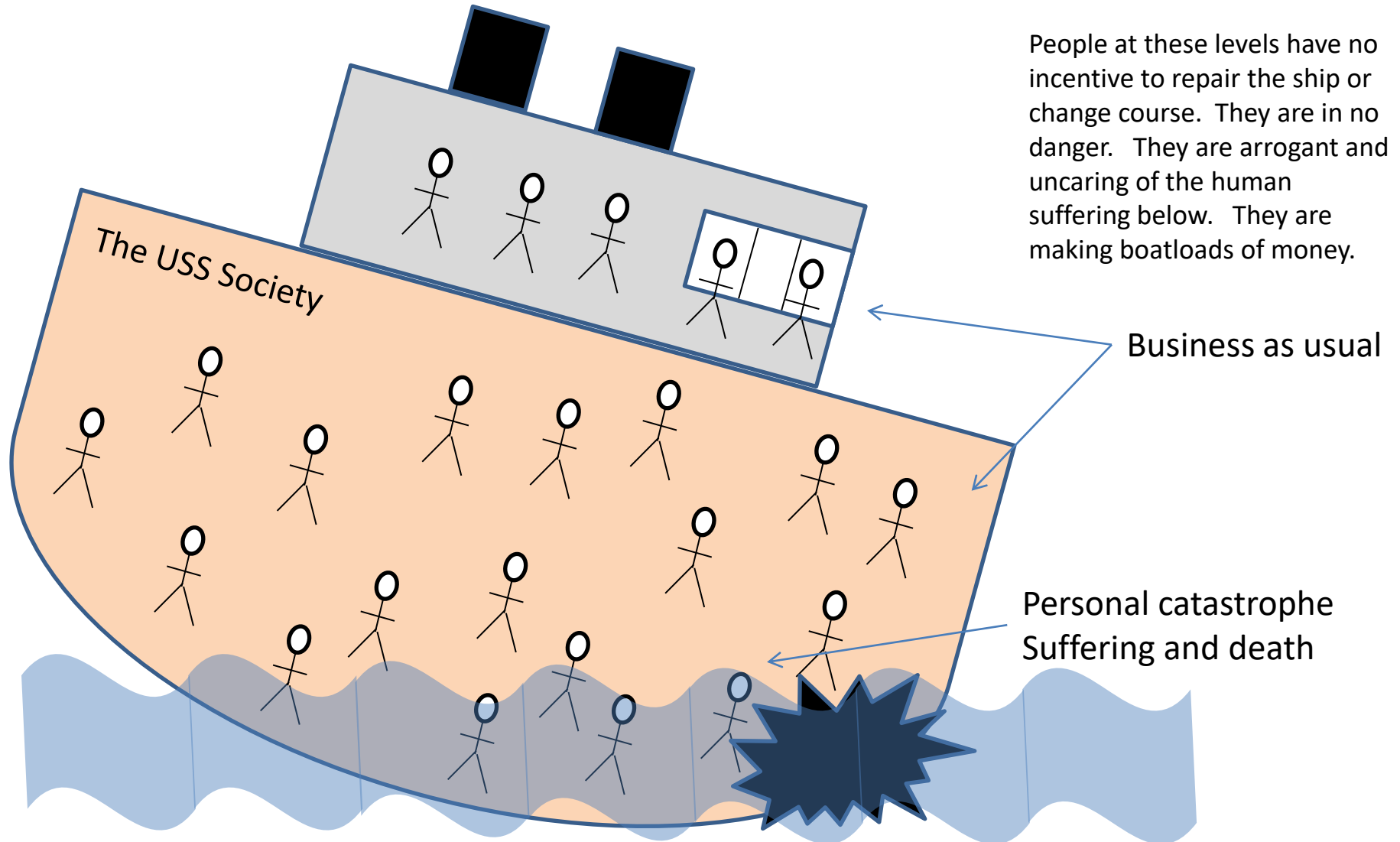
“The reason the boat is tipped is because there is a hole in it.”

“The reason the boat is tipped is because someone didn’t close a valve.”

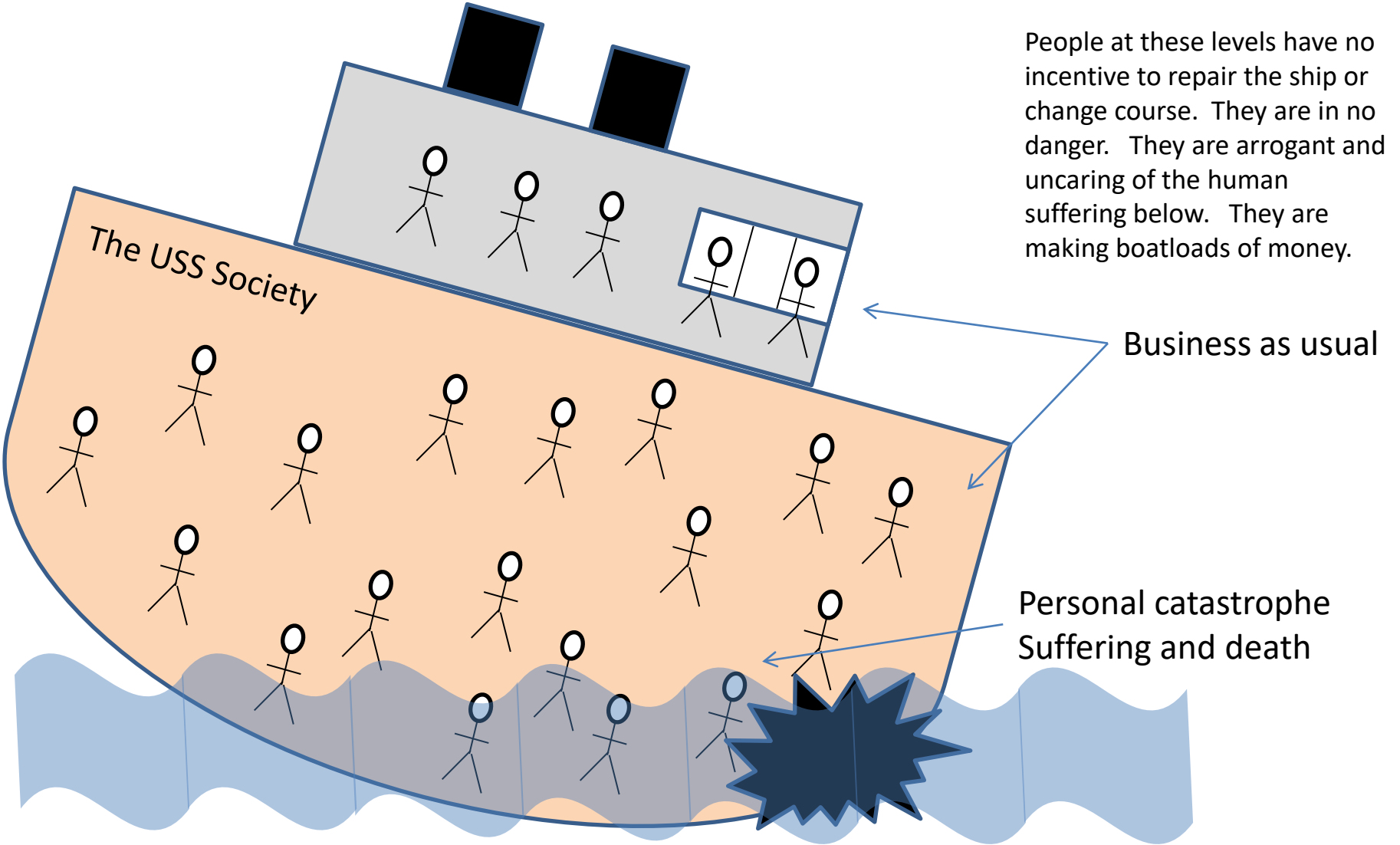
“The reason the boat is tipped is because the hull isn’t strong enough.”



While the people on the upper decks debate and discuss, hundreds of millions live in poverty, disease, suffering, and death.



The problem is the social model and those who have controlled this model for thousands of years. That is humanity's social disease. All other considerations are symptoms. If you treat the symptoms and not the disease then the situation will never change.

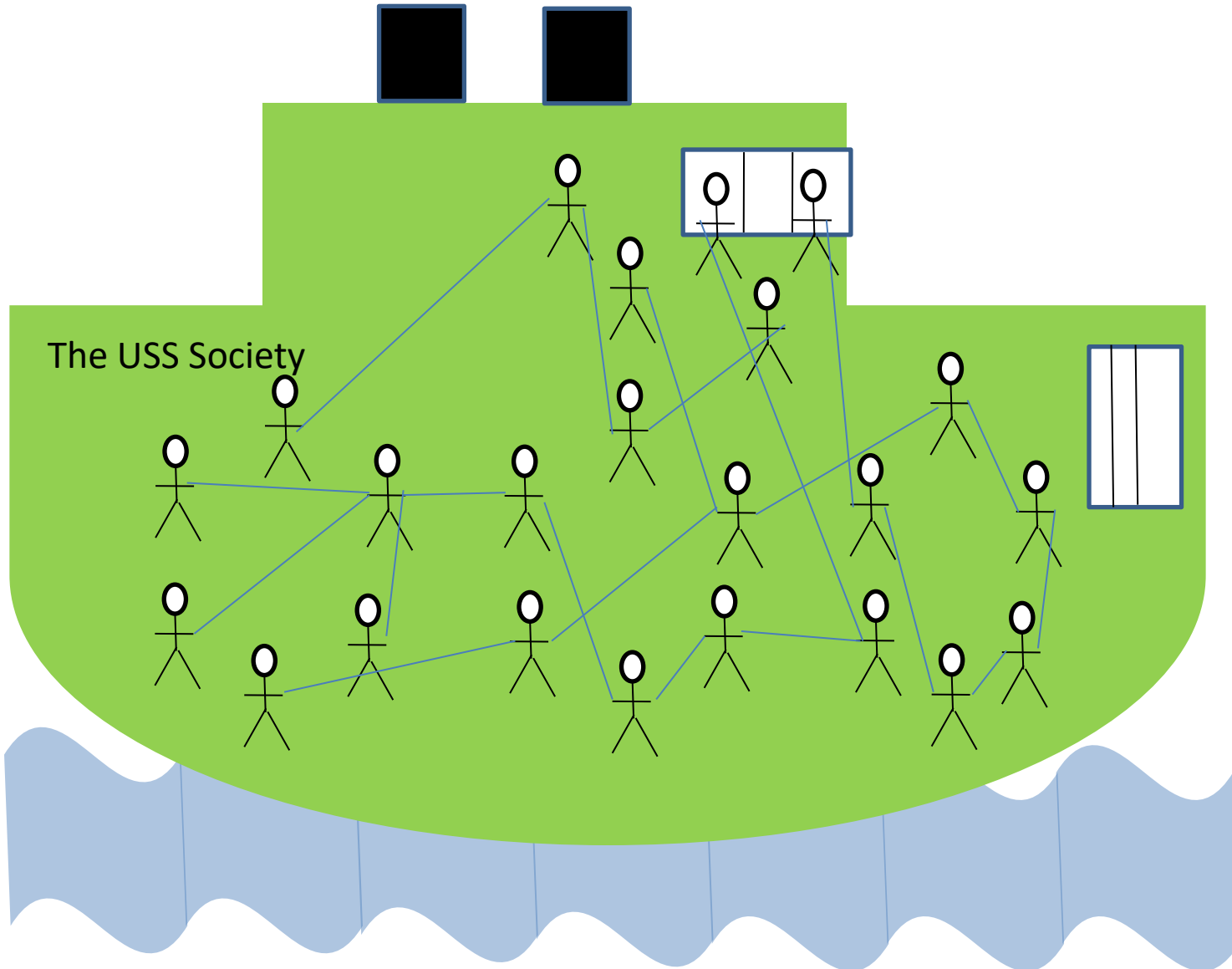

The answer is to create a new social reality based on a new model at both the personal and social levels where people are connected by common perspective, motivation, training, and social goals.



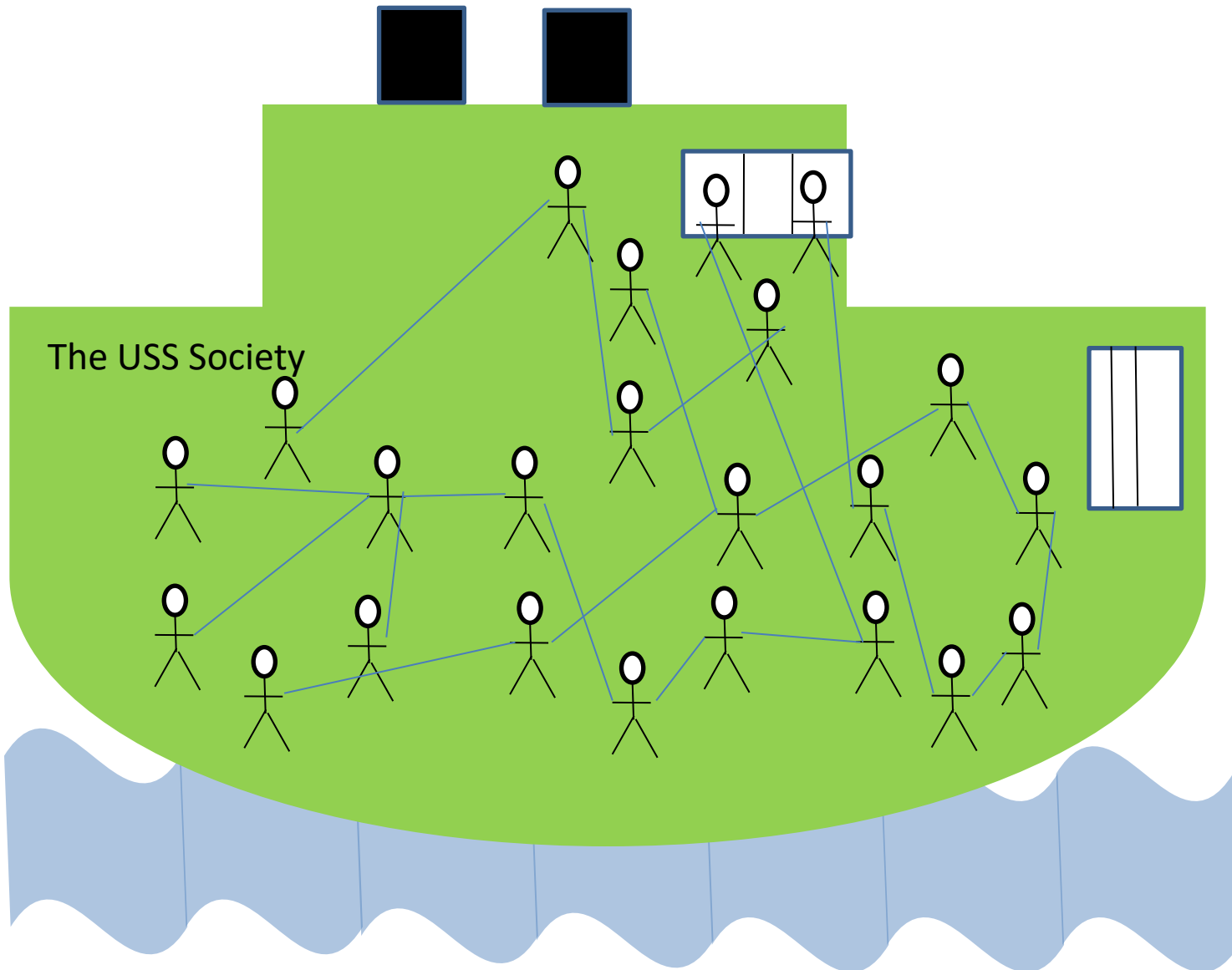
The ship must be built so that everyone can see what is coming.

To create a new social reality based on a new model at both the personal and social levels you must create different type of individuals.



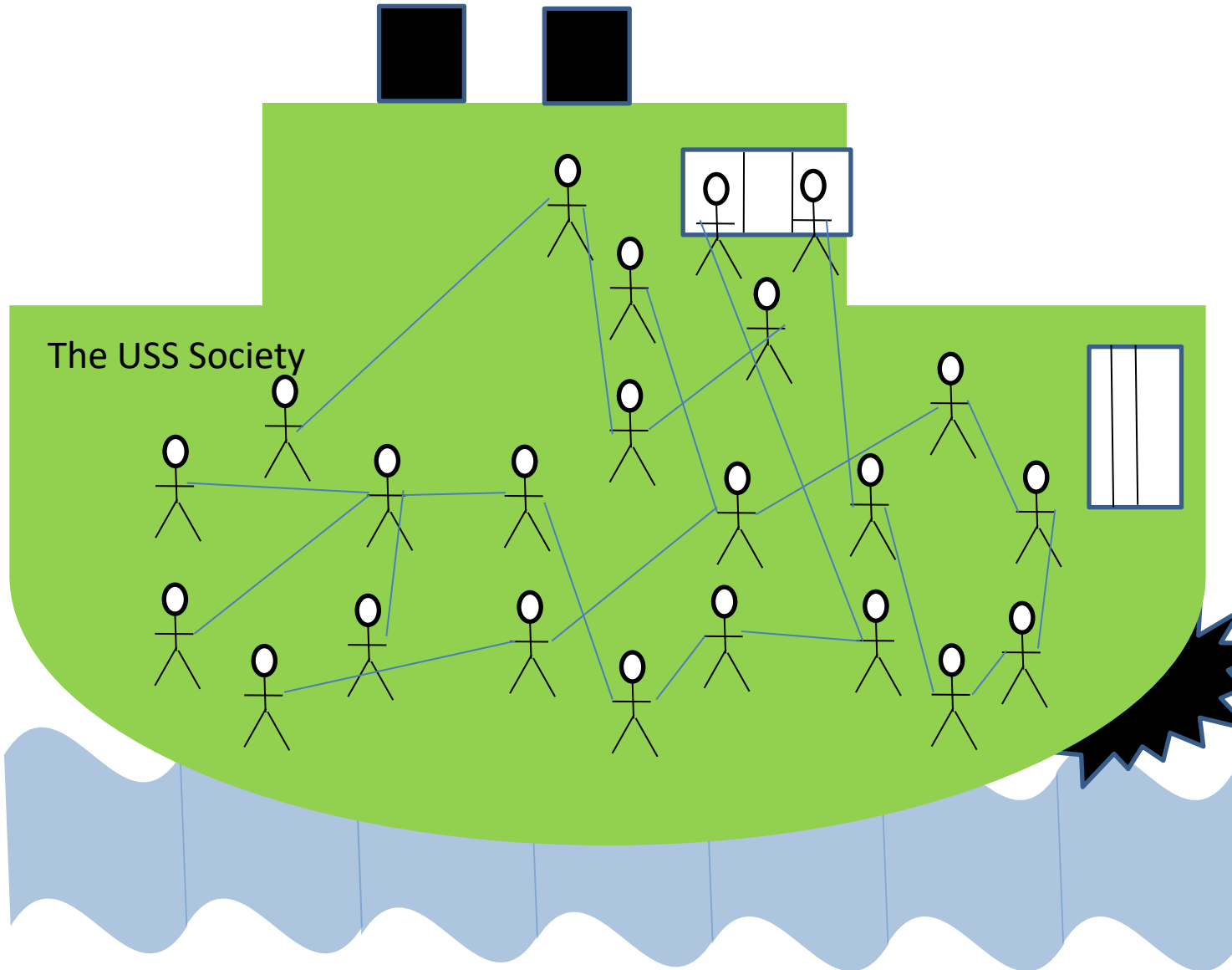

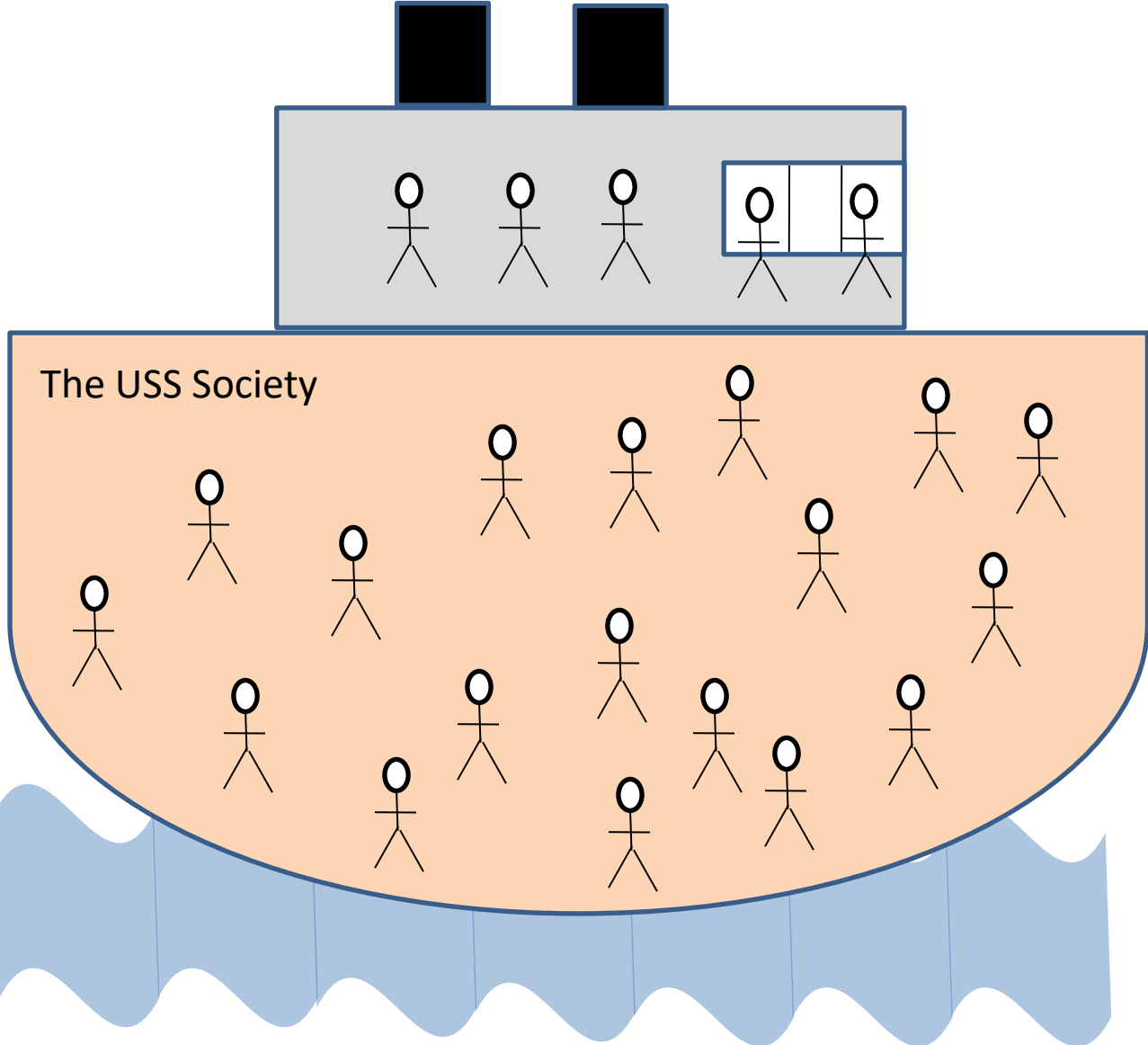

NONE OF THEM

Upper class

Has the means and the education but no motivation. As far as they are concerned, they already have everything they want or need.

Middle class

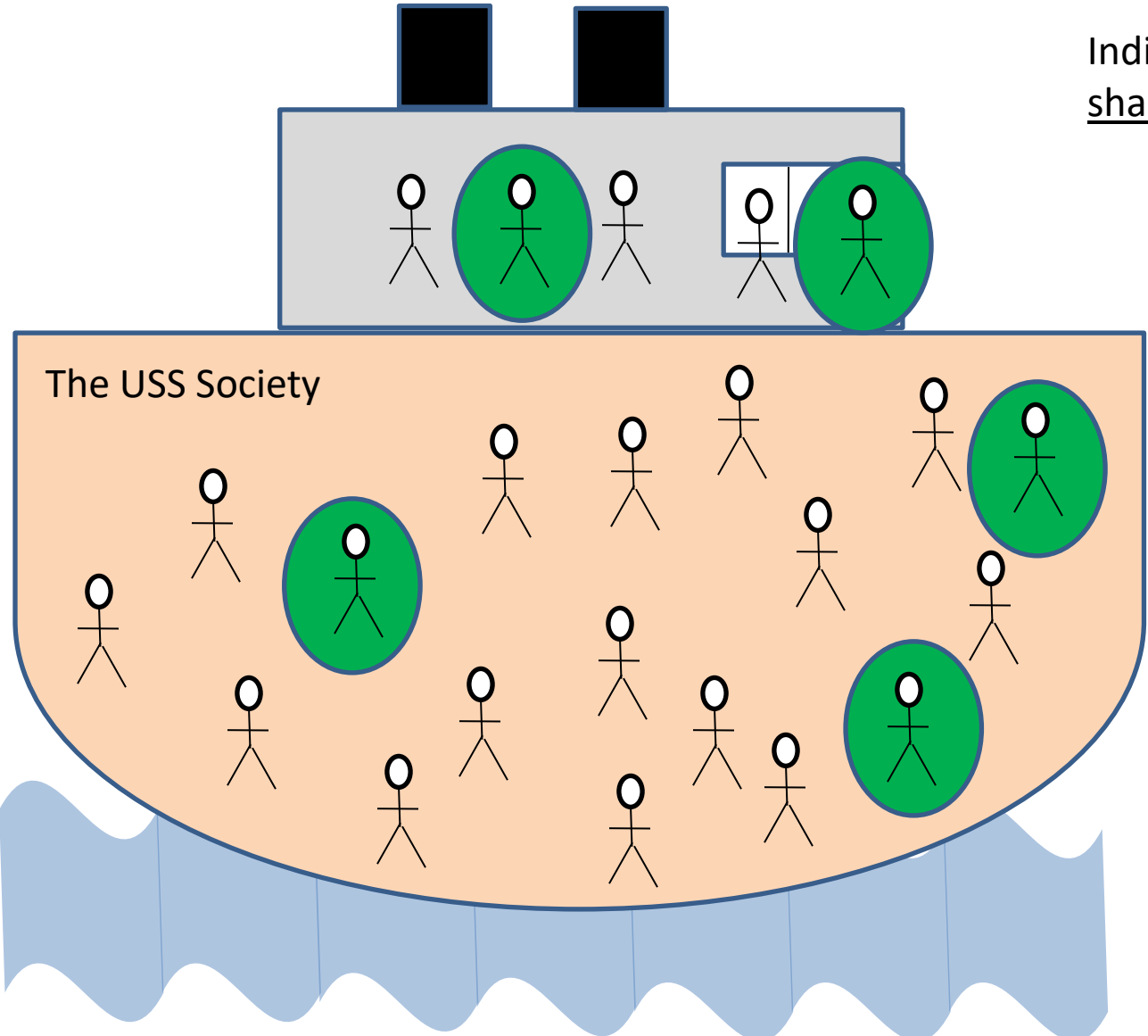
Has no motivation. As long as they get their material and psychological payoff, they already have everything they want or need.

Lower class

Has the motivation, but no means, education, or experience.

We are not trying to convince anybody of anything. We are trying to find the people who already have reached these conclusions and want to band together and work together to our mutual benefit.

Who then will join SSAF and begin building a new social order?



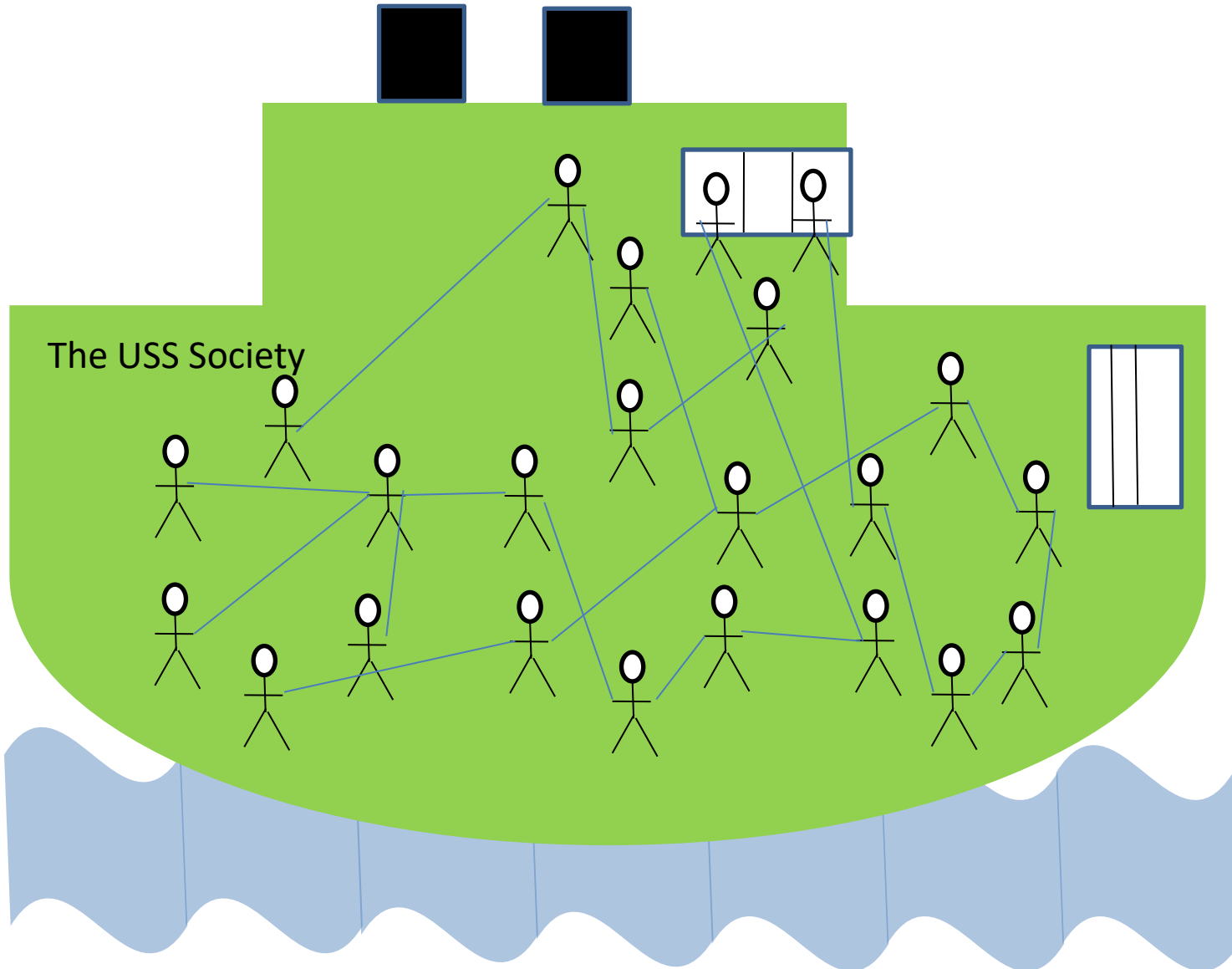
Individuals with an existing shared perspective.

Once these individuals understand that they have common perspective, common understanding, and common cause they can immediately begin working together to mitigate the threats presented by the existing system both at the personal and the social level.



Social change happens at the level of the individual.

Social benefit will be seen when there are enough individuals with the new perspective.

However, personal benefit will be seen as SOON AS WE START WORKING TOGETHER! 😊

The Strategic Social Architecture Foundation approach

Approach for fundamental social change – Strategic Social Architecture

It is a basic premise of Strategic Social Architecture that the people, each individual, are the bricks of the society. The sum of all their characteristics and behaviors create the reality of the resulting social order. The development of individuals who share a common perspective of principles and approach is the key to the Strategic Social Architecture Foundation view of social change.

The danger of the inability of the general population to control the institutions which exert such profound influence over their lives is described very well by [President Dwight D. Eisenhower in his farewell address](#) (emphasis - bold text - added here to call out the areas pertinent to this discussion):

"...This conjunction of an immense military establishment and a large arms industry is new in the American experience. The total influence -- economic, political, even spiritual -- is felt in every city, every State house, every office of the Federal government. We recognize the imperative need for this development. Yet we must not fail to comprehend its grave implications. Our toil, resources and livelihood are all involved; **so is the very structure of our society.**

In the councils of government, **we must guard against the acquisition of unwarranted influence, whether sought or unsought, by the military/industrial complex. The potential for the disastrous rise of misplaced power exists and will persist.**

We must never let the weight of this combination endanger our liberties or democratic processes. We should take nothing for granted. **Only an alert and knowledgeable citizenry** can compel the proper meshing of the huge industrial and military machinery of defense with our peaceful methods and goals, so that security and liberty may prosper together.

Akin to, and largely responsible for the sweeping changes in our industrial-military posture, has been the technological revolution during recent decades.

The prospect of domination of the nation's scholars by Federal employment, project allocations, and the power of money is ever present and is gravely to be regarded..." Dwight D. Eisenhower, 1961 Farewell address

The creation of an alert and knowledgeable citizenry and a social order where they can exercise realistic and effective control of the social institutions of the social order is the sole purpose of Strategic Social Architecture Foundation. In order for a person to be alert and knowledgeable they must first liberate themselves from the captivity of cultural programming, misinformation, propaganda, and integration of the cultural mythology into their personality and personal identity. Second, a person must commit to the time necessary to do the research necessary to develop and maintain a clear understanding of the true Social Architecture, Operating Model, and Key Performance Indicators of the social order.

The Strategic Social Architecture Foundation approach (con't)

The mission of the Strategic Social Architecture Foundation is to create and support people with free minds.

- 1) Create human beings who have a set of characteristics defined by the participants, not implanted by a pre-existing social order and its cultural programming mechanisms.
- 2) Provide citizens with the processes and the tools necessary to detect and neutralize psychopaths/sociopaths and the destruction psychopaths/sociopath cause in society.
- 3) Provide the groundwork for the creation of a global human society which will have defined characteristics i.e. universal health care, peace, etc.
- 4) Provide the framework for a social order where people can successfully work together to mitigate and eliminate the threats we face today and into the future.

Strategic Social Architecture is an approach for creating a social order based on the development and support of people with specific characteristics defined by the participants. The fundamental characteristics of the citizens of an SSA based society are effective self awareness, social responsibility, and resistance to psychological manipulation.

This conceptual solution is not drawn from nor does it correlate with any previous social architecture due to its focus on the characteristics of the individual as the essential component and driver for creation and maintenance of the social order. Strategic Social Architecture is a social approach, not a social system.

The main principle of Strategic Social Architecture is that the sole mission of the social order is the creation and training of individuals who CAN run their own social order and who have characteristics which will not allow them to turn into or allow themselves to be dominated by psychopathic oligarchs.

The people, each individual, are the bricks of the society. The sum of all their characteristics is the nature of the resulting social order.

It is the people involved who will finalize, complete, and implement a society based on the Strategic Social Architecture approach. This approach is in keeping with the new paradigm where the citizenry actually has full understanding, responsibility, and control of the society in which they live.
