HAWAII BULLY SHOWDOWN GOALS

- Foster a sense of inclusivity and belonging by providing an event where people from all walks of life can come together, interact, and create lasting connections.
- Collaborate with local business and kennels to create a platform for showcasing their work and productions, thereby promoting community engagement and support.
- Organize community-focused and family fun activities.

VENDORS ARE NOT ALLOWED to have dogs in their booths unless (a) have a standard kennel booth in addition to their vendor booth, or (b) have a sponsor booth. **FOOD VENDORS ARE STRICTLY PROHIBITED FROM HAVING ANY DOG IN THEIR BOOTH, regardless of sponsorship for health and sanitary reasons.**

SHARING OF BOOTHS AMONG DIFFERENT BUSINESSES IS STRICTLY PROHIBITED.

APPLICATION PROCESS

1. All vendors must complete and submit application form to participate in the night market.
2. Submission of the application does not guarantee acceptance. Vendors will be selected on various criteria, including product and quality.
3. A confirmation message will be sent to vendors. Vendors will have 24 hours to respond and confirm. Approved vendors will be sent further instructions with their confirmation of attendance.

FEES & PAYMENTS

- a. Vendors are required to pay a participation fee to secure a space at the Hawaii Bully Showdown.
- b. All fees must be paid in advance and are non-refundable, even in the event of cancellation by the vendor. Non-refundable fees ensure commitment as event organizers may have turned down other potential vendors to accommodate the vendor's participation.

SETUP & HOURS OF OPERATION

- a. Vendors are required to supply their own tent, tables, chairs, and if needing additional lighting. The use of generators (either gas or electric) must be specified on application.

- b. Vendors must arrive at the designated setup time and have their booth ready for business fifteen (15) minutes prior to the start of the event.
- c. Vendors are expected to operate their booths for the duration of the event. Early teardown is strictly prohibited unless approved by event organizers.
- d. Event set-up instructions will be sent to vendors no later than **April 1, 2026**.

CLEAN-UP

- a. Vendors are responsible for cleaning up their booth area at the end of the event.
- b. Trash and waste must be properly disposed of in designated bins.

PRODUCT DISPLAY

- a. All vendors must display and have their GE license visible at all times of the event.
- b. Food vendors must display and have visible at all the times of the event the following:
 - Special Event or Food Establishment Permit
 - GE License
- c. Vendors are responsible for the quality and safety of their products.
- d. All products must comply with relevant laws and regulations.
- e. Displays must be attractive, clean, and well-maintained.

HEALTH & SAFETY

- a. Vendors are responsible for ensuring the health and safety of their customers and staff.
- b. Compliance with all health and safety regulations is mandatory.

FOOD VENDORS

- a. Special event food permit (for food vendors with prepared products) will have this displayed and visible for the duration of the event.
- b. Food Handlers Certification (prepared food vendors)

CANCELLATION OR CHANGE OF VENUE

In the event of cancellation or a change in venue due to unforeseen circumstances (severe weather, natural disasters, or other emergencies) event organizers will notify vendors as soon as possible.

- a. Event organizers will make reasonable efforts to reschedule the event or find an alternative venue. However, if rescheduling or relocation is not possible, vendors acknowledge that participation fees will not be refunded.
- b. Vendors understand and agree that event organizers will not be held responsible for any losses or damages incurred because of event cancellation or venue change.

ZERO-TOLERANCE

- a. There is zero-tolerance for unacceptable behavior. Participants are required to always maintain professionalism and courteous manner. Any discrepancies or disagreements must be promptly reported to the event coordinators for further investigation. Violators will be immediately escorted off the premises and will forfeit their participation in the event without a refund. If necessary legal action will be taken.
- b. Unacceptable behaviors include any form of harassment, bullying (bad mouthing on social media, disrespectful and distasteful comments or remarks made via text or calls), any form of threat or comments that would endanger the lives of other participants and their associates.
- c. **The sale and use of alcohol or drugs is strictly prohibited at the event.**
