The Nurses Pub conducts an After-School Program in collaboration with the LA Unified School District and HEET Community of Schools. This initiative helps high school students aiming for medical careers through CPR training, mentoring, stipends, scholarship guidance, and workshops. The organization aims to empower aspiring nurses, particularly those from underserved, economically disadvantaged, or at-risk communities, by providing resources and mentorship to help them pursue nursing and other medical careers.

Gala

The Nurses Pubs annual Scholarship Gala draws hundreds of student participants and raises crucial funds to support nursing education. Past gatherings have also helped lay the groundwork for a proposed Resource & Education Center tailored to the needs of students, especially single parents.

Covid Testing

The Nurses Pub COVID testing site in San Bernardino was part of a community outreach initiative led by The Nurses Pub (in partnership with the California Department of Public Health), aimed at serving residents in disadvantaged communities particularly those experiencing homelessness. The site offered free COVID-19 testing along with essential resources like food, socks, sanitizers, and connections to medical services.
