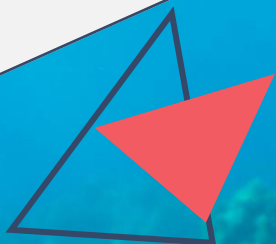




ST CLIMATE

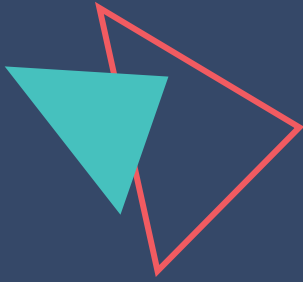
