Dear IRS person:

On June 9, 2025, an entire packet was sent to IRS to request an organizational name change and incorporation structural change. Due to severe delay from IRS in responding to an IRS-posted legal right of our organization, the lack of an IRS officially-changed Letter of Determination has forced the financial dissolution of the entity. All assets have been transferred, under IRS rules, to another 501c3 Nonprofit Corporation by Board of Directors on October 27, 2025. On November 19, 2025, the entity was legally dissolved under Louisiana Nonprofit Corporation law.

We hereby request a termination of the EIN 81-2980752. A Form 990-N (e-postcard) was completed online on January 5, 2026, noting termination of November 19, 2025. A complete Form 990 will be filed by the 5 month deadline of the dissolution/termination of the entity EIN of 81-2980752.

Because A, as both the restructuring organization and the surviving organization, is a domestic business entity classified as a corporation, pursuant to section 5.01 of this revenue procedure, A continues to be recognized as exempt under section 501(c)(3) and is not required to file a new Form 1023.”

RESOLUTION OF THE DIRECTORS OF NATCHITOCHE TRIBE OF LOUISIANA NATION

Pursuant to Notice or Waiver of Notice at special meeting of the Directors of Natchitoches Tribe of Louisiana Nation, a Louisiana Nonprofit Corporation, upon motion duly made and seconded, the following resolution was adopted by a two-thirds majority of the Directors present and entitled to vote thereon:

RESOLVED, by the Directors of the Corporation as follows:

According to Louisiana Nonprofit Corporation Law section 12:250, a voluntary proceeding for dissolution is approved. The Board appoints Fred Simon as the official liquidator to conduct the dissolution. This process will follow requirements of all Louisiana Nonprofit Corporation law.

As required by State law and IRS 501c3 law, all assets are transferred to another Nonprofit Corporation having both IRS 501c3 status and similar charitable purposes as Natchitoches Tribe of Louisiana Nation (EIN 81-2980752). That entity is "Natchitoches Tribe of Louisiana" (EIN 81-2711798).

According to Louisiana Nonprofit Corporation Law section 12:249, all rights, powers, and duties of the officers and Board of Directors of the corporation shall be vested in the liquidator (Fred Simon) and the authority and duties of the officers and Directors of the corporation shall cease, except as defined by law to preserve the assets for legal transfer to the "Natchitoches Tribe of Louisiana."

WHEREAS, the Board of Directors has been informed that Natchitoches Tribe of Louisiana Nation (EIN 81-2980752) (the "Transferor"), a 501(c)(3) organization, is dissolving and has proposed the transfer of its assets and certain liabilities to Natchitoches Tribe of Louisiana (EIN 81-2711798) (the "Transferee");

WHEREAS, the Board of Directors has reviewed the charitable purposes of the Transferor, as stated in its Articles of Incorporation, and has determined that the Transferor's mission is consistent with the charitable purposes of the Transferee;

WHEREAS, the Board of Directors has conducted due diligence, including a review of the Transferor's financial statements, assets, and liabilities, and has determined that accepting the transfer is in the best interest of the Transferee and its mission;

WHEREAS, an Asset Transfer Agreement will be prepared by the end of the State Dissolution, detailing the specific assets to be transferred and the liabilities to be assumed;

NOW, THEREFORE, BE IT RESOLVED, that the Board of Directors of Natchitoches Tribe of Louisiana EIN 81-2711798 hereby approves and accepts the transfer of assets and assumption of liabilities from Natchitoches Tribe of Louisiana EIN 81-2980752, as determined by the review of the Transferor's financial statements, assets, and liabilities, and as will be further outlined in the Asset Transfer Agreement.

BE IT FURTHER RESOLVED, that the assets received will be used solely for charitable purposes consistent with the Transferee's tax-exempt status, and any donor-restricted funds will continue to be honored and used for their designated purpose.

BE IT FURTHER RESOLVED, that the Fred D. Simon, President/Primary Chief, and Peggy Smith, Treasurer, are hereby authorized and directed to execute any and all documents necessary to effectuate the asset transfer.


