




CONDITIONS FOR USE OF COUNCIL CAMPING PROPERTY

- ✦ The best rules are the Scout Oath and Law, combined with good common sense.
- ✦ To avoid misunderstanding, the following conditions also prevail.
- ✦ Thank you for your corporation and have a great campout!
- ✦ Please have the courtesy to call the camp if you need to cancel within two days of your arrival date.

- 1. Reservations** are done online and are confirmed only when a payment is received. All reservations are on a first come, first served basis. Camp cannot be responsible for the loss or damage of unit or personal items.
 - 2. Arrival / Departure** check-in/out must occur with the ranger or campmaster. Check in time is prior to 10:00 pm on Friday. If checking in after 9:00 pm, call the camp ranger. Check out time is no later than 2:00 pm Sunday for weekend camping trips. Groups must remain in camp until properly checked out.
 - 3. Parking** must occur only in assigned areas. No vehicles are permitted past the parking lot without permission from the camp ranger. Carts are provided to transport equipment and are available at the trading post. Roads must be kept open for travel at all times. Camp speed limit is 10 mph.
 - 4. Off Limit** areas include all buildings and related grounds, unless authorized by your reservation. This includes, but is not limited to, the Challenge Course and Conference Center.
 - 5. Camp Activity Hours** are between 7:00 am and 10:00 pm. At all other times, please confine your group to the limits of your campsite and be considerate of others. Do not enter other campsites without permission from unit leader.
 - 6. Conservation** service projects to improve the environment are encouraged. See the ranger in advance for a project. The outdoor code should be in action at all times. The use of tools must be supervised by a unit leader. The ranger may deny the use of any tool wherever their use is deemed unsafe. If any live trees are cut or damaged, the unit will be responsible for it's replacement. Replacement must be arranged with the ranger and planted within 6 months
 - 7. Disposal** all solid garbage should be placed in dumpster beside ranger office. Aluminum cans should be bagged separately and placed in the recycling trailer and plastic bottles should be bagged separately and placed in recycling cans beside dumpster.
 - 8. Sanitation** of the latrine in your campsite is your unit's responsibility, including cleaning and proper use. No other method of human waste disposal is permitted in camp. Food preparation or dish washing is never permitted at, or near, latrine area. Drinking water must only be obtained from camp taps and never from springs or streams.
 - 9. Accidents** should be reported to the camp ranger or campmaster immediately. this includes injuries, fires, or property damage. Observe the location of the first aid area and fire equipment and be prepared to cooperate with the ranger if requested. Use of physician or hospital is at the expense of the unit requesting such treatment. The unit or group must arrange transportation of injured person.
 - 10. Firearms**, archery equipment, gas guns, and air guns are prohibited in camp. Shooting sports activities can be scheduled at the camp for a fee of \$5.00 per person for two hours, under the supervision of the camp's shooting sports program. This must be scheduled in advance by calling 412.782.2669.
 - 11. Leadership** for all camping trips must include a minimum of two adult leaders, one who must be at least 21 years of age with a second leader who must be at least 18 years of age. Pack camping and Webelos den overnights must be under the leadership of trained adults in accordance with national BSA standards.
 - 12. Beaver Service Patch** program is available for units conducting service hours at any of the Council's camps. Ask a ranger for a tracking card.
 - 13. Bicycles** are prohibited in campsites. Bicycles are only permitted on paved roads, using proper safety procedures, including wearing helmets at all times. A bicycle program is provided by the camp which includes use of bike, helmet, and a guide to Pittsburgh from the camp and back at a cost of \$20.00 per person with a minimum group of 20 people. This must be scheduled in advance by calling 412.782.2669.
 - 14. Swimming** is available from mid-June through early August. The pool is available for daily use during posted hours under the supervision of the camp's trained lifeguards. Private rentals can also be arranged on Sundays, when the pool is closed for public use.
 - 15. Sled Riding** is only permitted by registered Scouts staying at the camp and under the supervision of their unit leaders. Sled riders must wear a helmet at all times. Helmets are available to use, free of charge, from the trading post, but must be returned every two hours for sanitation and possible waiting list.
 - 16. Smoking** is not permitted inside any building. No smoking is allowed in sight of children.
 - 17. Refunds** will not be issued, unless the camp is closed by the Council Service Center.
 - 18. Prohibited** items on camp property include alcoholic beverages, illegal substances, firearms, fireworks, chainsaws, dogs, cats, other pets, and activities not consistent with the Scout Oath and Law, or Guide to Safe Scouting.
- The council executive board had designated the ranger as authority for dealing with any rule infractions. If immediate safety of others is put in jeopardy, the unit may be expelled at once. For serious, or repeated infraction, such as not checking out of camp, the Council may deny the use of the camps to a unit. If common laws are broken, local police may be notified.
