By and large, they are the same issues that all Americans, as well as the world community, deal with daily. Let's stand up and agree that we as a nation have not gotten the job done relative to prevention and cures. With the money spent and the technological advancements in the past 65 years, not achieving a major prevention or cure since curing polio and small pox. Let's finally return to the America with vision and pro-activity that our parents talked about and we desire. This resolves a need that is common to the entire family of America. Whether you are black or white, rich or poor, Democrat or Republican, we **ALL** suffer equally and will benefit equally.

Any global pharmaceutical company that invests in the ACC will be given pro rata rights to licensing any compounds that are created by the ACC, but are not cures. There will be a no sue zone around all ACC clinical trials and compounds in perpetuity. The ACC will conduct all of its own clinical trials. Each ACC effort will be funded annually with \$6 billion for 6 years. The board can extend the funding based on clear evidence of success and likelihood of cure.
