

CDC QUITTERS WERE PARTISAN ACTORS

EXECUTIVE SUMMARY: Despite their protestations that these are neutral stewards acting in the unbiased interests of public health, in reality, these CDC resignees – being framed by media as "speakers of truth to power" and lauded as "heroes" – have an undeniable, documented record of exclusively supporting Democrats (\$10,439.35 since 2008), leftist causes/policies, and Fauci-era medical authoritarianism. Their staged resignation was motivated by partisan politics, not sound science.

Debra Houry:

 Extensive, consistent history (since 2008) of donating to leftist campaigns. On the record as far back as 2012 writing op-eds for Obama policies. Masking, distancing, vaxxing advocate.

Demetre Daskalakis:

Apparent Satanist (tattooed Pentagrams on chest, Pentagram leather fetish gear)
who endorsed Kamala Harris. Has denied differences between men and women,
advocated for excessive masking/vaxxing. Biden Admin's czar for LGBT/racial
"health equity." Anthony Fauci praised Daskalakis after being tapped by Biden
admin to lead monkeypox efforts in 2022.

Daniel Jernigan:

• Longtime Democrat donor who downplayed the risk of the COVID-19 pandemic before it exploded, dismissed concerns of COVID vaccine health risks (myocarditis), and defended CDC's hoarding of invaluable data while obscuring it from the public.

Debra Houry - Former chief medical officer and deputy director for program and science at the CDC

- Advocate for masking, vaccination, physical distancing: "Flu activity was historically low last flu season, likely due to the widespread implementation of COVID-19 prevention measures—like wearing masks, physical distancing, and staying home." (Nov 2021 op-ed)
- Vaccine advocate: "Routine vaccinations are our best defense against illnesses that can make kids seriously ill, a key tool that can keep kids healthy in school and ready to learn" (CDC, Aug 2024).
- Dishonest: When asked if Secretary Kennedy's promise to "not take vaccines away from people who want to get them" was broken, she <u>told MSNBC</u> that it was broken because the CDC guidelines changed (Katy Tur Reports Thursday, August 28, 2025). Also <u>blamed Secretary Kennedy for "pediatric deaths from measles</u>."
- Houry cited the recent CDC shooting in her resignation: "Recently, the overstating of risks and the rise of misinformation have cost lives, as demonstrated by the highest number of U.S. measles cases in 30 years and the violent attack on our agency." (TheHill)
- Has <u>alleged</u> that Secretary Kennedy is actively attempting to harm people: "I am
 unable to serve in an environment that treats CDC as a tool to generate policies and
 materials that do not reflect scientific reality and are <u>designed to hurt rather than to</u>
 <u>improve the public's health"</u>

LEFTIST POLITICAL OPERATIVE

- Advocate for the Affordable Care Act back in 2012; wrote <u>an op-ed</u> to CNN on November 3, 2012: "When the Affordable Care Act ... is fully implemented, many of the disparities that have plagued the nation's health care system will significantly lessen." Houry wrote extensively about <u>racial disparities</u> in healthcare and <u>opposed</u> <u>Romney</u> on the grounds that he (and Republicans generally) would endeavor to exacerbate those disparities.
- CNN Interview, 2012: "During my time as an ER doc, and throughout my work at CDC, I've seen that the reasons behind inequities and vaccination coverage for people from some racial and ethnic minority groups are systemic and a result of many factors."
- <u>Political Contributions</u>: Between 2008 and 2022, <u>Houry has consistently donated to Leftist organizations including the Obama campaign, ActBlue, the Warren


Demetre Daskalakis - Former Director of the National Center for Immunization and Respiratory Diseases at the CDC

- <u>Politico</u> noted in September 2022 that "[i]n New York, he was well known for going into bath houses and sex clubs to conduct STI testing and help educate its patrons."
- <u>Uses the phrase</u> "Pregnant People" instead of "Pregnant Women."
- March 2021: Named by Biden Admin as "senior vaccine equity lead" (WaPo).
 - Demetre blames disparities in HIV and COVID-19 outcomes on "... long-standing systemic health and social inequities have put many people from racial and ethnic minority groups at increased risk of getting sick and dying from covid-19. Racial and ethnic minority groups are disproportionately represented among covid-19 cases, as well as among HIV diagnoses. Social determinants of health, such as poverty and unequal access to high-quality health care, influence a wide range of health and quality-of-life outcomes and continue to drive inequities."

- Demetre regularly adorns himself with demonic symbology, chiefly the Pentagram of Baphomet (copyrighted symbol of the Church of Satan).
- His long-term partner Michael Macneal (left)
 founded "MONSTER CYCLE," a Satanic gym.
 MONSTER proudly displays slogans such as
 "Satan is Waitin'."








- Daskalakis denies an obsession Satanic symbolism, pointing out that he also has a Jesus tattoo during a September 2022 interview with <u>Politico</u>:
 - Many of the images were mined from his Instagram page, which is chock-full of shirtless pictures showing off 30-plus other tattoos. One article that featured numerous photos of him said "Dr. Daskalakis's social media presence reveals a penchant for pentagrams and other Satanic symbolism." Daskalakis laughs off the charge. For the record, he confirms he's not a Satanist. "I wish I were that interesting."
 - ...Daskalakis notes the pentagram tattoo on his left pec reads: "I believe that there's a light even in the darkest place." He says it represents both his past as a bullied child and living through the AIDS crisis. He also points out that none of the articles has ever mentioned the large Jesus tattoo on his

stomach, inspired by the Greek Orthodox church he grew up attending in Washington, D.C.

- Daskalakis argued to <u>Politico</u> that his "thirst trap" photos legitimize his work and that he does not "give a fuck":
 - O Unlike most public health officials, Daskalakis sees his thirst traps as a part of his work, not separate from it. A photo of him ripping off his leather jacket, exposing his bare chest, was featured in a "Bare it All" ad campaign for the New York City Health Department while he was the deputy commissioner of the city's division of disease control. He said such images help give him a level of trust with the people he's trying to reach that other doctors can't replicate. "I can't give a fuck because otherwise I would be rocking back and forth and [someone] would be stroking my non-existent hair," he says.

ANTI-SCIENCE

- Radical and aggressive advocate of vaccination for monkeypox for the LGBT community, calling for vaccination to create a "national force field of immunity" against the disease spread almost completely through sexual transmission (@CDCgov, Jan 2023).

Daniel Jernigan - Former director of the National Center for Emerging and Zoonotic Infectious Diseases at the CDC

• According to his LinkedIn account, Jernigan was the served as the CDC's Incident Manager (Jan-March 2020) and as CDC Lead from (Mar-June 2020) for the National Response Coordination Center (NRCC) for the joint FEMA DHHS COVID-19 response.

• Jernigan provided guidance on COVID-19 via the AMERICAN JOURNAL OF TRANSPLANTATION (along with three other authors) in March 2020.¹ However, by March 15, shutdowns were already occurring across the country despite the report suggesting the threat from COVID-19 was "low". The report suggests use of masks and the "six feet apart" guidance for those thought to be possibly infected:

- "It is unclear how this virus will impact the US over time. For the general population, who are un-likely to be exposed to this virus at the current time, the immediate health risk from 2019-nCoV is considered low."
- "CDC, multiple other federal agencies, state and local health departments, and other partners are implementing aggressive measures to substantially slow US transmission of 2019-nCoV, including identification of US cases and contacts and managing travelers arriving from mainland China to the United States."
- "CDC currently recommends a cautious approach to the examination of PUIs. These patients should be asked to wear a surgical mask as soon as they are identified, and directed to a separate area, if possible, separated by at least 6 ft (2 m) from other persons. Patients should be evaluated in a private room with the door closed, ideally an airborne infection isolation room, if available."
- Jernigan was featured in a February 2022 NYT article on the CDC's decision not to publish data: The C.D.C. Isn't Publishing Large Portions of the Covid Data It Collects

For more than a year, the Centers for Disease Control and Prevention has collected data on hospitalizations for Covid-19 in the United States and broken it down by age, race and vaccination status. But it has not made most of the information public. When the C.D.C. published the first significant data on the effectiveness of boosters in adults younger than 65 two weeks ago, it

<u>left out the numbers for a huge portion of that population</u>: 18- to 49-yearolds, the group least likely to benefit from extra shots, because the first two doses already left them well-protected...

...Two full years into the pandemic, the agency leading the country's response to the public health emergency has published only a tiny fraction of the data it has collected, several people familiar with the data said...Dr. Daniel Jernigan, the agency's deputy director for public health science and surveillance said the pandemic exposed the fact that data systems at the C.D.C., and at the state levels, are outmoded and not up to handling large volumes of data. C.D.C. scientists are trying to modernize the systems, he said. "We want better, faster data that can lead to decision making and actions at all levels of public health, that can help us eliminate the lag in data that has held us back," he added.

- This "hoarding of data" was criticized, as mentioned in BioSpace in February 2022:
 CDC Under Fire for Allegedly Hoarding COVID-19 Data
 - Citing individuals familiar with the CDC matter, the [NTY] noted that much of
 the withheld information could help state and local public health officials.
 Data on age and race can help public health officials identify the populations
 at highest risk of severe infection, while detailed information on
 hospitalization rates for COVID-19 patients, regardless of age, can provide
 more information on who may need a booster shot.
- Jernigan discussed the mass collection of "surveillance data" on COVID-19 cases with Contagious Conversations in 2022.² Clearly, Jernigan supports a heavily centralized system to collect such information:
 - The big activity right now is stewarding the Data Modernization Initiative, which is a multi-billion dollar activity to try and address a number of longstanding problems in surveillance and data capture that need to be addressed and need to be fixed in order to have public health to a place where it's really modernized...
 - We recognize that we don't get information on every case, but the attempt during COVID has really been to get as much information as possible. And so, that requires that anyone that's tested, that result can be captured; not only a positive test, but a negative test as well, that means that there's lots of data

that's being collected. And for that data and then all of the contacts that had been with those cases that might turn out to have illness, especially early on in the response, we needed to know who all those contacts were and talk with them and give them guidance on how to prevent further transmission.

- And so, we worked with the Secretary of Health, worked with the Centers for Medicare & Medicaid Services, and we were able to identify ways to have nationally collected information about various different parts of COVID, but that kind of thing only could happen during an emergency. And so, some changes in that space are needed.
- The United Kingdom, other countries, have single systems, single capability to collect data, and the ability to really understand things because they're already in place collecting that information. So, in the U.S. there is not that kind of approach. We'd love to get there, some things are happening to make that change, but it certainly was not there at the beginning of the COVID response. A third thing is the underinvestment in public health data capabilities. And so, that just means that there has not been funding toward infrastructure for surveillance, data collection, et cetera
- Some people when they're asked to fill out the information at their healthcare encounter, don't understand some of the categories for race, ethnicity or other questions. They want to know, why do I need to know what neighborhood I live in? Or why is it that you want to know if I use public transportation? There is a need for us to tell the general public why that information is important to collect, and also what it means.
- In February 2024, Jernigan testified before the Committee on Oversight and Accountability Select Subcommittee on the Coronavirus pandemic.³
 - Jernigan addressed in his opening that

- certain men developed myocarditis as a result of the COVID vaccines. However, he stated under questioning that "the risk of getting myocarditis is much lower among those vaccinated than among those that were unvaccinated."
- Also from his opening statement: "The conclusions from the data collected as part of this historic effort is clear—<u>COVID-19 vaccines are safe and</u> <u>effective</u>... Vaccine effectiveness data continue to show that vaccination against COVID-19 is the safest and most effective way to avoid severe hospitalization and death from COVID-19."
