WeStory-ai, Inc. (the "Company") is committed to maintaining robust privacy protections for its users.

Our Privacy Policy ("Privacy Policy") is designed to help you understand how we collect, use and

safeguard the information you provide to us and to assist you in making informed decisions when using

our Service.

For purposes of this Agreement, "Site" refers to the Company's website, which can be accessed at

"Service" refers to the Company's services accessed via the Site, in which users can be provided with

Al-empowered autobiography services. The terms "we," "us," and "our" refer to the Company. "You" refers

to you, as a user of our Site or our Service.

I. INFORMATION WE COLLECT

We collect "Non-Personal Information" and "Personal Information." Non-Personal Information includes

information that cannot be used to personally identify you, such as anonymous usage data, general

demographic information we may collect, referring/exit pages and URLs, platform types, preferences you

submit and preferences that are generated based on the data you submit and number of clicks. Personal

Information includes your email, address, date of birth, contact information, which you submit to us through the

In addition to the personal information you provide, we collect User-Generated Content (UGC), such as personal stories, texts, images, recordings, and other materials that you may provide when using our Service. UGC may include sensitive personal information. We collect, store, and process this content solely for the purpose of providing and improving our Service.

You retain ownership of the UGC you provide to us. However, by using the Service, you grant the Company a license to use, reproduce, modify, and display your UGC solely for the purpose of providing the Service, including Al-powered analysis, content generation, and story creation.

2. Information collected via Technology

To activate the Service you do not need to submit any Personal Information other than your email address. To use the Service thereafter, you do not need to submit further Personal Information. However, in an effort to improve the quality of the Service, we track information provided to us by your browser or by our software application when you view or use the Service, such as the website you came from (known as the "referring URL"), the type of browser you use, the device from which you connected to the Service, the time and date of access, and other information that does not personally identify you. We track this information using cookies, or small text files which include an anonymous unique identifier. Cookies are sent to a user's browser from our servers and are stored on the user's computer hard drive. • Preferences and settings you've selected within the Service (e.g., language preferences).

Interaction data, such as whether you opened our emails or clicked on links within them.

The Company may use both persistent and session cookies; persistent cookies remain on your computer after you close your session and until you delete them, while session cookies expire when you close your browser. For example, we store a persistent cookie to track your login status, allowing you to remain

logged in between sessions.

3. Information you provide us by registering for an account

In addition to the information provided automatically by your browser when you visit the Site, to become a subscriber to the Service you will need to create a personal profile. Personal Information with vendors who are performing services for the Company, such as the servers for our email communications who are provided access to user's email address for purposes of sending emails from us. Those vendors use your Personal Information only at our direction and in accordance with our Privacy Policy.

You retain full ownership of your UGC. We do not claim ownership over any personal stories or content that you upload. However, you grant us the right to use your UGC for the limited purposes of operating and improving our Service. III. HOW WE PROTECT INFORMATION

We implement security measures designed to protect your information from unauthorized access.
