Monthly Financial Report

- As presented at Annual Meeting, on track, good shape
\$65K chip sealing was encumbered at previous meeting, is noted on report and will be recorded when expense made.
- Sandy presented the detail of the Financial Report as presented at annual meeting. Verifying the totals of report as reformatted to match the numbers presented in Quick Books. Verified cash on hand.

Website Update

- Annual meeting minutes are updated - 2024 approved, 2025 unapproved and date for 2026 Annual meeting on calendar.

Road Items

- Darwyn requests a new posting board at Coomer – occasionally board is filled over capacity and makes it ineffectual for notification.
 - Proper posting requirement is 1 physical location (townhall) if also have website, but nice to offer posting at second site on other side of town (Coomer)
 - Scott moved to allow Darwyn to build vs cost of purchase.
- Twin Lake Road – Widen and preparation for increased road usage due to new development.
 - Doug removed trees all winter to open up.
 - BCHD removed stumps, make berm, shape ditches. Bulldozing took longer than expected, higher than estimate but extra help was critical.
 - Stumps left on land as instructed by landowner, Jared Washburn
 - Grass seed purchased; hay coverage donated by Darwyn
 - Gravel being hauled and laid – a town priority to get all gravel laid ASAP to protect from potential rain damage.
- Dump Truck broke bracket, BC Hwy Maintenance to do work to repair bracket (est \$1900 parts) as well as new muffler (est. \$700) and alignment
 - While truck being repaired, renting a dump truck from Town of Marshfield at \$25 / hour so work on hauling gravel can continue.
- Trees within road right-of-way will either be mowed or cleared.
 - Multiple residents have had concerns.
 - After checking with WTA attorneys, safety of right-of-way is priority. Cannot ask owner to move, however are allowed to warn them via letter that you are clearing / mowing road right of way.
- Road Tour – schedule for May 21st, at 7:00 am
 - Create a 3-year road plan
 - Need to determine and document width of local roads, also identify easements
 - If no history provided, assume 4 rod road. But if documented anywhere, that is the assumed width.
 - Malone Rd – Patti Hurd – pavement bulging, south side of bridge, need to evaluate.
- Chip Sealant – Town already on list at county, hope to be early.
- Used new grinder, discovered an oil leak.

White Pine Cemetery

- Annual meeting suggested to raise plot prices for non-landowners to cover cost of perpetual care. Current fee is \$400.
 - Darwyn made motion to raise rates for non-landowners to \$800, none seconded
 - Mitch made a motion to raise rates for non-landowners to \$1000, Scott seconded. So moved

Resident Issues

- Critter control, Mitch made a motion to reinstate gopher payments of \$2, Scott seconded.
 - Gopher tail to be provided.
- Enhanced Wake Ordinance
 - Sent draft ordinance to DNR for review and approval.
 - DNR responded with a few minor technical changes, response is attached to meeting minutes.
 - Not enough copies provided at meeting; Darwyn read the response letter out loud.
 - Village powers were not granted during annual meeting, so again lack of enforcement of an ordinance became evident.
- Darwyn made a motion to table the Enhanced Wake Ordinance, motion seconded by Mitch, so moved.
 - Motion based upon advice from Town Attorney, WTA lawyers, Insurance carrier, other Town Boards as well as concern of liabilities.
 - The issue of an Enhanced Wake Ordinance is complex. The opinions and advice given to and researched by the Town Board since the topic was opened in March is broad and varying. Residents have spoken with passion concerning the reasons, dangers and concerns on all sides as recorded in prior meetings.
 - Discussion of actions that can be taken beyond issuing a town ordinance include:
 - As discussed at Annual meeting, the town will write a letter to prominent political figures and the DNR to consider regulations at the State level, versus expecting individual towns to regulate.
 - The Town board will create, sign and send such endorsement.
 - Meeting to proof and sign letters set May 14th, following close of BOR
 - Potential power of a Lake Associations to give voice to members of a lake. Help to monitor lake, create neighborhood committees, etc.
- Discussion / concern about potential of contamination of local waters largely due to contaminated water being drained from the ballast of wake boats. Discussion of a permit process or another way to protect the waters from contamination. Again, DNR or State regulations are needed, or local Lake Assoc.
- Viola Lake hoping to establish a Lake Assoc to drive preservation and potential grants to help habitat.
 - Discussion of culverts on Viola Lake
- Harvey Asmus – Town has participated in critter control with beaver trapping.

Subject: Ordinance Review Letter – Town of LaFollette Wake Enhancement Ordinance

Dear Town Clerk:

On 04/28/2025, the Department received your proposed ordinance to regulate boaters on the waterway in the Township of LaFollette, Burnett County, specifically regarding wake enhancement equipment on all town lakes. Thank you for being concerned about the safety and welfare of the recreational users in Wisconsin and the protection of its natural resources. This letter serves as a review of your proposed ordinance as required under ss. 30.77, Stats.

The proposed ordinance is not entirely consistent with ss. 30.77. The ordinance is consistent with this chapter as it is seeking to address safety concerns for recreational users, specifically citing the danger of enhanced waves swamping other boats or knocking down swimmers, skiers, and the occupants of other boats, as referenced in the condition report. Furthermore, you cited an increase in user conflicts and water accidents if this ordinance is not passed. You also reference preserving the State's natural resources including shoreline erosion, sediment disruption, preserving wildlife nesting areas, and reducing the chance of the spread of aquatic invasive species if this ordinance is passed.

As stated the proposed ordinance, as presented, does not meet all of the requirements under ss. 30.77, Stats. There are a few concerns to address:

1. In the first paragraph: Boating regulations are encompassed from ss. 30.50 through 30.71 Stats.
2. Section 2 (2): I suggest defining what an "artificially bow high manner" is. Slow-no-wake and planing speed are well defined. The new term puts ambiguity on operating in between slow-no-wake and planing speed when not trying to achieve planing speed.


As a reminder, the following must occur upon final approval of the ordinance:

2. Notice of the ordinance must be posted at all public access sites.

ORDINANCE NO. 2025- _

Town of LaFollette, Burnett County, Wisconsin

AN ORDINANCE RESTRICTING CERTAIN ARTIFICIAL WAKE ENHANCEMENT

WHEREAS, in the interest of public health, safety, and/or welfare, including the public's interest in preserving natural resources, the Town of LaFollette ("Town") has the authority to enact ordinances covering waters within its jurisdiction if the ordinances are not contrary to or inconsistent with Chapter 30, Wis. Stats., and they relate to the equipment, use, or operation of boats or to any activity regulated by Sections. 30.60 to 30.71, Wis. Stats.; and

WHEREAS, there exist within the Town numerous lakes; and

WHEREAS, artificially enhanced wakes can cause environmental damage to lakes and lakeshore, including resuspension of sediment adding nutrients to the water and increased risk of algal blooms, turbidity, shoreline erosion, and threats to aquatic life and waterfowl; and

WHEREAS, boats with ballast systems increase the likelihood of aquatic invasive species being introduced and spread on lakes; and

WHEREAS, artificially enhanced wakes can damage shoreline, lake bottom, moored boats, and shoreline structures including docks; and

WHEREAS, operating boats in a stern down manner creates downward prop wash, disturbing the lake bottom far below the wave zone, 30 feet and more below the surface; and

WHEREAS, artificially enhanced wakes can endanger swimmers, anglers, and other watercraft; and

WHEREAS, the use of ballast and wake enhancing fins can cause unsafe operation by causing the bow to rise obscuring vision forward; and

WHEREAS, the Town submitted a draft of this ordinance to the Wisconsin DNR for advisory review at least 60 days prior to passage, pursuant to 30.77(3)(d), Wis. Stats.; and

WHEREAS, the Town wishes to include several border lakes shared with the Town of Sand Lake within this ordinance pursuant to Wis. Stats. 30.77(3)(ac)(1), and coverage extends to these border lakes if a substantively identical ordinance is enacted by the Town of Sand Lake covering such lakes; and

WHEREAS, the Town Board, after considering public comments and any DNR suggestions, determines that adopting this Ordinance is consistent with all other ordinances of the Town and would promote the public health, safety and welfare, including the public's interest in preserving natural resources;

NOW, THEREFORE, the Board of Supervisors of the Town of LaFollette, Burnett County, Wisconsin, does hereby ordain as follows:

Section 1. Applicability and Enforcement: The provisions of this ordinance shall apply to:

- i) all lakes and other waters wholly within the Town of LaFollette; and
- ii) to Owl Lake, Big Sand Lake and Viola Lake, these lakes being border lakes shared with the Town of Sand Lake, it being understood that as regards these three border lakes, pursuant to Section 5 below, this Ordinance shall not take effect until the Town of Sand Lake has enacted a substantially identical ordinance.

This ordinance shall be enforced by all individuals empowered to enforce ordinances in this town.

Section 2. Certain Artificial Wake Enhancement Prohibited

(1) **Prohibited Equipment.** No person may use or employ ballast tanks, ballast bags, fins or similar devices to cause a boat to operate in a bow-high manner, or which increases or enhances a boat's wake.

(2) **Prohibited Operation.** No person may operate a boat in an artificially bow-high manner having the effect of increasing the boat's wake. Such prohibited operation shall include wake enhancement by use of ballast tanks, or ballast bags, or fins, or similar devices or continuous operation at transition speed (the speed below planing speed in which a boat is operating in plowing mode) and similar methods. For the purpose of this provision, "continuous operation" shall mean "operation that is not acceleration for the purpose of achieving a state of planing."

(3) **Certain Operations Excluded.** In no event shall any of the following operations be deemed a violation of this Ordinance, provided such operations do not use or employ ballast tanks, ballast bags or wake enhancing fins or similar devices or methods: i) water skiing, ii) tubing, iii) wake boarding employing a tow rope; iv) brief transition operation to empty a boat of bilge water, or v) brief transition operation of a boat accelerating into a planing condition.

Section 3. Penalty.

(1) Wisconsin state boating penalties as found in s. 30.80, Wis. Stats., and deposits established in the Uniform Deposit and Bail Schedule established by the Wisconsin Judicial Conferences, are hereby adopted by reference, except all references to fines are amended to forfeitures and all references to imprisonment are deleted.

(2) To the extent that the penalty for any violation of this Ordinance is not provided under Wisconsin state boating penalties as found in s. 30.80, Wis. Stats., any person violating this Ordinance shall forfeit \$500 for the first offense and shall forfeit \$1000 for the second and subsequent offenses within one year. Deposits established in the WISCONSIN CIRCUIT COURT FEE, FORFEITURE, FINE AND SURCHARGE TABLES shall also apply to any violation.

Section 4. Severability. Should any portion of this Ordinance or the affected Code Section(s) be held invalid by a court of competent jurisdiction, the remainder shall not be affected.

Section 5. Effective Date. Upon adoption this ordinance shall come into effect as follows:

- I. **For all lakes and other waters wholly within the Town of LaFollette** –upon enactment this Ordinance shall take effect the day after publication or posting.
- II. **For Owl Lake, Big Sand Lake and Viola Lake** – For each of these three lakes this ordinance shall take effect upon the date both the Town of LaFollette and the Town of Sand Lake have adopted and published and posted an ordinance covering these lakes substantively identical as regards sections 2-4 above. If the Town of Sand Lake enacts an ordinance covering some, but not all of these three lakes, this ordinance shall apply only to those lakes covered by the ordinance enacted by the Town of Sand Lake.
