The Johnson Trust wants to get a permit to remove the Pokegama Dams and they have been trying for 14 years and are still waiting for a permit. Bob and Harold Searles owned the dams and never put a guard around them. The Town widened the road in 1995 and never touched the dams. Searles always maintained them. If we have a hard rain it would fall out of the culverts and flood the road, we would have to put overflow culverts in. Mike said that Steve Hemp said the Johnson Trust would at fill by the East culverts. How much would a permit cost? Boat access on Pokegama Lake as of 2017 there is an access on Vesley Road. Doug, Jerry sexton and Darwyn will meet with the DNR on Tuesday.
