The clerk's minutes read and approved on a motion by Mike Tarnowski and seconded by Scott Lauder.

The treasurer's report was read and approved on a motion by Mike and seconded by Scott with a cash on hand of \$186,172.87 before the bills were paid.

Residents from Spencer Lake, Cheryl and Allen Elzea, have no internet service. Darwyn told them he talked to Sid from Siren Telephone and he said that if there are enough people are interested, he might be able to help. So Darwyn told the couple to get together with everyone to see who will be willing to pay for internet service.

A motion was made to approve permit license from DNR to fixing sides of culvert and to widen Cranberry Marsh Road to 15 feet by the marsh and 10 feet by lake by Mike and seconded by Scott and we have 5 years to finish. The culverts have been filled in with cement.

Hermes welding has the tractor for repair. The wood chipper is here. Monarch is working on grading Anchor Inn Road and black top should come Thursday. Doug is patching blacktop. We will pay Town of Lorain for dust control the 2 residents will reimburse us for the service.

The federal stimulus program will require a letter with the request for money spent for covid protection such as face masks, plexiglass, hand sanitizer, traffic cones, replace chairs etc. Fix front door.

Darwyn reviewed an email from North Ambulance stating that they had 2 paramedics. We have a fifteen-minute response. Washburn's ambulance told them they are terminating the service in Washburn County. It will be discussed at next Thursday meeting. A motion was made if assistance is needed in Coomer mutual aid should come from Indian Creek (Lorain) by Mike and seconded by Scott.

Bob Irwin said the his step daughter is going to take over the business.

Bills were paid and correspondence looked at.
