

The Founding of the NAACP

On February 12, 1909 the National Association for the Advancement of Colored People was founded by a multiracial group of activists, who answered "The Call," in New York City, NY. They initially called themselves the National Negro Committee.

FOUNDERS

Ida Wells-Barnett, W.E.B. DuBois, Henry Moscowitz, Mary White Ovington, Oswald Garrison Villiard, William English Walling led the "Call" to renew the struggle for civil and political liberty.

NAACP Vision Statement

The vision of the National Association for the Advancement of Colored People is to ensure a society in which all individuals have equal rights and there is no racial hatred or racial discrimination.

NAACP Mission Statement

The mission of the National Association for the Advancement of Colored People is to ensure the political, educational, social, and economic equality of rights of all persons and to eliminate racial hatred and racial discrimination.

Dayton Unit NAACP Vision Statement

The Dayton Unit NAACP *vision* is to fulfill the Dream of the Civil Rights Act of 1964 by capitalizing on the *2nd "A"* of the NAACP, which stands for *ADVANCEMENT*.

The following statement of objectives is found on the first page of the NAACP Constitution — the principal objectives of the Association shall be:

- To ensure the political, educational, social, and economic equality of all citizens
- To achieve equality of rights and eliminate race prejudice among the citizens of United States
- To remove all barriers of racial discrimination through democratic processes
- To seek enactment and enforcement of federal, state, and local laws securing civil rights
- To inform the public of the adverse effects of racial discrimination and to seek its elimination
- To educate persons as to their constitutional rights and to take all lawful action to secure the exercise thereof, and to take any other lawful action in furtherance of these objectives, consistent with the NAACP's Articles of Incorporation and this Constitution.


Among the founders, pictured on this page, were: Oswald Garrison Villard, who wrote the Call; Ida Wells-Barnett, a crusader against lynching: William English Walling, whose article on the Springfield, Illinois race riots of August, 1908, stressed the need for a "large and powerful hody of citizens" to defend the rights of black people; Henry Mosleowitz, a social worker among immigrants; W.E.B. DuBois, the multi-talented founder and first editor of *The Crisis*; Mary White Ovington, a social worker, who conceived the idea for an NAACP; Moorfield Storey, first NAACP president; and John Haynes Holmes, a minister.

August 2008 – Quarterly Community Educational Workshop entitled, "Getting Ahead of the Emerging Storm – Surviving Battlefields." Chaplain PamelaJune B. Banks-Anderson, Founder & CED of the National Restoration Team (NRT), conducted the workshop. Also, Carolyn Rice, Montgomery County Treasurer, gave a very detailed presentation on the services that are provided by the treasurer's office.

September 2008 – At our Executive Committee Meeting, Lori L. Ward, Deputy Superintendent for the Dayton Public Schools, gave a very detailed presentation regarding the Dayton Public Schools Issue 52 November 2008 Ballot Initiative. Also, Al Washington, Authorized Representative for the Coalition of Community Organizations,

spoke about the lack of African Americans visibly employed on the I-75 Construction Project. At our General Membership Meeting, *Dr. Kurt Stanic*, Interim Superintendent for the Dayton Public Schools, along with *Jeffrey J. Mims*, *Jr.*, Vice President of the Dayton Board of Education, reiterated the severe importance of why the Dayton Board of Education voted to place a 4.9-mill continuing operating levy on the November 2008 ballot. They both stated that it is to meet the district's pressing educational needs.

November 2008 – Quarterly Community Educational Seminar on "Foreclosure In Montgomery County Part III" conducted by Willis E. Blackshear, Montgomery County Recorder. (Chris Shaw, Economic Development Committee Chair)

December 2008 – The Annual Meeting was held. We voted for members to serve on the NAACP Board of Directors. We had a Christmas Celebration that concluded a year of activities in the current administration.

Civil Rights Cases:

The NAACP does not provide legal advice but we do offer Non-Lawyer assistance when feasible. Our Labor & Industry Committee (Chairperson Menta D. Kimbell, Chris R. Cortner, Rev. Jacob R. Jernigan, Theodore C. Fields) and Legal Redress Committee (Chairperson Atty. Mia Wortham-Spells, General Mwesi Chui, Theodore C. Fields) have teamed-up to investigate over 173 cases that have been filed with our office December 31, 2008 YTD.

Involved In The Following High Profile Cases:

- 1. Taser Incident in Trotwood, Ohio Concerning A Pregnant Woman
- 2. Alleged Fire Bombing in Troy, Ohio
- 3. Shooting involving the Dayton Police Department (Caucasian Male Died As A Result of His Injuries)
- 4. Shooting involving the Dayton Police Department (African American Male Died As A Result of His Injuries)
- 5. Shooting involving the Dayton Police Department (Hispanic Male Survived)
- 6. Shooting involving the Dayton Police Department (African American Male Died As A Result of His Injuries)
- 7. Taser Incident in Dayton, Ohio Concerning A Blind Woman
- 8. Racially Motivated Fire Bombing in Jefferson Township

Our process is as follows: Intake all Complaints Reported to the Unit; Thoroughly Investigate Case; Assess the Validity of the Complaint; Meet with Respondent to Review Entire Case; and Offer Proposed Solutions Based on a Thorough and Complete Investigation. Some cases may result in direct action or withdrawal of economic support if deemed necessary. We will continue to pursue freedom and justice for all Americans on a daily basis.

<u>Membership Update:</u>

As of December 31, 2008 YTD, the Dayton Unit NAACP has 20.5% more financial members than last year. We set a record at the 57th Annual Freedom Fund Banquet by recruiting 28 Fully-Paid Lifetime Members in one year.

Youth Achievements:

The Littlejohn Junior Youth Council (Ages 1-12) held their first ever, "Soul Food Saturday" to continue to build positive relationships in the community. They held their 4th Annual Election at the Dayton Cultural & RTA Transit Center and the Officers are as follows: Austin DeVaughn, President; Makaila Sloan, 1st Vice President; Raelyn Hill Ross, 2nd Vice President; Tiarra Murphy, Secretary; Caled Murphy, Treasurer; Te'Nayia A. Bailey, Sgt. At Arms. The Littlejohn Junior Youth Council continues to come up with creative ways to recruit and attract new members such as holding their first ever "Back To School Swim Bash" at the Princeton Northwest Recreation Center. In this national historic election year, they conducted a "Voter Registration" drive to stimulate voter participation and turnout.

The Dayton Youth Council (Ages 13-17) held their *Annual Soul Food Dinner* in the month of January 2008. They partnered with Amesbury Chase Productions to recruit an audience for a talk show that was part of a documentary-style film that examined pertinent topics in the African American community including, but not limited to: religion, class and economics, family values, interracial relationships and education. The talk show subject matter dealt with adoption, specifically transracial adoption, and the challenges associated with black children being raised outside of their race. They have distinguished themselves as one of the premier youth groups in the Greater Dayton Metropolitan area as well as have shown exemplary leadership skills throughout the Dayton community.

The Dayton ACT-SO (African-American, Cultural, Technological and Scientific Olympics) Youth Program conducted a contest for our high school students to be able to compete at the National level. ACT-SO is a yearlong enrichment program designed to recruit, stimulate, improve and encourage high academic and cultural achievement among African-American high school students. The ACT-SO program centers around the dedication and commitment of community volunteers and business leaders; to serve as mentors and coaches to promote academic and artistic excellence among African-American students. There are 25 categories of competition in the sciences, humanities, performing and visual arts. They held their first ever, "Freedom Dance Event" to showcase the various talents of our youth. They held their first ever "Talent Showcase" in July 2008. There were 9 local "Gold Medallist" that competed at the NAACP National ACT-SO Competition in Orlando, Florida in the month of July 2008 into August 2008. At the national level, we brought home to the City of Dayton, a Silver Medal in Computer Science (Malcom Keith, Jr.). CONGRATULATIONS!!! Dr. Robert J. Sweeney, Executive Vice President for Planning and Secretary to the Board of Trustees at Wright State University, assisted the leadership of ACT-SO in designing their strategic plan.

Voter Registration:

We have been very busy with our Voter Registration drive, registering over 1,600 citizens in the Greater Dayton Metropolitan Area. We have *informed* and *educated* the citizens of the Dayton, Ohio community on the importance of registering and actually casting their vote. This ultimately *empowered* them to make a well-informed decision on the candidate of their choice. This year marked a historic election year with the "Showdown" between *Senator Barack Obama (D-Illinois)*, first African American to be Nominated for President on a major party ticket and *Senator John McCain (R-Arizona)*. They both wished to become the next President of the United States of America however, only one candidate can go forward and take the Oath of Office on January 20, 2009. Your voice was heard loud and clear on November 4, 2008 as *Senator Barack Obama* was *elected* and became the *I*st *African American President of the United States of America!!!* (*Creola Reese, Voter Registration Leader; Rev.
