- Held a Team Building meeting with 1st Vice President Fields to hear concerns regarding the overall operations of the Unit. Also, to give input on solutions to areas of opportunity.
- As previously agreed upon, we want to be fair in every decision we make for the good of the organization. Our 40 member Executive Committee is comprised of a highly talented, skilled and diverse group of Citizens seeking to achieve the vision and goals we set for the 2007 2008 administration of the Dayton Unit NAACP: *Inform*, *Educate*, *Empower*. With that said, the 99th Annual NAACP Convention to be held in Cincinnati, Ohio from July 12, 2008 July 17, 2008 is rapidly approaching. We need to elect voting delegates and alternate delegates to represent the Dayton Unit NAACP at the convention. We should consider the following when electing delegates:
 - 1. Active Support of the Unit's Vision and Goals
 - 2. Active Financial Support of the Unit (Membership Solicitation, Etc...)
 - 3. Monthly Written Committee Reports
 - 4. Rotation of Delegates at State, Regional and National Conventions

- Held a Dayton Unit NAACP Volunteer (DUL, Job Center, Court System) Meeting to discuss each person's roles and responsibilities as it relates to being more productive while at work thereby creating better efficiencies in overall Unit operations. The importance of office personnel keeping the office neat, clean and organized on a daily basis was also discussed.

- Initiated a plan to have all Labor & Industry Cases as well as Legal Redress Cases saved on the computer. Worked with Adam Stone, Chris Cortner, Carolyn Perkins, Menta Kimbell, General Chui and Aariane Jackson to implement the plan.

- Assigned volunteers and staff to conduct a Voter Registration drive at the "Square Biz" event hosted by the Greater Dayton African American Chamber of Commerce.
- Implemented a monthly phone call reminder system to help increase member participation.
- Held a Team Building meeting with 1st Vice President Fields to hear concerns regarding the overall operations of the Unit. Also, to give input on solutions to areas of opportunity.
- Recommend we give \$4,000 to ACT-SO for the ACT-SO Competition in Orlando, Florida. (Action / Approved)
- Recommend we have a \$500 budget for our 2008 Voter Registration drive. (Action / Approved)
- Recommend we send Jessie Gooding and Carolyn Perkins as Alternate Delegates to the NAACP 99th Annual Convention in place of Willie Terrell, Jr. and Dr. Carl Moyler who are unable to attend due to their various reasons. Mr. Gooding and Ms. Perkins will receive the stipends that were already voted upon for Mr. Terrell and Dr. Moyler respectively. Also, Mr. Gooding will room with Presiding Elder Dr. Charles Holmes and Ms. Perkins will room with Josephine Noble and Crystal D. Jackson. (Action / Approved)
- Recommend that Crystal D. Jackson, Assistant Secretary, represent the Dayton Unit at the NAACP 99th Annual Convention as a Voting Delegate instead of an Alternate Delegate. (Action / Approved)
- Recommend that the Dayton Unit NAACP 2008 Election be held on Sunday, November 2, 2008 from 12:00 p.m. to 5:00 p.m. at the Dayton Unit office while the Citizens of Dayton as well as the Citizens throughout this Nation are in the spirit of voting. (Action / Approved)
- Nominated Attorney Mia Wortham-Spells, Dayton Unit NAACP Legal Redress Chair, for the "2008 Foot Soldiers In The Sands Award." This distinguished award will be given at the NAACP 99th Annual Convention during the "Clarence M. Mitchell, Jr. Memorial Lecture Luncheon." The nomination was accepted. *Congratulations Attorney Spells!!!*
- Recommend that the Dayton Unit NAACP hold it's "1st Annual Dayton Unit NAACP Community Picnic At The Park" in the month of September 2008 in honor of the late Rev. Donald C. Smith. An estimated budget would be around \$3,000. Our 3 dynamic youth groups can work closely together on this project as we endeavor to unite them once again. We can highlight our 2007 Accomplishments, pass-out our literature, conduct voter registration and showcase our team. (Action / Approved)
- Recommend that the Dayton Unit NAACP hold it's "1st Annual Meet The Candidates Night" on October 1, 2008 or October 8, 2008 to ask pertinent questions in which the NAACP feels is important to it's constituents. This would also include a Legislative Report Card. (Action / Approved)

- Recommend that we recommend to the General Membership that 7 members be elected to the Nominating Committee at the September 22, 2008 General Membership Meeting to be held at Trinity Presbyterian Church at 6:00p.m. (Action/Approved)
- Recommend that we recommend to the General Membership that 15 members be elected to "At-Large" Executive Committee Seats during the Dayton Unit NAACP Election to be held on November 2, 2008 at the Unit office from 12:00 p.m. to 5 p.m. (Action/Approved)
- Recommend that we recommend to the General Membership that paper ballots be used for the Dayton Unit NAACP Election to be held on November 2, 2008 at the Unit office from 12 p.m. to 5:00 p.m. (Action/Approved)
- Recommend that we elect eight voting delegates to represent the Dayton Unit NAACP at the Ohio Conference NAACP 78th Annual State Convention to be held at the Kalahari Waterpark Resort & Convention Center located at 7000 Kalahari Drive in Sandusky, Ohio from October 3, 2008 to October 5, 2008. The Unit will pay for the state assessment, their registration package and allocate a specific amount of money for their hotel accommodations (\$94 Per Night), transportation cost (\$150) and meal per diem (\$150) as listed by their respective name.
