

#### **Economic Development Committee's Annual Report To The Community:**

The Committee on Economic Development supports and or shall recommend additional efforts to preserve and expand economic empowerment among African-American and other communities of color.

The goals of the committee, relevant to our activities in communities west of I-75 and south of I-70, include the following:

- Goal # 1: Research and establish relationships with private and public entities;
- Goal #2: Support the work of the National Office in monitoring the progress and activity of private and public entities designated by national programs;
- Goal #3: Implement local efforts to promote the growth of business ownership;
- Goal #4: Increase employment and job creation; and
- Goal # 5: Encourage business development and home ownership.



The makeup of the committee includes Business Owner(s), Bank Executive, Realtist Representative, Economic Professors, Executive Directors of Agencies and Organizations, CPA, Chambers of Commerce Representatives (Dayton Minority Business and Hispanic), and Leadership of African United States.

## **Deborah A. Smith**

#### Housing

- On Monday, August 28, 2017, moderated a monthly community meeting entitled "Let's Get Our Houses In Order." The panel was comprised of local, minority owned home repair contractors who informed the audience of their services.
- Five Oaks Neighborhood Clean Up
  - On Saturday, April 22, the Dayton Unit of NAACP Housing committee assisted in the cleanup of the Five Oaks neighborhood.
- Ohio's New Plywood Ban on Vacant Houses
  - Governor John Kasich, in January, signed into law House Bill 463. As a result, Ohio enacted the nation's first statewide ban on mortgage lenders using plywood to board up vacant structures. Moving forward, lenders will be required to use alternative boarding materials, such as a glass-like polycarbonate that is easier on the eye and does not advertise that a home or building is unoccupied.
  - West side gets millions for demolition
    - The city has been awarded about \$12.2 Million in Neighborhood Initiative Funds to fight blight and the spread of foreclosures throughout Montgomery County. However, two neighborhoods (Westwood and Edgemont) on Dayton's west side account for nearly half the homes being removed across the city even though they do not have highest vacancy rates. About 66 homes in Dayton have been knocked down or are in the acquisition process to be demolished. About 220 of those properties are in the Westwood neighborhood and 78 are in Edgemont, according to city data. This year, the city expected to demolish 298 properties in Westwood and Edgemont combined, 68 in Burkhardt, 47 in Riverdale, 43 in Twin Towers and 40 in Wolfcreek.



### **Rev. Ayo Ogunduyile**

#### **International Affairs**

- Moderated a Dayton Unit NAACP Monthly Community Meeting Titled, "NAACP Impacting Global Community"
  - NAACP is deeply disappointed by President Donald Trump's announcement that the United States will withdraw from the Paris Agreement of the United Nations
    Framework Convention on Climate Change. Despite this move, NAACP resolves to not only do its part in adhering to the tenets of this Paris Agreement but to also continue to fight for environmental justice.
  - NAACP will pursue the training of "International Observers" to monitor elections. This will be a "Pilot" program and each of the regions will be encouraged to train three people, resulting in 21 observers that will be selectively deployed in 2018.
  - The United Nations Human Rights has expressed concerns shared by the NAACP that the 20 million people on the verge of being denied Health Care by the Trump's administration may be in violation of its treaty.
