***Local NAACP President Wins  
Re-election to Seventh Two-Year Term***

**DAYTON, OHIO - NOVEMBER 7, 2018** – On Sunday, November 4, 2018, the Dayton Unit of the National Association for the Advancement of Colored People NAACP held it's Biennial Election at the Dayton Unit NAACP office. Dr. Derrick L. Foward was re-elected as President of the Dayton Unit NAACP with his term commencing on January 1, 2019 and ending on December 31, 2020. He has won re-election to his seventh 2-year term.

"I am humbled and truly appreciate the members of the Dayton Unit NAACP for believing in my leadership and entrusting me to lead the organization for another two years," said Dr. Derrick L. Foward, President of the Dayton Unit NAACP. "We will remain focused on our 21<sup>st</sup> Century Game Changers which are as follows: Economic Sustainability; Education; Health; Public Safety and Criminal Justice; Voting Rights and Political Representation; and Expand Youth and Young Adult Engagement" said Foward.
