

- **Held a press conference to announce a settlement agreement we reached between our client, Darrell Williams and H&L Market**
- **On behalf of the members of the Dayton Unit of the National Association for the Advancement of Colored People (NAACP), filed an official complaint with the State Board of Education, regarding the “Colored and Washing of the Hands” comments made by State Senator Steve Huffman. Asked for the medical board to revoke his license to practice medicine in the State of Ohio. State Medical Board President Dr. Michael Schottenstein did respond by the date requested and said the disciplinary actions can range from no action, to a warning letter, to probation / remedial education / treatment, to permanent license revocation. 
