- Represented the Dayton Unit NAACP at the Ohio Black Expo in Columbus, Ohio. Received the same stipend as given for an in-person CRATI and State Convention. (Action/Approved)
- Will be conducting my annual congressional sponsored lobbying session in mid-July along with our NAACP lobbyist. Please text and/or email me concerns that you would like for me to address with our Ohio Congressman. Funds will be given to the Dayton Unit NAACP, and a check will be cut in the same amount for me to pay for accommodations as in previous years. (Action/Approved)

- Met with DPD Sergeant Kyle Thomas (FOP President) and DPD Sergeant John Sopczak (FOP First Vice President), along with Treasurer Branham and Executive Committee Member Stacey Benson-Taylor, to discuss salary increases for DPD Officers that are covered under the collective bargaining agreements. We also discussed the DPD contract with GDPM. The issue is that the City of Dayton cannot retain current officers and recruit new officers. The Fire Department has between 600-700 people on eligibility list, while DPD has just over 100 people on the eligibility list. Out of the 100 that passed the test, DPD will be able to seat about 30 people in the Ohio Peace Officers Training Academy (OPOTA) Class.
- Met with Valerie Lemmie, Honorary Chair for the 2023 Hall of Freedom Awards, to secure their \$10,000 commitment.
- Went to Washington DC to lobby Congressman Mike Turner on several key issues that are important to the NAACP and our constituents. I want to take this opportunity to say, "Thank You" to those Executive Committee Members who participated in setting the agenda for the day.
- Led a press conference with various organizations (We Are The Legacy, Panhellenic Council, AFL-CIO, Unity Coalition, Masons and Shriners, churches, and civic associations) to oppose Issue One.
- Organized an educational tour for the Reflections in Time...Dayton Unit NAACP Celebrates History exhibition, followed by a reception. I want to take this opportunity to say "Thank You" to Chairman Elijah Rashaed and all attendees for making the exhibition a great hit.
- Met with Mike Riordan, President & CEO of Premier Health, to discuss the feasibility of placing an Urgent Care Center at the former Good Samaritan Hospital. He stated that they will continue to explore that option.
- Working as a Project Manager for Solar Panel Installation and Roofing Repairs at NAACP Dayton Headquarters, as well as, Concrete Pad installation at the NAACP Dayton Community Hub.
- Held an Office Volunteer Staff Meeting to address various topics (see attached.)
- Organized a delegation of people to participate in the Black College Football Hall of Fame game featuring Virginia Union and Morehouse College. Will be attending the Chicago Football Classic featuring Central State University vs. Mississippi Valley State University. Will receive same stipend that I received over the last three years to attend the Black College Football Hall of Fame. (Action/Approved)
- Accompanied our client, Laticka Hancock, to a 2-day court trail of Todd Stanley, former Sergeant for the Butler Township Police Department. He was found guilty of first-degree misdemeanor assault charge, for punching her in the face over a piece of cheese that was left off of her Big Mac sandwich.

- Organized the official grand opening of the NAACP Dayton Headquarters. I would like to take this opportunity to say, "Thank You" for all that participated in the event. It was a huge success!
- Held a meeting with Jeremy Kelley, Assistant News Director for the Dayton Daily News, to discuss how both of our organizations operate so we are able to work together to educate the community on issues that affect them from a Civil and Human Rights standpoint.
- Met with Dayton Convention Center Representatives and Leslie Barrow, our Hall of Freedom Awards Contractor, to discuss pricing and logistics.
- Organized a follow-up meeting with John Page, Region Manager for DCC, along with Chairlady Lu Dale and Leslie Barrow, to address concerns we had about pricing. As a result, the pricing will remain the same as last year.
- Implemented another Hall of Freedom Award titled, The Breakthrough Award", to honor those exceptional individuals who sit quietly in the background but does tremendous work.
- Called and sent e-mails to over 60 churches and corporate partners to solicit their support of our Hall of Freedom Awards.
- Organized 2 Additional Meet the Candidates Forums in Outlier Communities that are in our jurisdiction.
- Held a meeting with Madam Secretary Thompson to discuss the resignation she submitted that was supposed to be effective December 31, 2023. She has decided to rescind her resignation and to complete her term which ends December 31, 2023.
- Held a Special Meeting with Executive Committee Members to make them aware of my intention to seek the Office of State Representative of the 38th House District of Ohio. I made it clear that no matter what happens with the State Rep. position, that I also plan to seek re-election as President of the Dayton Unit NAACP in November 2024. I also expressed that I would like to attend the 115th NAACP National Convention in Las Vegas, Nevada as a voting delegate, as we won't know the outcome of the March primary until that time.
