- Facilitated an Ohio Conference NAACP training titled, "Best Practices on Building Effective Units" with 5 different Units across the State of Ohio.
- Secured WDTN-TV 2 to host the Dayton Unit NAACP 70th Annual Freedom Fund Awards Banquet. It will air on NBC.
- Met with Scott Sliver to discuss how he will continue to serve on the Dayton Unit NAACP Executive Committee as he pursues public office as a Dayton City Commissioner. Also have been in communication with Roland Winburn and Stacey Benson-Taylor to advise them of the same.
- Coordinated a Dayton Mayoral Candidates Forum and Dayton City Commission Candidates
 Forum respectively, along with 2nd VP Roberts and 29th Dayton Unit NAACP President
 Richard Austin. One of the primary goals were to ensure that voters understood the 6 ballot
 initiatives before early voting began. Also, to hear straight from the candidates.
- Organized and facilitated the first "How to Avoid Poverty" presentation that was aired live via our Facebook page.
- Arranged a meeting with a representative from the Montgomery County Auditors Office to discuss and make a diagram of the property line for the future site of our parking lot which is located adjacent to our Headquarters at 911 Salem Ave. Appreciate the assistance of Building Committee Chair William Spear.
- Submitted a Letter of Intent to The Dayton Foundation to apply for funding for our future parking lot. The application will be included in their Grants Committee packet and agenda set for May 6, 2021. Their Governing Board will approve the Grants Committee recommendations at its meeting scheduled for June 9, 2021. Should receive an answer later in the day.

- Planned a press conference along with 1st VP White and Chairman Fox, to address a
 discrimination complaint filed at our office by Jack Runser, a disabled citizen who resides in
 Dayton.
- Met with Matt Sichman, Construction Inspector for the City of Dayton, to discuss the Salem Avenue Reconstruction Phase I Project and how we can coordinate the City's project with our Parking Lot Project. As a result, they are going to include an apron and drain system as part of the project which will be a cost savings for our project.
- Held an organizational meeting with the students of Central State University for reactivation purposes. They elected Officers and I submitted the Reactivation Packet to the NAACP Board of Directors. The NAACP Board of Directors approved the reactivation during its Board Meeting held on Saturday, May 15, 2021. The Central State University NAACP College Chapter #3808 n is now active.
- Submitted a Dayton Unit NAACP Membership Laydown to Ophelia Averitt, Chair of the NAACP National Life Membership Committee, which was acknowledged during the NAACP Board of Directors Meeting. Kudos to all who recruited new members in the months of April and May of 2021.
- Worked with Bobbie Trittschuh, Corporate Social Responsibility Manager for Honda, to secure a \$20,000 grant for our Operational Expenses. Will serve as administrator and marketing consultant for the grant, and administer funds accordingly. (Action/Approved)
- Met with Sherman Kinney, Branch Business Manager for US Bank, to establish a new partnership with their organization, and to educate him about our organization's work.
- Followed-up with the Letter of Intent that I submitted to The Dayton Foundation. Their Grants Committee approved the request on May 6, 2021 and will recommend for approval to their Governing Board on June 9, 2021. Should receive an answer later in the day.
- Met with Jeffrey Trzeciak, Executive Director of Dayton Metro Library, to educate him about the history of the NAACP and the work of the Dayton Unit NAACP. We also discussed the possibility of him serving as an Honorary Chair for the 70th Annual Freedom Fund Banquet.
- Met with Kelli Donahoe, General Manager for the Dayton Convention Center, to discuss how the DCC plans to move forward under new leadership. Placed a tentative hold for our 2021 & 2022 Freedom Fund Banquets.
- Worked with the Toxic Brew Company on a Juneteenth initiative to support our Civic Engagement work. We netted \$1,500 from the event. Plan to use this donation to attend the Black College Football Hall of Fame Classic featuring Grambling State University vs. Tennessee State University. The event will take place in the Tom Benson Hall of Fame Stadium located in Canton, Ohio. I want to take this opportunity to thank Chairman Montgomery and his committee for conducting a Voter Registration Drive at the event, along with all other Executive Committee Members who joined us. - Met with The Dayton Foundation to finalize our Grant Request. The request was approved.
- Met with Admiral Engineering and Surveying to conduct a survey of our 911 Salem Ave. property to design a parking lot. Still awaiting the final drawings.
- Met with Sheriff Rob Streck to discuss the proposed jail. He stated that they house about 800 inmates on a monthly basis and do not plan to increase the bed count should a new jail be constructed. He will keep me informed and welcomes anyone to call him to have a discussion.
- Met with Trotwood Police Chief Erik Wilson along with several other law enforcement agencies to include the Ohio State Patrol, to discuss traffic enforcement. I asked that they put together a PowerPoint presentation to include their Oath of Office and we would have a special meeting to inform the community.
- Connected new members who have expressed interest in a particular Standing Committee with the various Standing Committee Chairs. I am asking that each Standing Committee Chair reach out to those members to engage them in the work of Civil and Human Rights.

- Went before the North Central Land Use Board to present our case to add a parking lot to our 911 Salem Ave. property. The board voted unanimously to send a letter of support to the Board of Zoning Appeals which I have to go before on July 27, 2021. They stated that I represented the Dayton Unit NAACP very well as evidenced by the unanimous consent Vote which is very rare.
- Met with Rob Rohr, 2020 Honorary Chair, to discuss our TV Ratings from last year's Freedom Fund Awards. In his words, "Ratings are the percentage of people who are watching tv at a given time based on the entire audience of people using television at any given time period. In this example of all the people watching TV on Saturday October 24th, 2020 the Freedom Fund Special did a 1.5 rating. That translated into 11,600 adults watching (about ten times what you told me the attendance for the in-person gala usually totals). For comparison. The late show on with James Corden on CBS will usually do about the same rating. Jimmy Kimmel on ABC will do about the same. Big name shows that are on 5 nights a week with lots of promotional money behind them.... Those are just examples, but I think you and your board can be very proud of the showing. Ten times the physical event attendance is a great point to hammer home with advertisers."

- Met with Interim Police Chief Mat Carper along with 1st VP White, to discuss how the relationship has been down through the years with the Dayton Unit NAACP and the Dayton Police Department. He stated that the Police Department will start supporting our Freedom Fund Banquet at the Silver Sponsorship level, he will become a Silver Life Members, we will reignite our Quarterly Meetings and we will be discussing 4 cases that have come to the attention of our organization. Informed him that we would be holding a press conference to urge City of Dayton leadership to hold a national search for the City's next Chief of Police.
- Held a press conference to state the official position of the Dayton Unit NAACP as it relates to the selection of the next Chief of Police for the City of Dayton.
- Gave a presentation to the BZA regarding our Parking Lot Project, and they VOTED unanimously to approve our project.
- Organized a meeting with NAACP National Staff, along with Chairman Leppla and 2nd VP Roberts to discuss a Solar Project at our Headquarters.
- Met with Interim Dayton Police Chief Matt Carper and Assistant Chief Eric Henderson along with Chairman Fox and Criminal Justice Committee Member Maurice Evans to discuss 4 different cases as well as many other issues.

- Moderated a Facebook Live Meeting with the Ohio State Patrol, Montgomery County Sheriff's Office and the Dayton Police Department to discuss major traffic concerns and how they are going to deal with the Citizens concerns.
- Participated in a meeting with City of Trotwood leadership along with Greyhound Leadership to address various Human Rights concerns at their location in Trotwood.

- Plan to negotiate and to use the quotes (\$7K to \$10K) we previously received in the decision-making process to demolish the house we own at 1732 W. 1st St. We will then install a sign on the property to identify it as the Home of the Dayton Unit NAACP. We can use the green space to host different events in the future. (Action/Approved)
- Plan to call the DOJ to discuss placing the Dayton Police Department under a Consent Decree.
- Held a press conference with our client, Clifford Owensby, Sr., to share his story regarding
 his encounter with the Dayton Police Department. Plan to file a complaint with the DOJ and
 the Ohio Attorney General.
- Held a meeting with the Volunteer Office Staff to address various concerns they have at the
 office.
- Have been interviewed by many news outlets over the past week regarding the Clifford Owensby, Sr. case.
- Organized several shoots for the Freedom Fund Awards
- Organized an event with the Ohio Harness Horseman's Association at Hollywood Gaming at Dayton Raceway during their first Charity Night event. We will be receiving \$2,000 for our participation, and look forward to next year.
