I, the undersigned, hereby agree to comply with all California State and local rules and regulations as outlined in The Kings Fair Exhibitor Handbook. I understand that it is my sole responsibility to read, understand, and adhere to all rules set forth in the handbook. I acknowledge and accept that any violation of these rules will result in the forfeiture of all awards, ribbons, premiums, disqualification from the sale, and disqualification from any future exhibition participation in any form at The Kings Fair. Furthermore, I understand and agree that by entering my animal into a Kings Fair Market class, the animal is potentially subject to sale if deemed of satisfactory quality by the judges, and I am obligated to sell the animal to the highest bidder unless it is withdrawn in writing to the livestock office 24 hours prior to the start of the sale. I further acknowledge that if my animal is awarded Supreme Champion or Reserve Supreme Champion, it cannot be withdrawn from the sale under any circumstances, and the sale of my animal will be terminal unless I am selling a Dairy Replacement Heifer, Dairy Yearling Heifer, or Commercial Beef Replacement Heifer. By signing this agreement, I affirm my understanding of and willingness to adhere to these terms and my intent to contract my animal for competition at The Kings Fair.
