Home Arts, Crafts, Table Setting, Food Preservation and Ag Horticulture exhibits-Must be received for Judging Friday, June 6th, 2025, 10:00am – 6:00pm and Saturday, June 7th, 2025, 10:00am – 6:00pm.

Food and Floriculture entries - must be Received for Judging Monday, June 16, 2025, 10:00am – 6:00pm.

FFA Ag Mechanics entries - must be Received for Judging **Thursday**, **June 5, 2025, 10:00am – 6:00pm**.

Ag Mechanics -must be received **Thursday**, **June 5**th **between 10am – 6pm**.

All Exhibits Released: Monday, June 23rd, 2025, 10:00am – 6:00pm. All unclaimed exhibits and awards will be recycled or donated to a charitable organization after Monday, June 23rd, 2025.

Rules:

- 1. All articles must remain on display until the day after the Fair.
- 2. All exhibits must have been made by the exhibitor and may not have been previously entered into The Kings Fair.
- 3. Competition in the Junior Divisions is limited to residents of Kings County (or be a bona fide member of a Kings County 4-H or FFA organization) and must be under 19 years of age.
- 4. An article may be entered for one award only.
- 5. An article may be transferred from one class to another at the discretion of the judge.
- 6. Danish system of judging is utilized for all Junior, 4-H and FFA Divisions.
- 7. Best of Show Rosette awarded in each Division (excluding Primary and Beginning 4-H Divisions)

Age Limits: (as of 12/31/2024)

4-H Primary Member..... Age 5-8 (Display only, cannot be Judged)

Junior Member Age 9 - 10 Intermediate Member Age 11-13 Senior Member Age 14+

Rules:

- 1. In all 4-H departments entries are judged using the Danish System.
- 2. All articles must remain on display until the day after the Fair.
- 3. All exhibits must have been made by the exhibitor and may not have been previously entered in The Kings Fair.
- 4. Competition in the 4-H Home Arts limited to exhibitors enrolled in the 4-H youth programs within one year of the opening day of The Kings Fair.
- 5. An article may be entered for one award only.
- 6. An article may be transferred from one class to another at the discretion of the judge.
- 7. All exhibits must be CLEAN and ready for display or could be disqualified.
- 8. Must include number of years in project when entering online.
- 9. 4-H PRIMARY MEMBERS CAN EXHIBIT BUT CAN NOT BE JUDGED.

FFA COMPETITION RULES

Rules:

- 1. Students entering exhibits in Agricultural Mechanics must be regularly enrolled in a High School that is following the California State Plan for Vocational Agriculture.
- 2. Although the exhibits need not be owned by the exhibitor, all must be products of students as a regular part of their instruction in Agricultural Mechanics for the past year.
- 3. Each individual is considered a separate exhibitor; although projects completed by two or more individuals are permitted (Include the group's name in the description field). These projects will be counted as one exhibitor. Any awards won by a group project shall be awarded to the individual or organization signing the Online Entry Registration. Group projects shall be entitled to receive one award.

The item must be shown in 4-H Divisions 401-403, class 9, be a large metal or woodworking project OR in Division 454, FFA Wordworking Projects & 456, FFA Large Metal Projects, above and be awarded first place to qualify for the Silent Auction.

Each exhibitor must enter the Silent Auction class to be eligible for the auction on Saturday, June 21. Fair does NOT guarantee sale of item.

4-H, FFA and Youth Organization Feature Booths

American System of Judging

Rules:

- 1. The feature exhibit booth provides members an opportunity to share the public with a specific phase of their club program. The booth can show what they have learned, the activities in which they have participated or contributions of the organization to the community. Judges will insist upon a high quality of products & material used in the exhibit. A high scoring exhibit will be artistically designed, constructed, and installed by youth members only.
- 2. The booth may use the fair theme in creating the display.
- 3. Leaders or parents ARE ONLY TO supervise. Leaders sign Entry Forms as agents for club.
- 4. Feature Booths shall be limited to one entry per club.
- 5. Exhibitors must make arrangements to replace fruits & vegetables which deteriorate during Fair.
- 6. ALL BOOTHS MUST BE COMPLETED BY SATURDAY, JUNE 14, 2025, 6:00pm. The Booth area will be available on Wednesday, June 11, 2025-Saturday, June 14, 2025, from 10am-6pm.
- 7. Make sure your booth has something in front & sides to keep public out (i.e: fence, rope, etc)
- 8. HAY BALES CAN BE USED IN THE BUILDING BUT MUST BE FIRE RETARDANT.
- 9. 4-H, FFA and Youth Organization booth will be judged together.
- 10. LIMIT of 8 booths will be set up. Booth Dimensions: Back 4' high x 8' wide Sides 4' high x 8' long One wall can go over 4' but no higher than 6 feet.
