PUBLIC PARTICIPATION

Members of the public may request that an item be considered for placement on a future Board meeting agenda. Requests must relate to the business or jurisdiction of the 24A District Agricultural Association and must be submitted in writing to the Fair Office no later than 4:00 p.m. on the twelfth (12th) business day before the scheduled Board meeting. Placement of an item on a future agenda is at the discretion of the Board President, consistent with the Bagley-Keene Open Meeting Act and other applicable law.

The public is encouraged to participate in Board meetings. Members of the public may address the Board on agenda items at the time the item is considered and on matters within the Board's jurisdiction during the designated public comment period.

To provide all interested persons an opportunity to be heard and to conduct the Board's business efficiently, public comment will be limited to up to one (1) hour. Individual speakers will be limited to two (2) minutes each.

The Board welcomes public comments, including criticism of the policies, procedures, programs, services, actions, or omissions of the Board, its members, or District staff. No policy or action of the Board shall prohibit or otherwise discourage lawful public criticism or the expression of differing viewpoints.

Comments shall be directed to the Board as a whole. Speakers are expected to conduct themselves in a respectful and orderly manner. Conduct that actually disrupts, delays, or otherwise impedes the orderly conduct of the meeting including persistent shouting, making threats, refusing to comply with the lawful direction of the Board President after a warning, or other disruptive behavior is not permitted. Individuals who substantially disrupt the meeting after receiving a warning may be directed to leave the meeting room or be removed from the meeting in accordance with the Bagley-Keene Open Meeting Act and other applicable law. Any removal shall be based solely on disruptive conduct and not on the viewpoint or content of the speaker's remarks.

Individuals who substantially disrupt the meeting after receiving a warning may be directed to leave the meeting room or removed in accordance with the Bagley-Keene Open Meeting Act and other applicable laws. Any removal shall be based solely on disruptive conduct and **not** on the viewpoint or content of the speaker's remarks. Speakers may not cede or transfer their allotted speaking time to another individual. Public comments on agenda items will be taken as each item is considered by the Board. Public comment on matters **not** appearing on the agenda is also permitted. However, the Board will not engage in debate or take action on non-agenda matters during the meeting, except as authorized by law, because formal public notice is required before the Board may consider or act on an item.
