#### Stillbirth and Sudden Unexpected Infant Death Prevention, Education & Awareness Act of 2011

On November 14, 2011 Senator Lautenberg (D-NJ) and Representative Pallone (D-NJ) introduced the Stillbirth and Sudden Unexpected Infant Death Prevention, Education and Awareness Act of 2011 (S1862/ HR3418).

This Act will improve the collection of critical data to determine the causes of stillbirth, Sudden Unexpected Infant Death (SUID), and Sudden Unexplained Death in Childhood (SUDC) up to four years of age. It will establish a national database to track these deaths and identify risk factors to prevent them in the future. It will create public awareness campaigns to educate parents and other caregivers about the risk factors for these sudden deaths. And it will expand support services, such as grief counseling, for families that have experienced the loss of a child.

This is very similar to the legislation that was introduced, but not passed, in the 111th Congress. Once again we are asking organizations who deal with the terrible tragedies of stillbirth and sudden unexpected infant and child death to send letters of endorsements for this important legislation.

## Infant Sleep Environments Depicted in Magazines Targeted to Women of Childbearing Age

OBJECTIVE: The goal was to evaluate pictures in magazines widely read by women of childbearing age, for adherence to American Academy of Pediatrics (AAP) guidelines for safe infant sleep practices.

MEHTODS: Magazines were included in this study if they had an average female readership of >5 million, circulation of >900,000, and median age of female readers of 20 to 40 years. Twenty magazines met these criteria. An additional 8 magazines targeted toward expectant parents and parents of young children were included, for a total of 28 magazines. Pictures of infant sleep environments and sleeping infants in articles and advertisements in issues of these 28 magazines were analyzed for adherence to AAP guidelines for decreasing the risk of sudden infant death syndrome.

RESULTS: A total of 391 unique pictures from 34 magazine issues were included in the analysis. Only 57 pictures (64%) portraying sleeping infants not being held by an adult portrayed the infants in the supine position, and 14.8% of sleeping infants were portrayed as sleeping with another person. Only 36 pictures (36.4%) of infant sleep environments portrayed a safe sleep environment, as recommended by the AAP.

the highest honor California can give for contributions to the California SIDS community.




#### **Anaheim White House Fundraiser Luncheon**

CONCLUSIONS: More than one third of pictures of sleeping infants in magazines geared toward childbearing women demonstrated infants in an inappropriate sleep positions, and two thirds of pictures of infant sleep environments were not consistent with AAP recommendations. Messages in the media that are inconsistent with health care messages create confusion and misinformation about infant sleep safety and may lead inadvertently to unsafe practices. *Pediatrics* 2009; 124-e425-e431.

#### American Academy of Pediatrics Revised Recommendations, 2011

The American Academy of Pediatrics published its revised recommendations for SIDS risk reduction on October 17, 2011 1. These recommendations update the previous AAP recommendations published in 2005 2. The new recommendations largely support the 2005 recommendations, but the new ones expand and clarify some issues. Changes in the 2011 recommendations include:

- While back sleeping improves the risk for SIDS in all infants, the new recommendations emphasize that non-supine sleeping is especially dangerous for preterm infants, and encourages NICUs and newborn nurseries to place preterm infants to sleep in the supine position as soon as possible.
- Safe sleeping surface: The new recommendations emphasize that cribs or bassinets should conform to Consumer Product Safety standards; only mattresses designed for specific products should be used; infants should not be placed in adult beds because of risk of entrapment and strangulation; infants should be in areas free of hazards; and infant should not sleep in sitting devices, such as car seats.
- Roomsharing but not bedsharing: The new recommendations emphasize that the infants' crib or bassinet should be placed in the parents' room, but not in their bed; devices designed to make bedsharing safe (i.e., in bed cosleepers) should not be used; and epidemiological studies do not demonstrate any bedsharing arrangements which are protective against SIDS or suffocation.
- The new recommendations identify specific situations where bedsharing is especially dangerous:
  - Infant younger than 3-months of age.
  - Bedsharing with parents who are smokers, even if they do not smoke in bed.
  - Bedsharing with someone who is excessively tired. Studies suggest this occurs when a parent has slept less than 4-hours the previous night.
  - Bedsharing with someone who uses central nervous system depressant medications, alcohol, or illicit drugs.
  - Bedsharing with anyone who is not a parent including other children.
  - Bedsharing with multiple persons.
  - Bedsharing on a soft surface, such as waterbed, old mattress, sofa, couch, or armchair.
  - Bedsharing on a surface with soft bedding, such as pillows, heavy blankets, quilts or comforters.
- Bumper pads are not recommended.
- Pregnant women should receive regular prenatal care.
- Mothers should avoid alcohol and illicit drug use during and after pregnancy.
- Breastfeeding is now recommended as part of the reduce the risk of SIDS recommendations. While
  protection increases with exclusive breastfeeding, any breastfeeding is more protective than no breast
  feeding.
- Infants should receive their regular immunizations.
- Media and product manufacturers should follow safe infant sleep guidelines in their messaging and advertisements.
- Expand public education campaigns about safe infant sleep.
- Continue research into the causes of SIDS and risk factors and prevention.

The 2011 recommendations include information about unsafe infant sleeping environments in order to prevent deaths due to suffocation, strangulation, or entrapment. This is not to say that SIDS is the same as suffocation, strangulation, or entrapment. However, the goal of the recommendations is to reduce the number of sleep-related infant deaths from any cause. Some infants are dying in unsafe sleeping environments, and it is important to include education to avoid these unsafe sleeping situations.

There is an accompanying Technical Report to the AAP recommendations which details the evidence and scientific basis for these recommendations.
