

**1. REGISTRATION, TUITION & PROGRAM FEES**

**2. PROGRAM BILLING & TUITION POLICIES**

**AUTOMATIC BILLING REQUIRED**

All athletes must maintain an active credit card or bank account on file. Tuition and fees are automatically charged on scheduled due dates. Inform accounts department immediately of updates.

**SIBLING DISCOUNTS & TUITION BASIS**

A \$50.00 monthly sibling discount applies to tuition. Tuition is flat-rate and not dependent on gym hours or practices. Schedule adjustments are at coaches' discretion.

**MID-SEASON ENROLLMENT & SHOES**

Mid-season starts require payment of all annual fees (excl. tuition for non-enrolled months). Rebel Black Revolution Shoes must be bought on your own following Sizing Day fits.

**CROSSOVER ATHLETE FEES**

Crossovers do not owe extra monthly tuition. They are fully responsible for crossover: bow, music, competition fees, choreography, skills camp, and choreo camp.

**3. ACCOUNT COMPLIANCE, PENALTIES & DROP RULES**

- **Late & NSF Charges:** A \$30.00 NSF return fee is assessed for returned payments. A \$30.00 late fee is charged if invoices aren't cleared within 5 days of due date.
- **Tardy & Absence Fines:** A \$20.00 tardy fee applies if an athlete is over 15 minutes late to a competition meet time. Competition fees are non-waivable for injury or absences.
- **Fundraising Credit Rules:** Credits can only apply to your active athlete's balance. No cash or account refunds given for any reason, even with a zero balance.
- **Withdrawal Drop Penalty:** Leaving or getting removed results in **NO REFUNDS** of any prepaids or credits. A \$300.00 drop fee is ran immediately if dropping after choreography finishes.

**MANDATORY 12-MONTH FINANCIAL COMMITMENT**

I understand and explicitly agree that this program requires a strict **12-month financial commitment from June 2026 through May 2027**. I legally bind myself to honor this operational agreement and timely pay all financial obligations detailed above. I acknowledge that **all 12 months of tuition are mandatory and required to be paid in full**, even if my child does not attend all practices or misses segments of the season.
