SC Joe reported he has not been feeling well with a cold since 8/6/18. 8-9-2018 DIR.'s were noted. Clearance noted on 6-28-2018 by M. Diaz, on 8-9-2018 L.Lemons completed a clearance on the family. 8-10-2018 an add information was documented by Addison, Sherena. 8-16-2018 a clearance was noted: Ezequiel Balbuen. 8-9-2018 CWS notes the following: CPSS conducted face to face contact with BM, Margaret and Joe at the family shelter. BM appeared nervous and inquired as to how many ACS workers were going to be coming to the home. CPSS explained that due to the time that the report came in that ECS responded to the initial call. Supervisory note states the following: Prior History: Case ID 26871553 INV indicated 3/12/2018 and remains open in FSS for PPRS. Case was indicated against the father for domestic violence, and family was referred for services. There were Concerns of mother having alleged cognitive delays. Concerns of Bf alleged untreated mental health. On 6-28-2018 this was noted. Additional information is provided in the active INV. Additional cases were noted on 8-9-2018 and 8-15-2018 suspended, and clearances are noted above. ACS HAS NO EVIDENCE OF THERE BEING ANY MENTAL HEALTH CONERNS FOR ME. THESE ARE ALLEGATIONS BY THE MOTHER. MARGARET INGOGLIA HAS NO COGNITIVE DELAYS AND THE INDICATED AGAINST ME IN THE PAST WAS DISMISSED. ## Prior History FATHER

On 07/31/18 a Neglect Petition was filed against the MO and the children were parolled to the Mo with COS. A Full OOP was issued against the Father. Supervised visits with the CH, Margaret, only. ACS to assist Mo to enter PATH if possible.

Date: 06/28/18- Joe (14) is diagnosed with Bi-Polar Disorder and Depression. Last month he was hospitalized for 2-3 weeks after leaving a suicide note. He was prescribed medication and advised to be in therapy to address his condition. For the last week and a half the child has not been taking his medication because he doesn't like the side affects. The mother (Margaret) and the parent substitute (Robert) are aware of the child's diagnosis and his need to be on medication but have failed to ensure that child is taking his medication or contact a doctor to change his prescription. The role of Margaret (3) is unknown. This report is active in the BO

Date: 12/29/17- In an incident a few months ago, the father (Robert) threw Margaret (3) against her car seat violently to the point where she was screaming. It is unknown if Margaret was injured. The father has unknown mental health concerns which cause him to act angry, manic and crazy. The father verbally abuses Margaret by cursing and screaming at her to the point that she shakes and screams. This is an ongoing concern. The mother (Margaret) also has mental health concerns and is cognitively delayed which inhibits her ability to care for the child. The father does not have heat in the home and uses space heaters which pose a fire hazard. The mother is aware of the father's verbal abuse towards the child as well as the use of space heaters and fails to address these concerns. This report was indicated **AND SINCE DISMISSED.** 

Date: 12/07/17- Last night, 12/6/17, the father (Robert), was arrested for Criminal Mischief, and was charged with a felony. The father is currently incarcerated at an unknown location. The mother (Margaret), is very low functioning on a cognitive level. The mother is unable to provide adequate care for their child, Margaret (3), on her own. The mother lost custody of an older child many years ago due to her inability to provide care for the child for the same reasons. Now that the father is incarcerated, the mother is currently acting as the sole caretaker of Margaret. Also, while the father was residing in the home, there was great concern for his ability to provide adequate care for Margaret as well. The father has untreated mental health concerns that need to be dealt with that are currently not. Margaret is currently at risk of danger and harm at this time. This report was unfounded **CASE DISMISSSED**

Review Clearances to assess Prior History for family.

Report was assigned to C. Sealy for source contact. CPS is to verify the report and obtain additional information regarding the safety of the child

Discuss findings with Supervisor for further case planning.

### **Supervisory Preliminary Assessment of Safety Directives:**

Based on the nature of the allegations listed on the intake report the safety of the child in this home may be an immediate concern. CPS is to make a visit to the case address to assess the subject child in the home.

#### **Initial Guidance:**

The case was assigned to CPS C. Sealy for a home visit.

CPS is to speak with the Mother as to reported concerns. Explore the Mother's parenting styles and whether it is effective in managing the children behavior. If no, ask the Mother to explain her parenting challenges. Report indicates that the MO is verbally and physically aggressive towards the children. Does she confirm screaming at the children? Hitting them? If so, for what reason.

Explore the reason the MO becomes so frustrated and resorts to physical violence. Discuss age appropriate methods to set boundaries without using physical methods of discipline.

Explore the Mother's support system. Who assists the Mo with the care of the children? Explore if the Mo feels overwhelmed with the care of the children. What coping skills does the Mo utilize when she feels overwhelmed?

Document the children's physical appearance, cognitive development and interactions with the mother.

Explore the disciplinary methods used in the home. Assess if the children appears to be fearful of anyone in the home. Assess the children for marks and bruises. Take pictures WHERE ARE THEY?

JOE HIT HER.

Screen for domestic violence, drugs/alcohol misuse and or mental health. Document contact information of all services the family is receiving. Assess where the children receive medical care.

Complete home assessment- ensure the family has adequate provisions and appropriate sleeping arrangements. Assess the home for health hazards

Mother reports that the father never hit her, but he has pushed her around, he was controlling with the money, and made her bring reciepts when she spent money. She also reports that he has kicked the subject child in the butt when she was walking too slow, he has threatened the child with being sent to foster care and he has dumped water on her as discipline. She reports that he has threatened the older child with violence, and has pinned him against the wall in the past. The father is only father to Margaret, Joe has a different father. The mother reports DV with Joe's father as well, but did not go into details about the DV. Mother reports that there is a full order of protection against Margaret's father for the mother and Joe, and it is limited for Margaret so he can see her during supervised visitation. Mother reports that Margaret has been observing the fathers aggressive behavior and has been getting aggressive herself. She reports that the child has been cursing, and hitting her brother. The mother reports that she has observed the father teaching the child to curse. Mother reports that the father does not know the location of the shelter, and drop off for visitation happens at an ACS office. She reports being fearful of the father.

AND WHY ARENT THESE ABSURD ALLEGATIONS IN THE ACS PETITION AGAINST ME?

Mother reports that the child does have marks located on the child's left upper butt that she only noticed yesterday. She reports that the marks where not present before the visitation with the father. She reports that the father has supervised visitation at an ACS office, where the child is fully clothed so she is confused as to how the father could know about the presence of the marks. She reports that the father didn't even change the child during the visitation as she returned with a soiled diaper. When asked how the child got the marks she stated that she does not know, but she suspects the child fell down because the child falls often.

Mother reports that they have joint custody, but she is going to try to obtain full custody of the child. She states that she will mostly likely still allow supervised visitation only.
