Assistant Attorney General:  
Attorney General's office.

Robert Malek:

Yes, it's Rob Malek calling back. I called FedEx and they said it was delivered yesterday at 9:15 to the front desk.

Assistant Attorney General:  
To the front desk?

Robert Malek:  
Yeah. 445 Broadway.

Assistant Attorney General:  
445 Broadway, Albany?

Robert Malek:  
Yeah.

Assistant Attorney General:  
Let's see here. Let's see. What is exactly there. The US courthouse. That was actually delivered to the federal courthouse?

Robert Malek:  
Yes.

Assistant Attorney General:  
Down on Broadway. The court and us are two completely separate entities.

Robert Malek:  
But you have an office in that building though.

Assistant Attorney General:  
Incorrect. Probably the federal Attorney General's office might have an office there, but the New York State Attorney General's office does not have an office in the federal court.

Robert Malek:  
Was that maybe the Department of Justice that I saw in there?

Assistant Attorney General:  
Possibly. Possibly. Again, I'm not quite sure. Our office again, is a little bit further up the hill.

Assistant Attorney General:

Our mailing address is the Capital. Your documents were actually served on the court.

Robert Malek:

Well, I wouldn't really say that. Well, there's more. I wouldn't really say the court.

Assistant Attorney General:

I mean again [inaudible 00:01:33].

Robert Malek:

On the court building. You mean on the court building?

Assistant Attorney General:

Correct. It's a completely different mailing address. We were actually never served. [inaudible 00:01:44].

Robert Malek:

Maybe I should try. Sorry, go ahead.

Assistant Attorney General:

Whatever documents you have, if you have copies of them, I would highly recommend reserving them on the new address.

Robert Malek:

Is there a front desk number?

Assistant Attorney General:

For us or for them?

Robert Malek:

For them.

Assistant Attorney General:

I briefly looked up the United States court and I literally just ran a Google search on 445 Broadway, Albany. It came up as the US District Court and it says it's listed as 518.

Robert Malek:

Yes.

Assistant Attorney General:

257.

Robert Malek:

1800. It's off top of my head. All right. You know what? I'll try calling over there.

Assistant Attorney General:

Tell you what, let me just do another Google search real quick to see if it's the justice department. I mean, we are the New York State Department of Justice and Law, but this may be federal. I mean, it's pretty much coming up as the same thing, 445, room 509.

Robert Malek:

You guys are part of James office?

Assistant Attorney General:

Yes. Latisha James is the New York state attorney general.

Robert Malek:

I see. Well, [inaudible 00:03:01] I don't want to go in there. All right. That's good.

Assistant Attorney General:

You actually might have sent it to the right people. It's just, you're calling the wrong people to confirm. I mean, if it needed to go to the Department of Justice, there's a good chance you probably mailed it to the right address, it's just the phone number that you have to contact whomever is probably the wrong one.

Robert Malek:

Well, no problem. I'll contact them. By the way, I didn't know I was calling the New York state James's defendant, my federal lawsuit, number two, and there'll be many, many more lawsuits against her in the AG office. But I just want to let you know before you go to have you be aware of what you're dealing with over there.

Robert Malek:

If you don't know, is that Janet Sabel, she went to your office as a director of immigration of legal aid. That was her background, director of immigration. In a matter of four years, she was put second in command at your office and bypassed all the other AGs. After she became second in command, she went back to legal aid. Legal aid immediately made her the CEO and she retained her employment working for the state as second in command at the AG's office and at the CEO of legal aid at the same time.

Assistant Attorney General:

That's a conflict of interest sounds like to me.

Robert Malek:

You bet. That's what James did. But it's also wrong as far as employment. I wrote on my case. What about all the AGs that are working for James that got bypassed because of a political situation over here? Why'd she go [inaudible 00:04:53]?

Assistant Attorney General:

I've been here for 20 years and that's ...

Robert Malek:

Thank you. I mean, I could see if she came from some type of high position somewhere. I mean, all right, I get it where she went by all you guys. But coming from director of immigration to go right to the top like that, and then maintained both positions. Then in my case, legal aid is trying to say that their employee is not a state actor. I'm like, "Really? The head of legal aid is working for James at the same time."

Assistant Attorney General:

That's the head of legal aid. What's her last name?

Robert Malek:

Sabel, Janet Sabel.

Assistant Attorney General:

S-E-B-A-L?

Robert Malek:

E-L. But now she's no longer working. If she left you guys, it was about a year ago, approximately.

Assistant Attorney General:

She's no longer with us. I can't find her on the computer.

Robert Malek:

But anyway, I just wanted, ever since she worked there, I wanted like, okay, I just wanted to let you know.

Assistant Attorney General:

For some reason, this just popped into my head. We also have an intergovernmental bureau that sort of handles a lot of intergovernmental ...

Robert Malek:

Almost like a DOI or an internal affairs kind of thing?

Assistant Attorney General:

Yeah, exactly.

Robert Malek:

I didn't know about that. What is their contact?

It's called the Intergovernmental Bureau. It's pretty much Intergovernmental Affairs Bureau, is responsible for the coordination of all significant communications between the Attorney General's office and New York publics and elected officials. It might be what you want.

Robert Malek:

I have a lot of stuff on James. This is great.

Assistant Attorney General:

Do you have a pen and paper?

Robert Malek:

Yes, I do, sir.

Assistant Attorney General:

Phone number is area code 212-416-8985. This is the Intergovernmental Affairs Bureau. The director, if you want to send it to somebody's attention?

Robert Malek:

Yes.

Assistant Attorney General:

Director is Kim Ramos.

Robert Malek:

K-I-M Ramos.

Assistant Attorney General:

Correct.

Robert Malek:
