Good morning,

The January 18, 2019 order states that an Imminent Risk Assessment be done for the subject child. It was my understanding that the court was asking for Mr. Malek to complete an Imminent Risk Assessment, not the child. I'm not sure if that was a misunderstanding but I think it would be more appropriate for Ms. Serlin to comment about that. I do not believe Minnie underwent an Imminent Risk Assessment.

As for a CPSE evaluation. Minnie was referred through the Committee on Preschool and Special Education and completed an evaluation at YAI Center for Specialty Therapy at the end of July 23rd to determine if she qualifies for special services. The January 18, 2019 order does not say the evaluation must be provided to all counsel, it merely says a report should be provided by ACS. What information is the Court seeking?

Also, I am happy to advance the court date. How would the part like to choose new dates?



Good evening Mr. Malek,

I wanted to address your questions below.

Were you aware that acs never investigated the assault of my daughter, her injury seen by me at acs 19 rogers ave on October 11 2018? The statutes regarding investigations are very clear. Unless you are the subject of the report you are not entitled to know that there is an investigation or to know the outcome of that investigation. Simply being the parent of a child named in an ORT does not entitle you to the results of the investigation. As such I am not at liberty to tell you specifically what was or was not investigated as this is confidential. What I can say is that every ORT that you have called in to ACS has been investigated, as is mandated by law.

Were you aware that neither did the 77 police pct? Since I don't work for the NYPD I cannot speak to what they did or did not investigate.

Were you aware that manhattan special victims did not investigate the toe nail incident with my daughter? As in my above response, I don't work for Manhattan Special Victims so I cannot speak to what they did or did not investigate.

Were you aware that acs lied to nypd detectives at the 77 pct in regards to my daughters assault by joe which happened on pprox. august 8 2018 ? I am not aware.

What do you intend to do about this? At this time, I do not intend to do anything – as I noted, all ORTs you have called in to ACS have been investigated. As such, if you called in these allegations, they were investigated. As to the NYPD & Special Victims Unit, I have no control over them & believe that if you have concerns about their actions or lack there-of, this Family Court case is not the appropriate mechanism to handle those concerns.
