The mother said that she had to be harassed and relocated with ACS assistance. There is an active OOP for all of them and a limited for the father so he can see his child at the agency. The 14yo denied the allegations also. He said that he has never hit his sister. The child denied having any anger management issues. The home was appropriate with adequate provisions.
