Section C UNSUBSTANTIATED ALLEGATIONS

The allegation of inadequate guardianship is being unsubstantiated against BM Margaret Ingoglia for subject children Margaret Malek, and Joe Palomino. BM reported that children go to medical appointments, subject children are eating all meals, and that they have appropriate sleeping arrangements. BM reported that subject children have appropriate clothing on. CPS observed the home to have appropriate sleeping arrangements and food in the home. CPS observed no concerns for subject children. There was not enough evidence to indicate the report.

The allegation of lack of medical care is being unsubstantiated against BF Robert Malek for subject Child Joe Palomino. BF has been working with BM and Case Planner on finding a new mental health provider for SC Joe. There is not enough evidence to indicate the report.

The allegation of Lack of medical is being unsubstantiated against BM Margaret Ingoglia for subject child Joe Palomino. BM admitted that SC has stop taking his mental health prescription, and seeing his mental health provider. BM admitted that she was working with her case planner Catholic Charities to provide SC with the proper mental health care. There is not enough evidence to indicate this report.

The allegations of sexual abuse are being unsubstantiated against BF Robert Malek for subject children Joe Palomino, and Margaret Malek. BF denied sexual abuse. Subject child was evaluated who reported that there were no signs on sexual abuse. completed a wellness check on subject child and had no concerns. BM did not disclose any signs of sexual abuse. There is not enough evidence to indicate this report.

The allegations of sexual abuse are being unsubstantiated against BM Margaret Ingoglia for subject child Margaret Malek and Joe Palomino. BM denied allegations of sexual abuse. SC was examined who reported that there were no signs of sexual abuse, and no concerns for SC. BM denied sexual abuse. There is not enough evidence to indicate this report.

The allegations of lacerations bruises or welts are being unsubstantiated against BM Margaret Ingoglia for subject child Margaret Malek. BM denied physically assaulting SC Margaret. BM reported that SC was playing with SC Joe and hurt herself. BM reported that SC Margaret is active, and plays a lot. BM reported that she was not purposely injured by SC Joe.

The allegation of swelling, dislocation/sprains is being unsubstantiated against BM Margaret Ingoglia for subject child Joe Palomino. BM denied this reported concern. BM reported that she did not physically hit SC Margaret.

BM denied SC being hurt on purpose by anyone in the home. There is not enough evidence to indicate this report.
