Honorable Judge Jacqueline Williams,

In accordance with the court's directives, NYC Children's is submitting an updated report for the Margaret Ingoglia case.

Supervised Visits/ Respondent Father Mr. Malek:

On 12/02/20, respondent father Mr. Malek visit with SC Margaret has been suspended due to repeated explosive behavior (verbally) towards the SC mother in the presence of the child. Mr. Malek behavior triggered adverse reaction to the child where she was regressing including nightmares and behavioral issues. The court stipulation is for the respondent father to engage in a mental health evaluation and comply with mental health services.

On 12/04/20, Mr. Malek emailed the Commissioner an attachment of pictures with the child Margaret wearing only a diaper and covered with pinkish reddish marks all over her body; claiming the child was harm while in her mother's care. CPS contacted the mother and she expressed the child was approximately two years old when that incident occurred. According to the mother, the

child got into her makeup while her Paternal Grandfather was supervising her. Reportedly, Mr. Malek accused the PGF of being a pervert and took the pictures of the child to use against the grandfather. On 12/06/20 and 12/08/20, Mr. Malek generated two (2) reports to State Central Register with old allegations. Ms. Ingoglia and the children were investigated, and the allegations were unfounded.

On 12/09/20, PD supervisor emailed Mr. Malek asking him if he was willing to accept a referral to begin the mental health evaluation. Mr. Malek responded with an email highlighting allegation about the care of his daughter at the hands of her mother. On 01/04/21, CPS email a service referral to Mr. Malek, as well as mailing out a hard copy (registered mail) to Mr. Malek. The resources were recommended after a mental health consult for the family.

These are the resources emailed to Mr. Malek:

Mr. Malek responded via email, identifying Dr. Lloyd Glauberman has his evaluation and CPS to email the doctor and copy him. Mr. Malek also stated, the courts has two letters with his evaluations, one from a Dr. Eli and on from a Dr. Fox. On 01/05/21, CPS emailed Mr. Malek asking him to provide Dr. Glauberman phone contact and address. CPS asked Mr. Malek again to give consent for CPS to communicate with Mr. Glauberman. Instead he copied the commissioner and other law enforcement talking about police misconduct.

At this juncture, Mr. Malek has not shown any willingness to sign a HIPAA to give consent to communicate with Dr. Lloyd Glauberman. CPS will continue efforts to engage Mr. Malek surrounding giving consent for the agency to speak with his identified resources to ascertain his treatment in mental health service.

Home Visits/Assessment:

CPS continues to conduct regular bi-weekly in-person and virtual visits to the case address. CPS observed the Non-Respondent mother is maintaining a tidy home, with adequate food and sleeping arrangements. The home continues to have secured window guards and working utilities

Last home visit was on 12/28/20, CPS observed Joe and Margaret interacting appropriately with no conflict. Joe and Margaret reported they visited the doctor earlier that evening and both got flu shots. Ms. Ingoglia also reported she got a flu shot that same evening. The children reported they had a wonderful Christmas and showed CPS their gifts. CPS also presented the children with bags of winter clothes, Jacket and shoes. The children are prepared for the winter season and were very thankful. CPS observed mother and children interactions to be cordial and free of fear and intimidation. The children continue to be well adjusted to their environment. The children have always been observed free of suspicious marks and bruises on their faces, chest, backs, arms and feet.

School:

Subject children Joe and Margaret continues to attend school both in-person and remotely. The children are attending regularly. Currently the children are not having any technical issues regarding remote learning. Their devices are efficient currently. SC Margaret are bused to school and Joe utilizes public transportation. On 12/23/20, Joe's social worker Ms. Ali, reported that child has made some improvement in his classes. On 01/04/21, CPS attempted phone contact with SC Margaret guidance counselor for an updated report. CPS left a detailed message for the counselor and will continue to attempt contact.

Medical:

The subject children Joe and Margaret are medically up to date. Their immunizations are up to date as well. On 09/15/20, subject child Margaret received her annual medical exam and Joe on 12/28/20. Joe is monitored by his endocrinologist and nutritionist currently. Joe is not on any medication currently. Margaret is being monitored by Pediatric Urologist and is continues to be prescribed Cephalexin 250mg, 5ml once a day.

The Non-Respondent mother takes the children to their medical care and follow through with specialized referrals.

Services and referrals:

On 12/23/20, Ms. Ingoglia and children were transferred for therapeutic PPRS. They are now receiving services from Jewish Board, Family Functional Therapy (FFT). This is a strength-based model built on a foundation of acceptance and respect. Its focus is on assessment and intervention to address risk and protective factors within and outside of the family that impact the adolescent and his or her adaptive development. Services are generally conducted in both clinic and home settings.

Ms. Ingoglia, Joe and Margaret continues to receive individual talk therapy on a weekly basis. CPS is in contact with the family therapists. The therapists reported the family is consistent with weekly therapy and follow through with all recommendations and suggestions. Hence the reason they now have therapeutic preventive services in place. Neither Ms. Ingoglia nor her children are prescribed psychotropic medication currently.

It is unknown if Mr. Malek is engaged in any mental health service as he has not agreed to give consent for CPS to communicate with the psychologist, he identified Dr. Lloyd Glauberman.

DIR/Criminal History:

CPS requested updated clearances for respondent father Mr. Malek and non-respondent mother Ms. Ingoglia. An updated report was received on 11/27/20, it showed no new DIR's or criminal reports filed vis-à-vis Ms. Margaret Ingoglia; however, one (1) new criminal report for Mr. Robert Malek was discovered through E Justice, E courts and Accurint NYC. On 01/02/20, Mr. Malek was arrested for auto stripping, Criminal trespass, possession of burglar tools and criminal possession of stolen property. On 04/19/20, Mr. Malek pleaded to criminal possession of stolen property.

Summary:

Both children are safe, healthy and currently meeting all the required developmental milestones. The children continue to be assessed without marks and bruises during home visits. The Non-

Respondent Mother, Ms. Ingoglia allows CPS in the home to assess for safety and risk. The home is stable. Ms. Ingoglia continues to address the children medical and mental needs.

Visitation is suspended between the respondent father and subject child Margaret currently due to the abusive and erratic behavior he displayed during supervised visits. For visit to be re-instated, Mr. Malek must receive a mental health evaluation and comply with mental health services.
