We will notify you of any cancellation, and if there is a need to reschedule, your permission will again be sought. *VP* understands, and fully respect that we will be on private property at all times and all due consideration will be given, so that no damage come to any burial sites, mementos, or any part of your property. If through accident, or neglect on our part we do cause damage, we will repay your organization in full for the cost of repairing it. We each have the utmost respect for all those who have a loved one buried here, and solemnly promise there will be no intoxicant consumption, drugs, horseplay, or any other disagreeable conduct, just the research as mentioned above will be done, for the duration permitted, and on the agreed site(s).

VP will also notify the appropriate division of local Police of the date and time of our study (if deemed necessary), so that there will not be a false alarm. ***VP*** agree that we undertake this research at our own risk and understand that your organization is not responsible for any injury or damage to the members of ***VP*** or their instruments, while on your property. ***VP*** members are required to carry their own health insurance prior to becoming a team member and providing necessary documents are their sole responsibility. ***VP*** agrees to conduct the entire study out of view of passerby and the general public so as not to arouse their curiosity. Please give ***VP*** your consideration, in this matter and if you require any other conditions to be met, we will accommodate them into our proposal, and sign to it. The other ***VP*** investigators names will be disclosed if required and sign to your required documents as well, on your request. ***VP*** will also provide our personal ID on every team member present for the study, if requested.
