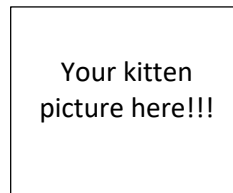

If shipping is needed, an additional \$350 is required. This includes airline cargo fees, state health certificate fees and the additional documentation required by the airlines. ** Please understand that with shipping, we are at the mercy of the weather and airline regulations and scheduling must be flexible. All fees and the purchase price must be paid in full before shipping.

We, the signing parties, consider this document to be legally binding. All parties must initial any changes or additions to this contract.

KITTEN/CAT HEALTH GUARANTEE

All of our kittens are vaccinated age appropriate. We take every precaution to assure you, the buyer, of a healthy animal. To the best of our knowledge, all kittens and cats are free of and have not been exposed to any communicable diseases. **All Kittens are covered by a 7- day health guarantee. Failure to have your own reputable veterinarian examine the kitten/cat within 7 days nullifies the health agreement.** It is recommended that all kittens be kept separate from all other cats or pets for two weeks to settle in without stress. This kitten/cat is sold as a pampered inside pet only. Allowing the kitten/cat to go outside, or declawing the kitten/cat voids all health guarantees.

If during the guarantee period, the kitten appears ill, it is to be examined by a veterinarian. If the vet determines that the animal is ill and the illness was present prior to the sale, the breeder shall be contacted at once. The breeder shall (upon receipt of a statement from the examining licensed veterinarian, that the illness was present prior to the sale) pay the cost of medical treatment (up to, but

not to exceed, the purchase price of the kitten.) If the kitten should die from a problem present prior to the sale, the breeder shall replace the kitten with one of equal quality. No cash refunds will be given. The total liability of the breeder shall in no case exceed the total sale price of this contract. ** This kitten is guaranteed for one year from the date of sale not to have any genetic or birth defects that would negatively affect its health.**

If, for any reason, the purchaser cannot maintain ownership, the breeder retains "right of first refusal" to re-obtain ownership of the cat/kitten.

Health records and recommendations will be provided. Please take them with you to your vet.

This kitten is being fed a high quality cat food and it is recommended to continue this diet for the life of the cat. A complete list of feeding instructions will be provided prior to pick-up/delivery.

ALTER AGREEMENT

In order for the 1-year health guarantee to be valid, the alter agreement must be fulfilled. **This Maine Coon Kitten is sold as an inside only pet and must be altered. Declawing of kitten/cat is not allowed and will void all health guarantees.** As part of the purchase agreement, the buyer is required to have the kitten spayed or neutered no later than 6 months (female) or 10 months (male) of age. **** If the seller does not receive verification of altering within ninety days after the date indicated, an additional payment equal to the purchase price shall be immediately due and payable. The seller reserves the right to repossess the kitten in the event of failure or refusal of the buyer to comply with the terms of this agreement. Registration slips will be provided AFTER verification of altering has been received.**
