

The Doggie Barn - Dog Boarding Service Agreement



DOG BOARDING SERVICE AGREEMENT

This Dog Boarding Service Agreement (the "Agreement") is made effective as of _____,
by and between The Doggie Barn ("Boarding Facility"), located at 4085 Pete Road, Jennings, LA 70546,
and the pet owner ("Owner"):

1. VACCINATIONS

The Owner agrees their dog(s) will have the following vaccinations up to date before boarding:

- Rabies
- Distemper
- Bordetella (Kennel Cough)
- Parvovirus

Proof of current vaccinations must be provided before check-in. Boarding may be denied without them.

2. HEALTH & MEDICATIONS POLICY

All dogs must arrive in good health and free from contagious illnesses.

Any medications must be provided in their original containers with clear instructions.

We do not administer injections.

All dogs must be on a flea prevention regimen before check-in.

If fleas are found, a mandatory flea treatment will be applied at the owner's expense.

For dogs with seizures, heart conditions, or other serious medical risks, we recommend boarding with a licensed veterinarian.

Dog Boarding Service Agreement (continued)

3. LIABILITY AND RELEASE OF RESPONSIBILITY

The Owner releases The Doggie Barn from liability related to:

- Sudden death
- Accidental injury
- Illnesses or infections
- Behavioral incidents
- Pregnancy

4. EMERGENCIES AND VETERINARY CARE

If a medical emergency occurs, The Doggie Barn will attempt to contact the Owner or emergency contact.

If unreachable, veterinary care may be sought at the Owner's expense.

5. BEHAVIORAL ISSUES

The Owner agrees to inform The Doggie Barn of any behavioral issues. Aggressive or dangerous pets may be

refused. The Owner is liable for damages caused by their pet.

****Muzzle Policy:**** If a dog displays aggression (biting, growling, etc.), a properly fitted, humane muzzle may be

used for the safety of all pets and staff. Muzzles are used only as a last resort, and the Owner will be notified.

6. FEES AND PAYMENT

All fees must be paid upon arrival. Charges apply for early pick-up, additional services, and any damages.

****Card on File Policy:**** A valid credit/debit card is required for all bookings. Charges may be applied for:

- Boarding fees
- Late pick-up fees

Dog Boarding Service Agreement (continued)

- Emergency expenses
- Damage or additional services

7. TERMINATION

Either party may cancel with notice. 48 hours' notice is required to avoid charges. Unsafe behavior may result in immediate termination of services.

8. INDEMNIFICATION

The Owner agrees to indemnify The Doggie Barn and its team from any claims or liabilities arising from their pet.

9. ADDITIONAL POLICIES

CANCELLATION POLICY

- 48+ hrs: No charge
- < 48 hrs: 50% charge
- No-show: Full charge

SPAY/NEUTER POLICY

Dogs must be spayed/neutered unless an exception is pre-approved.

FOOD & FLEA POLICY

Bring pre-portioned food labeled for the stay. Dogs must be on flea prevention; flea treatment will be applied at owner's expense if needed.
