Orders over 3 cases will be sent in the most efficient way possible, either as individual cases or as a pallet/part pallet at the appropriate rates providing the delivery address is accessible for an HGV vehicle. Pallet deliveries require an available fork lift at the delivery address and the pallet will be delivered to the entrance only.
