Exhibits

The exhibit hall provides the opportunity to advertise products and services to our conference attendees during our daily meal and refreshment breaks. In order to maximize exhibitor time with our attendees, we limit our exhibit hall space—so act fast!

Exhibit Space Fee

EARLY BIRD SPECIAL prior to **February 28, 2024** is \$1,200 for exhibit space. Application AND fee must be received by February 28th or until the hall is sold out, whichever comes first. The Early Bird Special is on a first-come, first-served basis. After February 28th and based on availability, the regular booth fee is \$1,400.

Payment Policy

Payment for EARLY BIRD SPECIAL received after February 28, 2024 will go towards the regular fee amount of \$1,400. VISA, MasterCard, American Express and checks are the accepted methods of payment. **In accordance with ACCME guidelines, exhibit space is separate from commercial event sponsorship.** Payment must be paid in full to receive confirmation of an exhibit space and listing as an exhibitor/sponsor in the promotional materials (deadline is April 19, 2024). Early payment (and sponsorship level) determines space location. Conference sponsors choose the location of their exhibit space. **Event Sponsorships are IN ADDITION to or IN PLACE OF exhibiting.** AzAAP offers a range of sponsor levels that include various levels of recognition. This will provide maximum exposure for you and your company.

Size and Type of Exhibits

Exhibit space in the hall is limited to the 6' table top, and exhibitors must conform to this space. Because of space limitations, there are no chairs at the exhibit booths. The Hilton Sedona Resort & Spa does not permit exhibitors to tape or hang materials on walls.

Electricity, Internet, and Shipping

Electricity will be provided for a fee of \$25. Companies must indicate the need for electricity on the exhibitor agreement enclosed in this packet. Wireless Internet is available. Shipping forms will be emailed to the paid exhibitors 4-6 weeks prior to the event. Questions regarding shipping should be directed to the resort. Each party agrees to be responsible for their own property and shall hold the AzAAP and the Hilton Sedona Resort & Spa harmless for any damages, theft, or personal injury occurring during the meeting.

Contact Card

Attendees will be inspired by our special "contact card" process to visit your booth, which allows them to enter their name into various raffle drawings.

Free Time

Exhibitor Rules and Regulations

Please review the AzAAP Continuing Medical Education (CME) Program Rules and Regulations for all AzAAP direct and joint sponsored CME activities prior to completing the Pediatrics in the Red Rocks exhibit and sponsorship agreement form. You can complete your agreement by **registering online [here](#)** or by submitting the form below (pages 7 & 8) to PIRR@azaap.org.

AzAAP has established Rules and Regulations which govern exhibits during AzAAP CME programs. The Exhibitor shall comply with all Rules and Regulations prescribed by AzAAP and/or the event facility regarding the use and occupancy of the exhibit space. Reminders will be sent leading up to the activity and monitored during the event. Exhibits and sponsorships must be sold and tracked separately.

- * It will be entirely the learner's choice to visit the in-person exhibit hall.
- * Exhibits will be placed in a separate exhibit hall location and learners are able to engage in the education without having to enter the exhibit area.
- * Exhibit placement must not interfere with the presentation of educational activities.
- * Advertisements and promotional materials may not be displayed or distributed in the educational space at any time.
- * No product advertisements will be permitted in the same room or obligatory path of the educational activity.
- * Contributor representatives may attend an educational activity under the following conditions: (1) They may not engage in sales activities while in the room where the activity takes place; (2) They must remove their company name badges while in the meeting room.
- * All educational materials (e.g., such as slides, abstracts, handouts, evaluation mechanisms, or disclosure information) will be free from marketing and the use of logos, trademarks, or company messages.
- * Activities such as receptions, poster galleries, etc. that are part of AzAAP live events but are not accredited for continuing education are clearly labeled and communicated to attendees as such. Marketing, exhibits, and nonaccredited education developed by or with influence from an ineligible company or with planners or faculty with unmitigated financial relationships are permitted by AzAAP and must not occur in the educational space within 30 minutes before or after an accredited education activity.
- * For virtual activities, virtual exhibits must be placed in a separate location on the virtual platform and learners are able to engage in the education without having to click through, watch, listen to, or be presented product promotion or product-specific advertisement. It must be entirely the learner's choice to visit the virtual exhibit hall, and links to the exhibit space must not be provided during the education.

A refund minus \$75.00 administrative fee is allowed for cancellations received in writing prior to April 12, 2024.
