 Center Room A108 at 1020 Lehigh Avenue.

 - c. Start of Construction 03 March, 2025
 - d. Stadium Solutions begins work 05 May, 2025

- f. Substantial Completion Sitework in coordination with Owners Athletics Contractor scope 15
 July, 2025
- g. Substantial Completion Bleacher Scope, Public Restrooms, & Concessions 18 August, 2025
- h. Substantial Completion Team Building 29 September, 2025
- i. Full and Final Completion 20 October, 2025
- 11. Liquidated Damages apply to this project. Refer to 00 31 13 for damages tied to milestone dates.
- 12. The Building Permits have been applied for and are in process. Permit fees will be paid by the Owner. Contractors are responsible for all licensing fees.
- 13. Minutes: The Architect will record and distribute meeting minutes by Addendum. Minutes of meeting are issued as Available Information and do not constitute a modification to the Procurement and Contracting Documents. Modifications to the Procurement and Contracting Documents are issued by written Addendum only.
- 14. The use of tobacco products and controlled substances is strictly prohibited on all School Property.
- 15. Employee screening is required.
 - a. Fingerprint, State Police and Child Abuse background checks will be required on all employees prior to being on site.
 - b. Employee screening files should be within 2 years of the start of the project.
 - c. Badging per SDoL guidelines.
- 16. Project overview reviewed including:
 - a. Scope of Work MM noted that Addendum 02 included additional description of contract responsibilities. If scope or responsibility in any contract is unclear, please send an RFI.
 - b. Temporary facilities.
 - c. Phasing was reviewed.
 - d. Use of site the parking area between the Stadium and the JP McCaskey High School will be partially available for contractor use.
- 17. Site tour was conducted. Access to the existing buildings, including to JP McCaskey boiler room area was provided.
