The contents of these revised documents alter and amend the drawings issued in the Coordinated Issued for Bid/Permit Construction Set dated 9/3/2024 and take precedence over the related items therein. Some changes listed below are informational only and do not impact the scope of work.

GENERAL INFORMATION

General Contractor is requested to provide a DEDUCT Change Order Proposal (COP GC-01) for the scope changes depicted in the revised drawings and described as follows. Please itemize all scope change items within each Change Order Proposal including credits for work items removed from the scope.

SCOPE CHANGES

- Remove concrete ramp and associated retaining walls along the north and west facades including guard rails. Existing building addition foundation including specified footing depths to remain as specified in bid documents. Retain concrete pads along west façade where shown on revised drawings.
- 2. Add sloped concrete walkway from building addition west entry door to new precast or cast-in-place, reinforced concrete steps and pipe railings.
- 3. Replace suspended stucco ceiling in Sallyport areas with suspended, painted moisture-resistant gypsum board ceiling.
- 4. Reduce wall and ceiling millwork packages in Conference Room 204 & Caucus Room 208 as indicated in revised drawings.
