The CONTRACT DOCUMENTS for the subject project are hereby revised by the following additions, changes, and/or deletions, which shall constitute ADDENDUM NO. 1.

1. **Pre-Bid Meeting Minutes**

2. **Bidder Questions**

ATTACHED: Questions and responses posted on the PennBid system and are hereby incorporated into this Addendum 1. Formal Addenda Items related to these items are provided after this section as applicable.

3. PROJECT MANUAL REVISIONS AND CLARIFICATIONS

The following Project Manual Sections have been updated/revised. In each case, the Bidder is responsible to make note of the revisions. In the case of extensive revisions the Engineer has noted if a new document is being provided for use by Bidders.

A. Form EJCDC C-520: Agreement Between Owner and Contractor, Article 4 - Contract Times. Paragraph 4.02 is hereby revised to read as follows:

"The Work will be substantially completed on or before **Two Hundred Ten (210) days** after the date when the Contract Times commence to run as provided in
Paragraph 4.01 of the General Conditions, and completed and ready for final
payment in accordance with Paragraph 15.06 of the General Conditions within **Two Hundred Forty (240) days** after the date when the Contract Times commence to
run." Should the owner award the Alternate Bid, the Work will be substantially
completed on or before **One Hundred Eighty (180) days** after the date when the

Contract Times commence to run as provided in Paragraph 4.01 of the General Conditions, and completed and ready for final payment in accordance with Paragraph 15.06 of the General Conditions within **Two Hundred Ten (210) days** after the date when the Contract Times commence to run."

B. Form EJCDC C-410: Bid Forms, Contract Nos. 1 through 3:

1. All Bid Forms have been modified to include an Add/Deduct Line Item to accelerate the project completion schedule by 30 days as an Alternate Bid. That is, to achieve Substantial Completion in 180 days and Final Completion in 210 days respectively after the date when the Contract Times commence to run as provided in Paragraph 4.01 of the General Conditions.

At the discretion of the Owner, the Contract may be awarded to the responsive Bidder with the lowest Total Base Bid (210 days and 240 days for substantial and final completion, respectively) or to the responsive Bidder with the lowest Total Alternate Bid (180 days and 210 days for substantial and final completion, respectively).

- 2. The Bid Forms have been modified to include the requirement for the submission of a compliant project schedule as part of the Contractor's Bid.
- 3. The Bid Form for Contract No. 3 has been modified to include line items for the provision of portable air conditioning units on a weekly basis if directed by the Owner.

C. Division 1- General Requirements: Section 011000 Summary

Paragraph 1.7. Access to Site – The following clarifications and supplementary information is provided:

- A. Use of Site The work site shall be available to all Contracts beginning on June 10, 2022. Contractor work hours shall be 7:00 AM to 7:00 PM through August 24, 2022, and may be extended with permission from the Owner. Beginning August 25, 2022 work hours shall be 4:00 PM through 3:00 AM; there will be no access to the work site during regular school hours, except to the mechanical room.
- B. Cleaning It is clarified that Contract 1 shall have the responsibility for the installation of drop cloths, etc. and protection of floors, furniture, and equipment in the work areas. Each Contractor is responsible to maintain a clean work area, protect existing furniture and equipment, and to remove all trash and debris generated by their respective work.

COMMENTS AND GENERAL DISCUSSIONS FROM THE PRE-BID MEETING

These notes are a general summary. Pertinent information will be formally added to the Bidding Documents as addenda if required.

- 1. The contractor is to provide sanitary facilities and dumpsters for the duration of project.
- 2. Equipment storage areas are to be coordinated with the school district. Bidders must provide fencing at their cost if secure storage is desired.

- 3. School District will provide card and badge access into buildings during construction.
- 4. All owner furnished equipment is expected to be stored on site.
- 5. Schuylkill Valley School District has awarded a roofing contract for the elementary school.
 - o HVAC contractor is expected to coordinate with roofing contractor during project.
 - o HVAC contractor is to install roof curbing.
- 6. Rooftop units for the elementary school and high school have been pre-purchased as well as the VRF system for the elementary school administration area.
 - Equipment shown on the Shamenek Engineering drawings has also been pre purchased.
- 7. Building permit costs will be paid for by Schuylkill Valley School District. Successful bidder will be responsible for preparing the permit application.
- 8. Schuylkill Valley School District to be the warranty holder for pre-purchased equipment.
- 9. The effective date for the start of all equipment warranties is based on date of substantial completion (per the contract documents).
- 10. Controls are to be included in HVAC package.
- 11. Both the elementary and high school projects can be done concurrently.
- 12. Several attendees expressed concern regarding the contract time being insufficient due to anticipated delivery times for contractor purchased equipment and materials (anticipated at 12 to 16 weeks from the time the order is placed). The Engineer will review this concern with the Owner and respond to Bidders accordingly. Bidders were directed to formally note this concern via the Pennbid system.
- 13. The Project is expected to take place during summer break (no school in session). Contractor must coordinate working hours with the school district on building access and working area.
- 14. Dust protection shall be provided in the library for books/shelving during construction. Provide dust/damage protection for any flooring and owner furnishings that are located in the area of work throughout the project. Protective mats must be used on the gymnasium floor.
- 15. Schuylkill Valley School District to provide tanks for glycol recovery. Coordinate with the school district for proper disposal and recovery at the high school and elementary school.
- 16. The general contractor is responsible for ceiling removal and replacement associated with existing HVAC demo and new work. Removal/replacement of seating and protection of floors as necessary shall be included in the bid price.
- 17. The Drawings will be updated by the Engineer to reflect changes to the schedule of prepurchased items.

Responses to Bidder Questions Posted on the PennBid System

- Notes 5, 6, 7, and 8 on Electrical plan EP.D-06, show AHU-7, 8, and 9 and 3 roof fans to be disconnected and removed, but the mechanical plans do not show these items as needing removed. Which is correct? Shannon Smith Work shown on SSM electrical plans is accurate. See included Mechanical plans from Shamenek related to RTU's.
- 2. Which contractor is responsible for removing and replacing the ceilings, and items such as lights, fire alarm devices, speakers, security, or lighting motion detectors, wireless access devices, in the ceiling where HVAC items need to be removed from above it? Shannon Smith General contractor is responsible for removing and replacing ceilings, as well as temporarily supporting lighting and ancillary devices.
- 3. General conditions article 14.02-D states Inspection and testing, paid for by the contractor. The electrical bid form shown \$5,000.00 is to be included for testing and inspection. Does the Electrical contractor need to pay for testing and inspection in addition to the \$5,000.00 listed on the bid for or will the Electrical testing and inspection be paid for with the \$5,000.00 listed on the bid form? Shannon Smith
 The Owner will pay for the electrical permit, which would typically include the required inspection fees. The \$5,000 allowance included on the bid form is for any supplemental testing required beyond that required by the electrical permit.
- 4. Does note #3 on drawing EP.1-01 mean that the conduit and wire for this is provided by the HVAC contractor or by Trane, or does it mean that the EC should provide conduit and wire to a control device that is provided by Trane? Shannon Smith Low voltage control wiring to be provided and installed by the HVAC contractor. EC to provide any 120V and greater circuiting.
- 5. If the EC is to provide conduit and wire where notes #3 appear on drawing EP.1-01, can you provide a location where these valves would be? Shannon Smith Low voltage control wiring to be provided and installed by the HVAC contractor. Valves are directly adjacent to the unit shown.
- 6. Does the EC need to provide power to the Damper Actuators shown on EP.1-01 in rooms A136, A137, Corridor E, and Corridor B, or are these control wired by the HVAC, or the HVAC ATC contractor? Shannon Smith Damper actuators are new and only require low voltage control wiring to be provided and installed by the HVAC contractor.

- 7. There are no power connections shown to the EDH units in rooms A132, A130, A133, and A134 on drawing EP.1-01. Does the EC need to provide power to these or are these control wired by the HVAC, or the HVAC ATC contractor? Shannon Smith EDH units are existing to remain and only require low voltage control wiring to be provided and installed by the HVAC contractor.
- 8. Notes 1 and 2 on both drawings A-1.01 and A-1.02 mentions temporarily supporting lights and ceiling devices. Is the work to support lighting and ceiling devices done by the GC or by the EC.? General contractor is responsible for removing and replacing ceilings, as well as temporarily supporting lighting and ancillary devices.
- 9. Note #2 on drawing EP.1-02, show a requirement for power to Trane Lev Kit. Should the power for these Lev Kits be connected to the nearest UV, or should these be run on separate a separate new circuit to a local panel?
 UV-3 shall be tied to 20A, 208V-1PH CIRCUIT "D2(R)-15,17" used for UV's in 2nd floor Corridor "D". UV-4 shall be tied to 20A, 208V-1PH CIRCUIT "C2(R)-7,9" used for UV's in 2nd floor Corridor "C".
- 10. Note #1 on drawing EP.1-02, show conduit and wire to HUH units control valve by Trane. There is also a circuit NEL-29 shown to all but one of these. Do all of these need power supplied by the EC?
 - We believe this should reference drawing EP.1-02. HUH units are existing to remain and only require low voltage control wiring to be provided and installed by the HVAC contractor.
- 11. Does the EC need to provide a power disconnect switch or a thermal switch for the HUH units shown on drawing EP.1-07?
 - HUH units are existing to remain and only require low voltage control wiring to be provided and installed by the HVAC contractor.
- 12. There is a combination starter shown on drawing EP.107 for Supply fan SF-1. Is this combo Stater provided by the HVAC, or Trane, or the EC?

 Electrical contractor to provide.
- 13. Can you tell us when the Boiler/Mech Room (mechanical) drawings will come out for the High School.

A date has not been determined.

14. Circuits HE-19, HE-20, HE-21 and HE-22, on drawing EP.1-08 show wire for these circuits as 3-#8's. The panel schedule HE for these circuits require 3-#6's on a 50/3 breaker. Should these 2 breakers be changed to 40/3, or should the wire be changed to #6's?

Circuits HE-19 & HE-21 shall be 3#6 & 1#10 - 1"C with a 45A breaker. Circuits HE-20 & HE-22 shall be 3#6 & 1#10 - 1"C with a 50A breaker.

15. Can you provide Drawing M.4-02?

The reference to Sheet M.4-02 is an error. The information can be found on sheet M.4-01, which is labeled "Mechanical Details."

- 16. Please clarify what equipment will be provided by the owner and what equipment is already on site versus what the contractors are required to procure for both the Elementary School and the High School.
 - All of the HVAC equipment shown on the Shamenek Engineering drawings has been prepurchased. This includes all the rooftop units as well as the VRF system in the elementary school administration area. The VRF system includes the outdoor condensing unit labeled VRF-1, nine indoor units, a branch controller BC-1, and a ventilation unit ERV-1. All of the roof curbs for the rooftop units have also been pre-purchased except for the curbs associated with RTU-14 and RTU-15. The equipment shown on the Spotts, Stevens & McCoy drawings will be purchased by the HVAC contractor.
- 17. There was some discussion at the pre-bid meeting about how to remove the AHU units in the auditorium are. It was suggested that HVAC contractor may need to remove the drywall ceiling below the units to remove them. Which contractor would carry the cost of removing and replacing the lights, and other electrical devices in this ceiling below the units?
 General contractor is responsible for removing and replacing ceilings. In rigid ceilings, Electrical Contractor shall disconnect and safe-off circuits and remove, store, clean, and replace existing lights and other electrical devices removed as a result of the AHU replacement.
- 18. There does not seem to be any ceiling replacement in the High school building, other than in the Library, by the GC as there is in the elementary school. Which contractor shall remove and replace ceilings in the work areas?
 - General contractor is responsible for removing and replacing ceilings.
- 19. There does not seem to be any ceiling replacement in the High school building, other than in the Library, by the GC as there is in the elementary school. Which contractor shall remove and replace light fixtures, fire alarm devices, speakers, security, or lighting motion detectors, wireless access devices in the affected work areas
 - General contractor is responsible for removing and replacing ceilings, as well as temporarily supporting lighting and ancillary devices.

20. What are the approximate gallons of glycol in the existing HVAC system at the Elementary school and High School?

SSM has not performed a system volume calculation for the existing system at the High School or Elementary School. Existing drawings indicate that the system is a 15% glycol solution for both schools. Contractor shall measure existing chemical/glycol levels and verify type of chemicals with facility staff. At the elementary school the final design will require the system to be drained, flushed, and refilled with water.

21. Has the duration for acquisition of Equipment been taken into consideration for schedule for this project?

Please refer to Addendum No. 1.

22. Can pro-press and / or Mega-Press and Mega-Press "G" be utilized on this project to make it more cost-effective?

Contractor should base their bids on the design documents and follow the substitution process outlined in the specifications.

- 23. Can mechanically grooved products be utilized on this project to make it more cost-effective? Contractor should base their bids on the design documents and follow the substitution process outlined in the specifications.
- 24. Please provide manufacture roofing warranty information and contact for installation contractor who initially installed the roof.

The installing contractor contact for the High School and Elementary school is Scott Liebl at Richard L. Sensenig Company 717-733-0364. The contractor holds the roof warranty and any roof work shall be coordinated with this contract to maintain roof warranty.

25. Is Zoom-Lok or equal product an excepts or fitting product to be utilized on the refrigeration piping?

Contractor should base their bids on the design documents and follow the substitution process outlined in the specifications.

- 26. Can the demolition of the mechanical rooms begin prior to the school summer break? Contractor will need to coordinate with the school district for scheduling of work when school is occupied.
- 27. Who is responsible for the protection of the gym floors?

 The general contractor is responsible for protection of the floors.
- 28. At the High School, there does not seem to be a defined scope of ceiling removal work other than in the library area. Who is responsible for seeing removal and reinstallation in areas requiring so for the installation of the new HVAC equipment or the demolition of existing HVAC Equipment?

General contractor is responsible for removing and replacing ceilings.

- 29. Will the owner permit the HVAC contractor to work on installation of the new gas piping during normal school hours prior to school being dismissed for summer break? No.
- 30. Will there be a High School Mechanical room plan provided?
- 31. Who performs the start-up on pre-purchased equipment?

 Contractor shall engage a factory authorized service representative to perform startup service.

 See specification sections 237416.11 and 237416.13.
- 32. The Scale on drawing EP.D-02-HS is noted 1/8"=1', making the distance across the library 75 feet. The Scale on drawing EP.1-01-HS is noted 1/8"=1', making the distance across the library 37 feet. The Scale on drawing El.1-01-HS is noted 1/4"=1', making the distance across the library 75 feet. Can you please provide the correct and usable scales for the Electrical drawings? The Scale on drawing EP.D-02-HS noted as 1/8"=1' is correct. - artificial non-competitive levels, or (c) to deprive Owner of the benefits of free and open competition;
- 3. "collusive practice" means a scheme or arrangement between two or more Bidders, with or without the knowledge of Owner, a purpose of which is to establish bid prices at artificial, non-competitive levels; and
- 4. "coercive practice" means harming or threatening to harm, directly or indirectly, persons or their property to influence their participation in the bidding process or affect the execution of the Contract.
