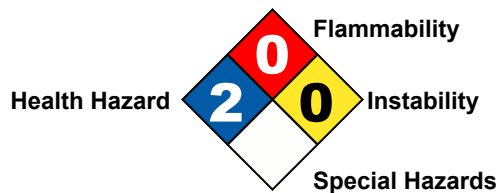

**4. FIRST AID MEASURES**

**4.1 Description of first aid measures**

**Eye** If in eyes, hold eyelids apart and flush continuously with running water. Continue flushing until advised to stop by a Poisons Information Centre, a doctor, or for at least 15 minutes.

**Inhalation** If inhaled, remove from contaminated area. To protect rescuer, use a Type A (Organic vapour) respirator or an Air-line respirator (in poorly ventilated areas). Apply artificial respiration if not breathing.

Ethylene glycol has moderate toxicity to aquatic life on both a short term and long-term basis.

**12.2 Persistence and degradability**

In water and soil ethylene glycol is expected to degrade in several days to a week. The major degradation product is hydroxyacetaldehyde.

**12.3 Bioaccumulative potential**

Ethylene glycol is not expected to bioaccumulate.

**12.4 Mobility in soil**

Expected to be very highly mobile in soil. Not anticipated to volatilise from moist soil or water surfaces.

**12.5 Results of PBT and vPvB assessment**

Avoid contamination of drains and waterways.

**16. OTHER INFORMATION****16.1 Additional information**

**RESPIRATORS:** In general the use of respirators should be limited and engineering controls employed to avoid exposure.
