The notice of appeal shall include the names and addresses of parties served. A notice of appeal not timely filed shall be dismissed for lack of jurisdiction.

The appellant shall personally deliver or mail the original notice of appeal to the Board of Indian Appeals. A copy shall be served upon the judge whose Order is appealed as well as all interested parties. The notice of appeal filed with the Board shall include a certification that service was made as required by this section.
